- 4 Applications should indicate the number and type of the residential units proposed together with a statement of the capital investment envisaged and be accompanied by proof that finance is available for the project
- 5 Applications should state whether the residential units will be intended for outright sale, renting, tenant-purchase or mort-gage housing
- 6 It should be understood that the construction of all internal roads, drains and sewers will be at the expense of the developer
- 7 Applications should be sent to reach the Commissioner of Lands, PO Box 30089, Nairobi, not later than 18th August, 1972
- 8 After the closing date mentioned above all the applications will be examined in detail on their merits and the selected applicant or applicants will be advised that their proposals meet with the requirement of the Government and an offer of the land will be made. The offer will contain details of the stand premium and annual rent payable, and set out the general and special conditions which the allottees would be required to comply. These will depend on the amount of land required for any individual scheme and the nature of the proposed development.

- 3 Applications must be sent so as to reach the Clerk to the Central Rift County Council not later than noon on 21st July, 1972
- 4 Application forms on the approved pro forma obtainable from the Clerk to the Central Rift County Council should be submited to the Commissioner of Lands through the Clerk to the Central Rift County Council
- 5 Applications must not be sent direct to the Commissioner of Lands
- 6 Applicants must enclose with their applications their cheque for Sh 1,000 as a deposit, which will be dealt with as follows
 - (a) If the applicant is offered and takes up and pays for the plot within a period of 14 days as required in para graph 5 below, the deposit will be credited to him
 - (b) If the application is unsuccessful the applicant's deposit will be returned to him
 - (c) If the application is successful and the applicant fails to take up and pay for the plot offered to him within a period of 14 days as required in paragraph 5 of the General Conditions, the Commissioner of Lands may declare the deposit forfeited and the applicant shall have no further claim thereto
- 7 Applicants must produce documentary evidence to indicate that they have sufficient funds for the development of the plot

General Conditions

- 1 The ordinary conditions applicable to township grants of this nature except as varied hereby shall apply to this grant
- 2 The grant will be made under the provisions of the Government Lands Act (Cap 280 of the Laws of Kenya), and title will be issued under the Registration of Titles Act (Cap 281)
- 3 The grant will be issued in the name of the allottee as stated in the letter of application
- 4 The term of the grant will be for 99 years from the first day of the month following the notification of the approval of the grant
- 5 Each allottee of a plot shall pay to the Commissioner of Lands within 14 days of notification that his application has been approved, the initial estimated amount for the construction of roads and drains to serve the plot, the assessed stand premium and proportion of annual rent, together with the survey fees payable in respect of the preparation and registration of the grant (Sh 225) and the stamp duty in respect of the grant (approximately 2 per cent of the stand premium and annual rent) In default of payment within the specified time the Commissioner of Lands may cancel the allocation and the applicant shall have no further claim to the grant of the plot

Special Conditions

- 1 No buildings shall be erected on the land nor shall additions or external alterations be made to any buildings otherwise than in conformity with plans and specifications previously approved in writing by the Commissioner of Lands and the local authority. The Commissioner shall not give his approval unless he is satisfied that the proposals are such as to develop the land adequately and satisfactorily.
- 2 The grantee shall within s x months of the commencement of the term submit in triplicate to the Commissioner of Lands through the local authority, plans (including block plans showing the position of the buildings and a system of drainage for the disposal of sewage surface and sullage water), drawings, elevations and specifications of the buildings the grantee proposes to ercct on the land and shall within 24 months of the commencement of the term complete the erection of a petrol station and the construction of the drainage system in conformity with such plans drawings elevations and specifications as amended (if such be the case) by the Commissioner

Provided that if default shall be made in the performance or observance of any of the requirements of this condition it shall be lawful for the Commissioner of Lands or any person authorized by him on behalf of the President to re-enter into or upon the land or any part thereof in the name of the whole and thereupon the term hereby created shall cease but without prejudice to any right of action or remedy of the President or the Commissioner in respect of any antecedent breach of any condition herein contained

- 3 The grantee shall at his own expense suitably connect the said drainage system and also the water supply system with any town drainage and/or town water supply system when in the opinion of the local authority the latter systems are so far completed as to enable the grantee to do so
- 4 The grantee shall maintain in good and substantial repair and condition all buildings any time erected on the land
- 5 Should the grantee give notice in writing to the Commissioner of Lands that he is unable to complete the buildings within the period aforesaid the Commissioner of Lands shall (at the grantee's expense) accept a surrender of the land comprised herein

Provided further that if such notice as aforesaid shall be given (1) within 12 months of the commencement of the term the Commissioner of Lands shall refund to the grantee 50 per centum of the stand premium paid in respect of the land, or (2) at any subsequent time prior to the expiration of the said building period the Commissioner of Lands shall refund to the grantee 25 per centum of the said stand premium. In the event of notice being given after the expiration of the said building period no refund shall be made

- 6 The land and buildings shall be used for the purpose of a petrol and service station which shall include only the greasing, washing and oiling vehicles. Adequate car parking facilities are to be provided on the plot for those cars which are serviced at the station
- 7 The grantee shall comply with the provisions of the Petroleum Act (Cap 116), and any amendment thereto or made from time to time thereunder
- 8 The buildings shall not cover a greater area of the land than may be prescribed by the local authority
 - 9 The grantee shall not subdivide the land

- 1 The Kenya Union of Cemmercial Food and Allied Workers shall hereinafter be referred to as the Claimants and the Kenya Planters' Co-operative Union Ltd, shall hereinafter be referred to as the Respondents
- 2 The parties were heard in Nairobi on 23rd and 24th May, 1972, and relied on their written and verbal submissions

AWARD

3 The last collective agreement between the parties was effective from 1st July, 1969, and the duration period is covered in clause 1 (d) as follows —

"These terms and conditions of service shall remain in force indefinitely and shall remain unaltered for the duration of one calendar year from the date of enforcement

Thereafter the parties undertake to negotiate together any reasonable alterations to these terms and conditions of service which may be desired from time to time

Such desired alterations shall be notified by one party to the other in writing not less than two calendar months before the date on which negotiations are desired to begin"

As a result of the Tripartite Agreement of 1970 the Claimants did not take any steps to revise this agreement until 22nd June, 1971, when they informed the Respondents through a letter that they desired the agreement to be amended in line with their proposals "which are enclosed" It is admitted, however, that the Claimants forgot to send their proposals with this letter and sent them on 28th June, 1971

The Respondents informed the Claimants that their proposals were excessive and recommended a more realistic approach. They also said that they would be ready to commence negotiations on 29th August, 1971. In fact the negotiations commenced on 1st September, 1971 and continued on 10th September after the Claimants failed to turn up for meetings on 3rd and 9th September. Another three meetings took place on 14th, 24th and 28th September, 1971.

It is not disputed that the Respondents time and again pointed out to the Claimants that they wanted the new collective agreement to be of two years duration effective from the date it is actually signed. They were emphatic that there should be no backdating and made this clear to the Claimants in their letter of 9th September, 1971.

The Claimants reported a trade dispute to the Ministry of Labour on 26th September, 1971, covering six items and a conciliator was appointed in November There was no settlement and the six items were referred to the Industrial Court by the parties vide the Notification of Dispute Form "A" signed on 27th January, 1972 This form, along with the Certificate of the Labour Commissioner dated 1st March, 1972, as required under section 9 (9) (e) of the Trade Disputes Act, was received by the Court on 4th March, 1972

During the hearing the Court was informed that the parties had already agreed to a wage increase of Sh 20 per month on the following rates for the various grades. The housing allowance, as it is an issue in dispute, is also shown hereunder —

The Respondents produced some minutes of a meeting which had taken place at Sagana on 14th August, 1970, to support their argument that the issues dealing with 'Loans' and "Bonus' were dropped by the Claimants after the Respondents had explained the position to the Claimants' representatives. These minutes were hotly disputed by the Claimants who maintained that this meeting dealt solely with the problems of Sagana employees and had no bearing whatsoever on other employees. After a careful consideration, the Court has decided not to attach any weight to these minutes and accordingly the Court has made its findings on these two issues on the arguments and submissions put forward by the parties during the hearing

- 1 Loans—Surprisingly there is a provision in the collective agreement, which is being revised, on this item. The existing arrangement recorded under "Welfare" is as follows—
 - "(a) (11) Where the Welfare problem takes the form of an application for a loan and the Company feels that compelling reasons have been established for granting such loan the amount advanced shall be recovered in instalments not exceeding one-third of the employee's gross wage

Loans in excess of one month's wages will not be granted except in very exceptional circumstances

In exceptional cases the approval of the Board of Directors shall be sought"

The Claimants now demand that an employee should be entitled to get by way of loan from the Respondents the equivalent of the amount lying to the credit of that particular employee in the gratuity scheme which has been frozen since the commencement of the National Social Security Fund They said there was no reason why their members should not get loans as suggested by them because the Respondents would have adequate security

The Respondents on the other hand strongly submitted that even at present they were receiving far too many applications for loans and they suspected that the money was being wastefully used In any case, they pointed out, the gratuity scheme was subject to its own rules one of which stated that if an employee was dismissed for gross misconduct he would lose his gratuity and therefore there would be no security in that case

The Court has carefully considered this demand but has come to the conclusion that loans should not be linked with the money lying to the credit of employees in the now frozen gratuity scheme. The Court must point out that it would be wrong to enable a worker to draw on his retirement benefits otherwise the worker would find that he has no money to fall back on when he is in most need of it, that is when he retires

In view of the fact that loans in excess of one month's wages can be granted in exceptional circumstances the Court must reject this demand

2 Sick Leave — The Claimants withdrew their demand on this item

3 Long Service Awards—About nine years ago, the Respondents used to pay their employees 13 months salary for every year of service. This practice was, however, discontinued towards the end of 1963 when the bonus element was consolidated in the wages at that time. The bonus element ranged from Sh 16/25 to Sh 92 per month

The Claimants now demand that at the end of every year the Respondents should award a certain amount of pay to their employees depending on the years of service of each employee They added that the workers needed an incentive for better performance

The Respondents maintained that this was an unrasonable demand and submitted that long service employees are well looked after in the general conditions of employment

The Court notes that the present wage structure is based on an elaborate job classification the details of which were made available to the Court and as a result the employees are paid a "rate for the job" and there are no annual increments. This fact is clearly recorded in the current agreement. For the foregoing reasons the Court must reject this demand.

4 Housing and Housing Allowance—The current situation is that out of some 270 employees there are 200 manual workers, out of these, 132 are housed by the Respondents Those who are not housed are paid the house allowance as set out herein before in the award

The Claimants demand new housing allowance as follows -

Grades	Sh p m
1 to 3	100
4 to 6	125
7 to 9	150
10	215

The Claimants further submit that the value of the houses provided by the Respondents was not more than Sh 30 per month. They alleged that the accommodation was very poor and the workers had to share communal bathrooms and toilets and cooked their meals in the only room which they were allocated. In these circumstances they asked the Court to rule that such employees should be paid in cash the amount of their housing allowance entitlement less Sh 30 per month.

The Respondents maintained that the present housing allowance was above average and it is never the intention that the allowance should equal the rent. The Respondents asked the Court to consolidate the present housing allowance into the wages so that the workers would get additional benefits

The Court finds that the Claimants' demand on this issue in respect of those workers who are housed to be unrealistic and is therefore not prepared to make any award for those workers who are housed by the Respondents If the workers are not satisfied with the houses provided they can then find other accommodation and claim the housing allowance for their grade. The Court must also reject the Respondents' demand that the housing allowance should be consolidated into the wages

In respect of those workers who are not housed by the Respondents the Court awards the following housing allowance for the various grades —

5 Redundancy—The Claimants demand that if workers are declared redundant then they should be paid severance pay at the rate of one month's pay for each completed year of service

The Court notes that it is already provided that in the event of redundancy the full amount standing to the workers' credit in the gratuity scheme would be paid to the workers. This scheme provides for setting aside each year of one-twentieth of the annual wage representing nearly 17 days' pay plus accrued interest.

In these circumstances the Court awards that in the event of redundancy, in addition to the existing provisions, workers shall be entitled to severance pay at the rate of 15 days' pay for every completed year of service with effect from the date the gratuity scheme was frozen

6 Effective Date and Duration—The provisions of the existing agreement on this point as set out hereinbefore are quite clear in that the negotiations should commence two months after the Claimants have submitted their demands. There is no ambiguity in the relevant clause. Therefore the Claimants having forwarded their demands to the Respondents on 28th June, 1971, the negotiations commenced on 1st September, 1971.

If agreement had been reached at the negotiating stage it would have become effective from 1st October, 1971 The delay caused at the Ministry of Labour is no reason to deny the workers a backdating of their benefits some of which had already been agreed as far back as September, 1971, and the others are the subject of this award

After a careful consideration of all the submissions, the Court awards that the effective date should be 1st October, 1971, and the duration period should be 18 months from that date
