## NEW RATES OF GOVERNMENT SUBSIDY ON FERTILIZERS

IT IS notified for general information that the Government has decided to change the rates of its subsidy on fertilizers. With effect from 1st September, 1972, the new rates of subsidy will be:—

Sh. 1.20 per units of "N"—Sh. 1.20 per metric ton "N".

Sh. 3 per unit of Water Soluble  $P_2O_5$ —Sh. 3 per metric ton Water Soluble  $P_2O_5$ .

Compound fertilizers and mixture containing Water Soluble  $P_2O_5$  and "N" will be similarly subsidized at the above rates.

Existing instructions for claiming subsidy remain unchanged.

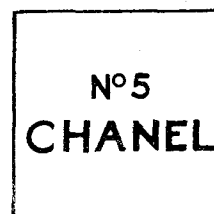
