CAUSE NO. 15 OF 1974

Parties:—

Kenya Union of Commercial Food and Allied Workers
and
Unga Limited

Issue in dispute.—Wrongful dismissal of Mr. Geoffrey Kwaheria.

1. The Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the Claimants and Unga Limited shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on the 25th day of April, 1974, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 24th November, 1973, together with the statutory certificates from the Minister for Labour and the Labour Commissioner, was received by the Industrial Court on 1st March, 1974.

Mr. Geoffrey Kwaheria started working for the Respondents' Nairobi mill on 1st April, 1969. He was employed as a fitter and was in possession of a Trade Test Certificate Grade I. His duties were those of a maintenance/fitter and he was required to service all the machines. On 10th January, 1972, he was suspended for an alleged offence of failing to comply with proper instructions and on 11th January, 1972, he was served with a letter of dismissal for serious offences. The letter read as follows:—

"I regret to inform you that as you have broken the company's regulations by committing the serious offence of refusal to obey proper instructions in that on 6th January, 1972, you were instructed and advised on three times to work on B.D.R. machine which you refused and caused loss to the company on production for one solid hour (memo. or agreement paragraph 13 (f) refer) your services are no longer required by this company and this letter serves to advise you of your immediate dismissal."

On 14th January, 1972, the Claimants' General Secretary intervened in the matter and wanted to know the reason for Mr. Kwaheria's dismissal as he had denied having refused to obey instructions to work on a B.D.R. machine. The General Secretary also wrote that Mr. Kwaheria was employed as a fitter and therefore an explanation was needed why he was not given a letter telling him whether he was being transferred permanently on to the B.D.R. machine or if he was to work there only temporarily. He also demanded Mr. Kwaheria's reinstatement.

Subsequently Mr. Kwaheria made an appeal to the General Manager of the Respondents and he was informed on 4th April, 1972, that after the appeal has been heard the findings were that there was full justification for his dismissal which was to stand.

The matter then ended in the Ministry of Labour and an investigator was appointed. The Permanent Secretary informed the parties on 10th March, 1973, of his recommendations which are produced below:—

Summary.—There is no doubt that Mr. Geoffrey Kwaheria refused to obey a lawful order. He made a voluntary statement in which he is reported to have said that he knew he was being disobedient but he was sure that the job was new to him. This proves that he was aware he was disobeying an order which could lead to his instant dismissal.

Recommendation.—Having taken all the factors into account it is considered that the action taken by the management was justified."

During the hearing the Claimants stressed that Mr. Kwaheria's request to be informed in writing about the circumstances under which he was being asked to work on the B.D.R. machine was reasonable and did not amount to gross misconduct. In fact it was not even a minor offence. They reiterated that Mr. Kwaheria did not refuse a lawful order but he wanted to know whether he was going to B.D.R. machine permanently or temporarily. He never asked for an increase in salary but just wanted a letter to satisfy himself as to what he was actually supposed to do. He had, however, asked to be given in writing whether or not he would be paid an acting allowance.

The Respondents maintained that Mr. Kwaheria had been asked to work on the B.D.R. machine for maintenance work only for as short a time as it would take to obtain a Grade I fitter from the labour exchange but Mr. Kwaheria refused to co-operate and a shopsteward was informed of this fact but this again had no effect and it was finally decided to suspend him and later he was dismissed.

The Court notes that about the middle of August, 1971, the Respondents installed a high speed B.D.R. packing machine at their Nairobi mill. The machine required a machine operator with mechanical skill to operate and maintain it. A person was employed for this purpose but unfortunately he left his employment in the beginning of January, 1972. The Respondents' Branch Manager was of the opinion that Mr. Kwaheria had the necessary qualification, experience and mental ability for this purpose and that it would further his progress within the undertaking. Accordingly Mr. Kwaheria was asked if he would like to be trained as a machine operator. However, he rejected this suggestion. This was on or about 3rd or 4th January, 1972. Because of Mr. Kwaheria's refusal a trainee miller was given this job until a suitable operator could be obtained.

It seems quite probable that the Respondents' Management, particularly the Mill Manager and his Assistant, were unhappy at this rebuff from Mr. Kwaheria and on 5th January, 1972, Mr. Kwaheria was asked to carry out the servicing requirements on this machine as the trainee miller did not have any mechanical knowledge and was unable to carry out the maintenance work and the normal service on the machine.

The Court has formed the impression that while Mr. Kwaheria is not necessarily a politician and a militant trade unionist, he certainly is a type of person who likes to be told precisely and in no uncertain terms what his instructions are. He no doubt has carried this attitude to the extreme and in the absence of any special circumstances would certainly amount to unreasonable conduct.

However if the circumstances surrounding the whole incident are viewed in the light of the fact that Mr. Kwaheria had spurned an opportunity of making progress in the undertaking when he was given an opportunity to be trained to operate the B.D.R. machine explains the rather extraordinary conduct of Mr. Kwaheria in asking for written instructions when he was asked to maintain and service the said B.D.R. machine. He thought it was just another excuse to get him to the B.D.R. machine.

The parties did not put forward any explanation as to why Mr. Kwaheria refused to be trained on the B.D.R. machine. It may seem odd and probably it was rather unwise on Mr. Kwaheria's part to forego such an opportunity for advancement but the fact remains that he refused the offer to be trained as an operator for the B.D.R. machine. Having done this he was naturally very suspicious when he was asked to go and work on the machine although the Respondents contended that the work required was mere servicing. At this stage the whole issue could have been clarified by a written instruction.

Mr. Kwaheria's behaviour in rejecting an opportunity to improve his prospects is very odd indeed but the fact remains that if a worker does not want promotion he should not be victimized.

After careful consideration of all the submissions the Court finds that whereas under normal circumstances a refusal to obey a lawful order does amount to gross misconduct giving the employer the right to summarily dismiss an employee, in this case the surrounding circumstances leading to Mr. Kwaheria's insistence to be told in writing the detailed instructions under which he was being asked to go to B.D.R. machine and also the work which he was required to do was not all that unreasonable. The Court would like to make it clear that under normal circumstances it would indeed be ridiculous for an employee to ask for written instructions for every little job that he was required to do.

The Court finds that Mr. Kwaheria's statement he is alleged to have made voluntarily on 8th March, 1972, does not materially alter the facts of this dispute. Neither does the question of whether or not Mr. Kwaheria was present at work on 8th, 9th and 10th January, 1972, as the whole matter during these days was taking shape and Mr. Kwaheria was no doubt confused and the Management were contemplating what action to take against him.

The Court has come to the conclusion that the Respondents' decision to terminate Mr. Kwaheria's services is wrongful but having considered all the circumstances of the case the Court is not prepared to order his reinstatement. The Court, however, awards that he be paid three months' salary by way of compensation for wrongful dismissal.



**IMPORTANT NOTICE TO SUBSCRIBERS

THE following notes are for the guidance of persons sub-
mitting "copy" for inclusion in the *Kenya Gazette, Supplements,*

- (1) *Kenya Gazette* contains notices of a general nature and which do not affect legislation, and may be submitted direct to the Government Printer.
- (2) *Legislative Supplement* contains Rules and Regulations which are issued by the Central Government, and must be submitted through the Office of the Attorney-General.
- (3) *Bill Supplement* contains Bills which are for introduction into the National Assembly only.
- (4) *Act Supplement* contains Acts passed by the National Assembly.

All "copy" submitted for publication should be prepared on one side of a foolscap sheet no matter how small the notice or Act, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible, and contain a minimum of alterations.

Particular attention should be paid to the following points:—

- (i) Signatures must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

Extract from the Code of Regulations, Section D—

Kenya Gazette

D.41. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 12 noon on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer when ready.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
