(b) If the application is unsuccessful, the applicant's deposit will be refunded to him.

(c) If the application is successful and the applicant fails to take up and pay for the plot offered to him within a period of 14 days as required in paragraph 5 below, the Commissioner of Lands may declare the deposit forfeited and the applicant shall have no further claim thereto.

5. The allottee shall pay to the Isiolo County Council within 14 days of notification that his application has been approved, the assessed stand premium and proportion of annual rent, together with the fees payable in respect of the preparation and registration of the lease and the stamp duty. In default of payment within the specified time the Commissioner of Lands or the County Council may cancel the allocation and the applicant shall have no further claim to the lease of the plot.

General Condition

The grant will be made under the Trust Land Act (Cap. 288). The term of the lease shall be for a period of 33 years from the first day of the month following the notification of the approval of the lease.

Special Conditions

1. No buildings shall be erected on the land nor shall additions or external alterations be made to any buildings otherwise than in conformity with plans and specifications previously approved in writing by the local authority. The lessor shall not give his approval unless he is satisfied that the proposals are such as to develop the land adequately and satisfactorily.

2. The grantee shall within six months of the commencement of the term submit in triplicate to the local authority plan (including block plans showing the position of the buildings and a system of drainage for the disposal of sewage, surface and sullage water), drawings, elevations and specifications of the buildings the grantee proposes to erect on the land and shall within 24 months of the commencement of the term complete the erection of such buildings and the construction of the drainage system in conformity with such plans, drawings, elevations and specifications as amended (if such be the case) by the lessor:

Provided that if default shall be made in the performance or observance of any of the requirements of this condition it shall be lawful for the lessor or any person authorized by him on behalf of the County Council to re-enter into and upon the land and the term hereby created shall cease but without prejudice to any right of action or remedy of the County Council or the Commissioner in respect of any antecedent breach of any condition herein contained.

3. The grantee shall maintain in good and substantial repair and condition all buildings at any time erected on the land.

4. Should the grantee give notice in writing to the County Council that he/she/they is are unable to complete the buildings within the period aforesaid, the county council shall (at the grantee's expense) accept a surrender of the land comprised therein:

Provided further that if such notice as aforesaid shall be given (1) within 12 months of the commencement of the term the

county council shall refund to the grantee 50 per centum of the stand premium paid in respect of the land, or (2) at any subsequent time prior to the expiration of the said building period the county council shall refund to the grantee 25 per centum of the said stand premium. In the event of notice being given after the expiration of the said building period no refund shall be made.

5. Users see Schedules (a) and (b).

6. The buildings shall not cover more than 50 per centum of the area of the land.

7. The grantee shall not subdivide the land without prior written consent of the Commissioner of Lands.

8. The grantee shall pay to the county council on demand such sum as the county council may estimate to be the proportionate cost of constructing all roads and drains and sewers serving or adjoining the land and shall on completion of such construction and the ascertainment of the actual proportionate cost either pay (within seven days of demand) or be refunded the amount by which the actual proportionate cost exceeds or falls short the amount paid as aforesaid.

10. The grantee shall from time to time pay to the county council on demand such proportion of the cost of maintaining all roads and drains serving or adjoining the land as the county council may assess.

11. Should the county council at any time require the said roads to be constructed to a higher standard the grantee shall pay to the county council on demand such proportion of the cost of such construction as the county council may assess.

12. The grantees shall pay such rates, taxes, charges, duties, assessments or outgoings of whatever description as may be imposed, charged or assessed by any Government or local authority upon the land or the buildings erected thereon.

13. Issue in dispute.—Underpayment of wages of Mr. Mwangi Kagwara.

1. The Kenya Local Government Workers' Union shall hereinafter be referred to as the Claimants and the Eldoret Municipal Council shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on the 14th day of May, 1974, and relied on their written and verbal submissions. In addition, the parties called the following persons to give evidence on oath:—

(1) Claimants.—Mr. Mwangi Kagwara.

(2) Respondents.—Mr. Mehar Singh Jagdev.

AWARD

3. The Notification of Dispute Form "A" dated 8th February, 1974, was received by the Court on 14th March, 1974, together with the certificate from the Labour Commissioner under section 9 (9) (e) of the Trade Disputes Act.

In this dispute the Claimants are claiming a sum of Sh. 3,661/80 from the Respondents being the difference between what Mr. Mwangi Kagwara was actually paid and what he should have received under the agreed terms and conditions of service. The details of the claim are as follows:—

The Claimants' contention is that Mr. Kagwara has been underpaid from the time he started working for the Respondents in July, 1970. They stated that the Respondents being one of the Municipal Councils were not allowed to enter into any verbal contracts of any nature with anybody and it was therefore irregular for them to allow Mr. Kagwara's name to appear in the Council payroll without a written contract.

The Claimants maintained that Mr. Kagwara was employed by the Respondents on full time basis and in any case the collective agreement which they had with the Respondents precluded them from employing any worker on part time basis although they could employ workers on temporary and casual basis.

The Respondents resisted this claim vigorously on the ground that Mr. Kagwara throughout his employment with the Respondents was a part time employee doing only two hours' work for five days a week and that he had been properly paid for that work.

The Respondents produced documentary evidence to prove that the job of a sweeper at Uasin Gishu Primary School had always been a part time job and that when Mr. Kagwara took over the work he was fully aware and he accepted to work as a part time sweeper working ten hours a week, working from 2 to 4 p.m. Monday to Friday.

It is necessary to go back into the records maintained by the Respondents in order to come to a just and fair decision in this case. In the minutes of the meeting of the Education Committee held on 3rd May, 1965, the following is recorded under Minute E. 23/65:—

"Subordinate Staff

The Town Clerk reported that it would be necessary for the Council to take over nine subordinate staff and one part time sweeper for the Uasin Gishu Primary School on Council's Terms of Service. Mr. Patel stated that he had already explained to the staff concerned the present conditions and that if the Council agreed to take them on they would be taken on as new employees. After discussion it was resolved to recommend to the Finance and General Purposes Committee that nine subordinate staff and one part time sweeper be taken over on Council's Terms of Service for Subordinate Staff."

The correspondence that was exchanged between the parties in 1971 and 1972 clearly shows that Mr. Kagwara was after securing permanent employment with the Respondents and that when the Claimants raised in January, 1972, the question of underpayment the Respondents emphatically stated that he was employed only on a part time basis.

Further documentary evidence has satisfied the Court that the post of the sweeper at the Uasin Gishu Primary School had always been one of part time until sometime last year when due to shortage of staff the present sweeper has been taken on full time and given additional duties like pruning the hedge, grass cutting, etc.

The Court notes that the Claimants are claiming underpayment on his behalf from July, 1970 to 13th March, 1973, the date when it is alleged Mr. Kagwara got so fed up with the treatment he was getting that he decided to resign but the Court has no doubt that he deserted his employment.

The Court must overrule the Claimants' submission that the Respondents are not allowed to engage any part time employees other than those who are temporary or casual. The Court finds that the words "temporary" and "casual" are wide enough to cover any part time employees as well. To make any finding to the contrary would amount to very severely restricting an employer's right to hire. This the Court is not prepared to do.

The Court is fully satisfied that notwithstanding the absence of a letter of appointment Mr. Kagwara with his own agreement was employed by the Respondents as a part time sweeper and that he has been adequately rewarded for the services that he rendered until the date of his desertion.

After a careful consideration of all the submissions and the evidence given by the witnesses the Court rejects the Claimants' demand.

1. Brollo Kenya Ltd. shall hereinafter be referred to as the Claimants and the Kenya Engineering Workers' Union shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on the 30th day of May, 1974, and relied on their written and verbal submissions. The Claimants called Mr. Francis Maina to give evidence in Court.

AWARD

3. The Notification of Dispute Form "A" dated 16th March, 1974, was received by the Court on 8th April together with the statutory certificate from the Labour Commissioner in accordance with section 9 (9) (e) of the Trade Disputes Act.

This dispute stems from the Claimants' desire to declare redundant 16 workers for whom they find they have no jobs. The Respondents generally had been sympathetic to the Claimants' problems as will be evident hereinafter but found that as far as the 16 employees involved in this dispute are concerned they cannot accept their redundancy.

The Claimants are an engineering undertaking and are involved in the manufacture of sheets, plates, angles, profiles and pipes. Their current factory capacity is 8,000 tons per month but most of the time from the middle of July, 1972, to April this year they had averaged a production of 800 to 1,000 tons per month which is well below their break-even point. Taking into account the changing price pattern of this industry they reckoned that 2,000 to 3,000 tons would be their break-even point. The Claimants produced the necessary documentary evidence in support of their contentions.

The Claimants called a witness who is their Deputy General Manager and he explained that at present they had 187 workers in employment but this number was larger than what they really required and for whom they had the necessary work. He produced the necessary factory chart showing the location of the various machines and which illustrated that they could not provide work for more than 171 employees and any additional employees on the machines would be superfluous. He further informed the Court that they had tried to absorb as many as they could but they cannot fit in any one of these 16 employees. In the past they had shifted people and given them training, etc., whenever that was necessary but now they could not have them any more.

The Claimants commenced the construction of their factory in December, 1971, and work was carried out in three stages—the first being completed in April, 1972, when 35 employees who were employed on a casual basis were transferred from construction to manufacturing work. Stage two continued until August, 1972, when a further 120 unskilled employees were transferred from contractor labour to the Claimants' undertaking on manufacturing work. 140 employees were employed on stage three which was completed in August, 1973, and all of them were transferred to manufacturing even though they were unskilled.

It was explained on behalf of the Claimants that their Chairman, himself an industrialist with many other factories elsewhere in the world, decided that all construction labour should be retained until all construction had been completed in the hope that work would be found for them and skills slowly imparted to them when production got into full swing. This was purely out of human consideration and Mr. Brollo's intentions in this regard were made clearly known to the Respondents from the outset.

This Court is satisfied that this attitude on the part of the Claimants resulted in their employing far too many employees and to make matters worse they had to face severe competition with firms who imported the very same items which the Claimants were supposed to manufacture here in Kenya. Consequently the demand for the Claimants' products did not materialize as was envisaged.

These factors coupled with lack of export markets in the neighbouring countries for the finished products compelled the Claimants to declare 119 workers redundant and they embarked

on discussions with the Respondents. As a result of the Respondents' appeal alternative jobs were found for 50 thus reducing the redundancy to a minimum of 68. The Court notes that the Respondents had been involved in this exercise from 3rd October, 1973.

As further agreement could not be reached between the parties the Claimants involved the Minister for Labour in this matter and a conciliator was appointed and a meeting with the Respondents was arranged for 14th February, 1974. This meeting however did not take place until 22nd February, 1974. The Respondents however confirmed that should any employee wish to leave the Claimants' employment then he should be paid his entitlements in accordance with the terms and conditions of service agreement, and it is not disputed that compensation has been paid as follows:—

- (a) One month's salary for February, 1974.
- (b) One month's salary for notice period to be effective for the month of March, 1974.
- (c) All leave having already been taken to be disregarded.
- (d) Two weeks' severance pay for every completed year of service.

Since all the employees had been sent on leave, 52 of them accepted their entitlement and left the employment and that leaves the 16 involved in this dispute of whom 9 are on permanent leave and 7 are attending the premises although there is no work for them.

The Court has carefully considered the Respondents' submission that the Claimants should be asked to absorb these 16 employees in their factory but in view of the submissions and the undisputed evidence both documentary and the oral testimony on oath of the Claimants' Deputy General Manager, the Court is of the view that however regrettable it may be in this case, the application by the Claimants to declare the 16 employees redundant should succeed.

In Cause No. 14 of 1973, between the Printing and Kindred Trades Workers' Union and Birds Office Stationery & Equipment the Court, while rejecting an employer's demand to declare certain employees redundant, set out certain points on which it had to be satisfied before any redundancy application could succeed. In this case the Court is wholly satisfied that all the principles as laid down in the Industrial Relations Charter and those set out by the Court in the aforesaid cause number have been complied with and there is therefore no ground for the Court to refuse this application.

The Court feels that it is important that the Claimants should be allowed to develop without carrying employees for whom no work is available and the Claimants have further given a guarantee that if the situation improves they will give the first offer of employment to those laid off.

During the hearing a rather important point emerged which is of general importance and application to the country's development plans at large. The Claimants have highlighted the fact that whereas they have the factory potential of 8,000 tons production per month, they found that their average output of sales varies between 800 to 1,000 tons per month. This was because all the items of steel products within the Claimants' range of production are imported in large quantities by Kenya merchants under open General Licence. The Claimants quoted the relevant statistics for 1972 and 1973 extracted from the E.A. Customs & Excise Department Annual Trade Report in substantiation of their complaint.

The Court cannot rule out that probably there are some other aspects of this problem of importation of steel products which were not gone into in fuller details during the hearing of this dispute but the Court is left with a distinct impression that there seems to be something wrong somewhere in that when an industrial undertaking has been set up in the country with the full blessings of the Government, conditions are allowed to exist which not only undermine the creation of new job opportunities in that industry but in fact lead to a good many workers already in employment to be declared redundant. If this sort of situation is allowed to develop then the Government's development plans would be seriously impaired. The Court feels duty-bound to draw the attention of the Kenya Government and the relevant Ministry to probe deeply into the allegation that was highlighted during the hearing of this dispute. The Court is sure that the Government will be in full agreement with the Court's views that industrial undertakings should be allowed to develop not only to keep in employment the existing number of workers but to create many more new jobs which are so very vital in the economic plans of our country.

In the dispute before the Court, the Court gives approval to the Claimants' demand to declare 16 employees redundant as stated in the submissions and awards that they should all be paid one month's salary in lieu of notice plus all their dues including wages up to the end of June, 1974.
