EXCLUSION OF LAND FROM PROSPECTING AND MINING

CAUSE No. 45 OF 1974

Parties:—

Kenya Chemical Workers' Union

and

E.A. Match Co. (Kenya) Ltd.

Issues in dispute:—

1. Wage increases.
2. Minimum rates of pay for each grade.
3. Normal working hours.
4. Effective date and duration.
5. Employment for casual labour and their rights of such services where terminated on redundancy ground.
6. Gratuity.

1. The Kenya Chemical Workers' Union shall hereinafter be referred to as the Claimants and E.A. Match Co. (Kenya) Ltd. shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on 28th October and 6th November, 1974, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 15th May, 1974, was received by the Court on 28th August, together with the statutory certificate signed by the Labour Commissioner in accordance with section 9 (9) (e) of the Trade Disputes Act.

The parties entered into a recognition agreement in November, 1962, and since then they have negotiated several collective agreements. It is not disputed that the parties invariably failed to reach settlement on the important issues like wage increases and other fringe benefits at their own level and resorted to third party assistance in settling their differences.

They have appeared before the Industrial Court on three occasions in the past *vide* Cause Nos. 49/65, 23/67 and 44/69.

The Claimants with some justification bitterly criticized the Respondents for having always displayed a negative attitude to the Claimants' demands and subsequent negotiations which had resulted in the aforesaid disputes being referred to the Court. The Claimants added that the Respondents' negative attitude had forced them once again to bring the dispute to the Court. The submissions before the Court have revealed an interesting picture which shows that although the Respondents until quite recently were virtually in a monopoly situation, yet had failed to meet the local demand with the result that importation of matches had been allowed and now a new local match manufacturer has also appeared on the scene in Nairobi.

There is also no getting away from the fact that until the Legal Notice No. 234 of 1974 came into force the Respondents were paying their employees consolidated rates ranging from Sh. 225 p.m. to Sh. 350 p.m. These rates have been adjusted to comply with the new statutory rates effective from 1st September, 1974. On 1st August, 1974, the Respondents increased the wage rates to Sh. 231/50 going up to Sh. 396/50. The Claimants have based their case largely on the increase in the cost of living and on the fact that the Respondents had paid very low wages for many years. They proposed the following rates for the various grades:—

The Claimants also claimed compensation for the growth in the country's economy. The parties are, however, not agreed as to the date from which compensation for price increases can be claimed.

The Claimants argued that the last increment was paid in April, 1970, and the cost of living index has increased by 50.2 per cent from that date. The Respondents on the other hand argued that the agreement was prolonged because of the Tripartite Agreement up to the end of September, 1972, and that no compensation should be granted for wage freezes following in the wake of the Tripartite Agreement and the cost of living increase from September, 1972, is 31.2 per cent.

The Employment Promotion Division have calculated compensation ceilings from the expiry of the Tripartite Agreement, i.e. July, 1971, and the price increase from that month up to September, 1974, is 38 per cent.

The Employment Promotion Division point out that the International economic dislocation is removing the base for the projected rise in the real domestic product per capita as published in the Government's Development Plan for 1974-78. They feel that no such growth can be assumed during the next few years to come and therefore no growth element should be included in calculating the ceiling.

The Employment Promotion Division analysis reveals that the ceiling for increases in labour costs for a new two-year agreement would be in the range of 30 to 40 per cent and the Claimants' demand for an 80 per cent wage increase and a reduction of working hours of 4.7 per cent are clearly in excess of that ceiling.

The Respondents put forward their difficulties which did not enable them to make a very big offer, these being that in December, 1973, there was a very large fire in their factory which put them out of production for about 17 days and that in April, 1974, they ran out of major raw material which severely affected the production to such an extent that there was another critical shortage of safety matches. The Respondents put forward that on both these occasions when they had started production they had to work round the clock to make up for the shortage and this had necessitated a need for the employment of casual workers. The Respondents added that they hoped to engage additional 60 employees on permanent basis over the next couple of months. This would be in addition to 39 employees they have engaged since 1st October, 1974.

The Court has given careful consideration to the parties' submissions and keeping in view the Guidelines which have been issued to the Court by the Minister for Finance, makes the following award on the various issues.

1. *Wage increases.*—The Court awards a wage increase of Sh. 60 p.m. to all unionizable employees on the wages they were getting on 1st June, 1974, for the first 12 months and a further increase of Sh. 40 p.m. for the next 12 months: Provided that any wage adjustments made since 1st June, 1974, shall be deducted from the wage increase of Sh. 60.

2. *Minimum rates for pay for each grade.*—The Court awards the following new minimum rates for each grade:—

3. *Normal working hours.*—The Court rejects the Claimants' demand for a reduction in the normal working hours.

4. *Effective date and duration.*—The Court awards that the effective date should be 1st June, 1974, and that the award should remain in force for a period of two years from that date.

5. *Employment for casual labour.*—The Court awards that a casual employee may not serve the company for more than three continuous months: thereafter such casual employees may be taken into regular employment on probation on the basis of the company's operational requirements provided that the casual employee's daily rate shall be calculated by dividing the rate for the particular grade in which the employee is working by 26 days.

6. *Gratuity.*—The Court rejects the Claimants' demand.

2. The transporter is hired out by the Government of Kenya on the understanding that the hirer has made every effort to obtain transport from a recognized hire transporting firm and has been unsuccessful in obtaining suitable transport.

3. Applications should be submitted to the Commissioner of Lands, Nairobi, through the District Commissioner, Nyahururu, stating the plot required in order of preference. Applications must be on prescribed forms which are available from Lands Department or the District Commissioner, Private Bag, Nyahururu.

General Conditions

2. The grantee shall within six months of the commencement of the term submit in triplicate to the local authority and the Commissioner of Lands plans (including block plans showing the positions of the buildings and a system of drainage for the disposal of sewage, surface and sullage water), drawings, elevations and specifications of the buildings the grantee proposes to erect on the land and shall within 24 months of the commencement of the term complete the erection of such buildings and the construction of the drainage system in conformity with such plans, drawings, elevations and specifications as amended (if such be the case) by the Commissioner:

Provided that notwithstanding anything to the contrary contained in or implied by the Government Lands Act (Cap. 280), if default shall be made in the performance or observance of any of the requirements of this condition it shall be lawful by him on behalf of the President to re-enter into and upon the land or any part thereof in the name of the whole and thereupon the term hereby created shall cease but without prejudice to any right of action or remedy of the President or the Commissioner in respect of any antecedent breach of any condition herein contained.

3. The grantee shall maintain in good and substantial repair and condition all buildings at any time erected on the land.

4. Should the grantee give notice in writing to the Commissioner of Lands that he is unable to complete the buildings within the period aforesaid, the Commissioner of Lands shall (at the grantee's expense) accept a surrender of the land comprised herein:

Provided further that if such notice as aforesaid shall be given (1) within 12 months of the commencement of the term, the Commissioner of Lands shall refund to the grantee 50 per centum of the stand premium paid in respect of the land, or (2) at any subsequent time prior to expiration of the said building period, the Commissioner of Lands shall refund to the grantee 25 per centum of the said stand premium. In the event of notice being given after the expiration of the said building period, no refund shall be made.

5. The land and buildings shall only be used for shops (excluding a petrol station), offices and flats.

6. 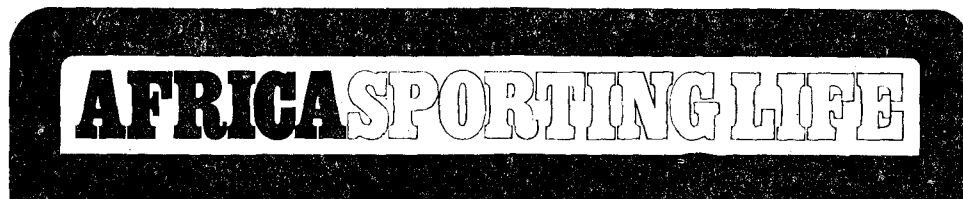

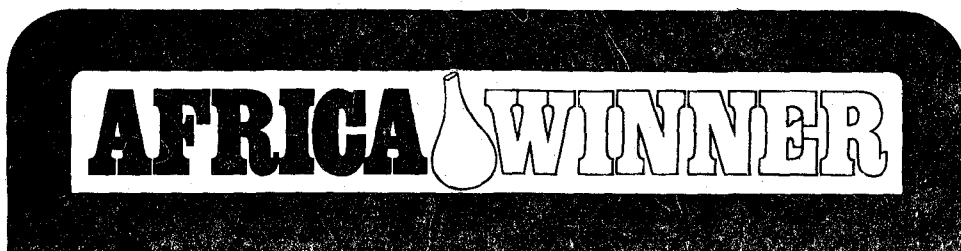
