VACANCIES

Civil servant applicants should complete Forms PSC. 2A in triplicate (submitting the original through their Heads of Departments) and Cards PSC. 25 and 25A. Other applicants should complete Forms PSC. 2 in triplicate and Cards PSC. 24 and PSC. 24A.

These documents are obtainable either from the Secretary or from other Government offices.

Originals of certificates and similar documents should not be submitted unless specifically asked for.

NOTE

Incremental credits will be granted to successful candidates who are not civil servants for approved previous experience provided the maximum salary is not exceeded. They will also be eligible for benefits and privileges enjoyed by civil servants in accordance with existing Government Regulations.

*Vacancies in the Ministry of Tourism and Wildlife:**Telecommunications Engineer (One Post) (No. 19/79)*

Salary scale.—£1,734 to £2,334 p.a. PENSIONABLE or AGREEMENT.

Applicants must have a university degree (Electrical Engineering) from a recognized university or have undergone a recognized apprenticeship or received training, and possess at least full technological certificate (Telecommunications) of the City and Guilds or its equivalent with at least seven years' experience of working with a reputable telecommunications organization after training, three of which must be in a supervisory capacity (equivalent to Job Group "J"). Knowledge of four-stroke petrol engine electric battery chargers will be essential. They should also be conversant with Government Regulations governing personnel, stores and financial matters and should have experience in training both technical and operational staff.

The successful candidate will be required to initiate and organize development projects, co-ordinate installations and maintenance of a country-wide radio network which is mainly comprised of modern H.F. (SSB and AM) V.H.F. (AM and FM) as they are used in their fixed, mobile, remote or portable applications (both valve and transistorized equipment) together with associated aerial system and test gears.

Senior Telecommunications Technician (Three Posts) (No. 20/79)

Salary scale.—£864 to £1,212 p.a. PENSIONABLE or AGREEMENT.

Applicants should be Kenya citizens who must have undergone recognized apprenticeship or received training and are in possession of at least City and Guilds Telecommunications Technician Certificate 49 Series (up to "B" Level) or its equivalent with at least two years' experience with a reputable telecommunications organization.

The successful candidates will deal with installation and maintenance of H.F. (S.S.B.) plus V.H.F. (A.M./F.M.) as they are used in their mobile aerial systems and test equipment.

Pilot (Rangeland Ecological Monitoring Unit) (Two Posts) (No. 21/79)

Salary scale.—£1,734 to £2,334 p.a. PENSIONABLE or AGREEMENT.

Applicants must be Kenya citizens with East African Certificate of Education in 1st or 2nd Division who should in addition be in possession of both private and Commercial Pilot Licences from recognized institutions. They are also required to have at least 1,000 flying hours on their records with a minimum of 500 hours as Commercial Pilots. Elements of Map-reading for K.R.E.M.U. are equally essential. Instrument rating though not essential, will be advantageous.

The successful candidates will be required to undertake extensive low level flying within the rangelands of Kenya in Cessna 185 tail wheel aircraft. Low level flying entails flying along specified transects at a specified height and maintaining the required speed while staff biologists and aerial observers

collect the necessary data on livestock and wildlife population and other environmental parameters, e.g. soil types, vegetation condition and availability of water.

Applicants will be required to sit and pass an aptitude test which will be conducted by or on behalf of the Ministry after which they will undergo intensive on-the-job training to be conducted by the Chief Pilot prior to the final selection.

Levy Inspector Grade I (One Post) (No. 22/79)

Salary scale.—£1,446 to £1,938 p.a. PENSIONABLE or AGREEMENT.

Applicants must be civil servants of East African Certificate of Education or its equivalent with a sound knowledge of Government as well as Commercial Accounting procedures with at least two years' experience in catering training Levy collection in the grade of Levy Inspector II. They should be conversant with the provisions of the Hotels and Restaurants Act No. 19 of 1971 plus all related Legal Notices. Experience in Court prosecution and debt collection will be essential, coupled with proven ability for leadership.

Successful candidate will be required to supervise Levy Inspectors and Assistant Levy Inspectors, process applications for exemptions and refunds, liaise with the Attorney-General Chambers on prosecutions in criminal and civil cases arising from the Act, look into criticism and complaint concerning the enforcement of the Act, prepare periodical and annual reports, deal with appeals against penalties and prosecutions, liaise with the Principal, Kenya Utalii College, on all matters regarding training of personnel already in the tourism and hotel industry. He will be answerable to the Administrative Secretary and he should be prepared to travel extensively throughout Kenya.

*Vacancies in the Ministry of Agriculture:**Agricultural Officer Grade I (Water Engineer) (One Post) (No. 23/79)*

Applicants should be graduates in Geology or Hydrogeology from a recognized university with at least two years' field experience in geology or hydrogeology.

The successful candidate will be responsible to the Co-ordinator, Marginal/Semi-Arid Lands Pre-investment Study Project for the detailed inventories on both surface and ground water sources and making recommendations on provision of water for domestic, livestock and irrigation requirements in the Marginal/Semi-Arid areas of Kenya. He will be stationed in Nairobi.

Technical Officer Grade I (Mechanization) (Six Posts) (No. 24/79)

Salary scale.—£1,446 to £1,938 p.a. PENSIONABLE or AGREEMENT.

Applicants must be in possession of Diploma in Agriculture (farm management option) from Egerton College or any other recognized institution with at least five years' experience, four of which must have been at Job Group "H" level in an office that handles machinery.

The successful candidates will be responsible to the District Team Leaders within the Integrated Agricultural Development Programme areas for the collection of cash flow data for farms, preparation of monthly reports for farms under him and to use and draw out farm budgets. They will also be responsible to the District Team Leader in the farm management committee meeting.

Assistant Agricultural Officer Grade I (Potato Research) (One Post) (No. 25/79)

Salary scale.—£1,446 to £1,938 p.a. PENSIONABLE or AGREEMENT.

Applicants should be in possession of Diploma in Agriculture from Egerton College or equivalent qualifications and should have served at the level of Assistant Agricultural Officer II in a Research Station for a minimum period of three years. They should be experienced in Potato Research, and be able to supervise junior technical staff.

The successful candidate will be posted to Potato Research Station, Tigon, where he will be assisting the Senior Potato Research Officer.

Applicants must be qualified systems analysts with at least four years' experience at the grade of Senior Computer Analyst/Programmer Grade I. They should be able to organize and manage a large data processing section. A sound knowledge of I.B.M. and I.C.L. hardware and experience of on-line and communications systems will be an added advantage.

Successful candidate will be responsible for evaluation of written computer instructions, co-ordinate and control data computer centre, plan and control computer programmes and train data processing and computer staff.

Senior Executive Officer (One Post) (No. 28/79)

Salary scale.—£1,734 to £2,334 p.a. PENSIONABLE or AGREEMENT.

Applicants should preferably be university graduates or holders of East African Certificate of Education with at least five years' experience in the field of fingerprint work and fund registration. They must have served for at least two years at Job Group "J". Duties include assisting the Director in the registration of fund members and identification of benefit claimants. Ability to control a large staff, make independent decisions, plan course of study for finger prints trainees and deal tactfully with members of the public is essential. Applicants must have a thorough knowledge of the National Social Security Fund Act.

*Vacancies in the Ministry of Power and Communications:**Meteorologist (Meteorological Department) (Thirty Posts)*
(No. 29/79)

Salary scale.—£1,446 to £1,938 p.a. PENSIONABLE or AGREEMENT.

Applicants should have passed an honours degree in Meteorology, Mathematics and/or Physics, Agriculture or Hydrology from a recognized university.

Successful candidates will after an orientation course be expected to carry out independent weather analysis and forecasting and providing meteorological service in all fields of applied Meteorology; Hydrometeorology, Agrometeorology or teaching in his speciality at the Institute for Meteorological Training and Research, Nairobi.

Revenue Officer (Road Transport Branch) (One Post)
(No. 30/79)

Salary scale.—£1,446 to £1,938 p.a. PENSIONABLE or AGREEMENT.

Applicants must be civil servants with a minimum qualification of East African Certificate of Education or its equivalent and must have attended advanced accounts course either at Kenya Institute of Administration or Government Training Institute, Maseno. They must have served at the Grade of Accountant II for at least four years or be Economics graduates from a recognized university plus three years' post qualification experience. They should have thorough knowledge of Government Accounts procedure and be fully conversant with Kenya Revenue Laws. The successful candidate will be responsible for planning, organization and supervision of accounting and collection of large sums of money.

Architectural Draughtsman Grade I (Aerodromes) (One Post)
(No. 31/79)

Salary scale.—£1,446 to £1,938 p.a. PENSIONABLE or AGREEMENT.

Applicants must be of the East African Certificate of Education or its equivalent and must have passed the Ordinary Diploma in Building and Civil Engineering from the Kenya Polytechnic or any other recognized institutions. They must have a minimum of six years' practical experience in Architectural Drawing Office, three of which must be at Job Group "H".

The successful candidate will be expected to have a thorough understanding of building construction and services and capable of producing working drawings from sketches.

Survey Assistant Grade I (Aerodromes) (One Post) (No. 32/79)

Salary scale.—£1,446 to £1,938 p.a. PENSIONABLE or AGREEMENT.

Applicants should have passed Technician Diploma in Land Survey from the Kenya Polytechnic or hold Survey of Kenya Occupational Test Grade I in Land Survey. They must have passed East African Certificate of Education or its equivalent.

In addition applicants must have at least five years of post qualification experience of which three years must have been at Survey Assistant Grade II (Job Group "H") level. They should also possess wide field experience in Topographical, Engineering or Cadastal Survey including Triangulation, Traversing, Tachometry, Photo Interpretation levelling and setting out of Engineering Construction works. Successful candidate must be prepared to travel all over the Republic to perform general Aerodrome Survey duties. He would be in charge of an independent survey team and therefore ability to handle staff is essential.

*Vacancies in the Ministry of Works:**Superintending Engineer (Electrical) (Building Services)*
(One Post) (No. 33/79)

Salary scale.—£2,154 to £2,820 p.a. PENSIONABLE or AGREEMENT.

Applicants must be registered Electrical Engineers and must be Members of the Institution of Engineers (Kenya) having at least five (5) years' experience in the design, installation, and maintenance of engineering services in most or all of the following:—

Hospitals, Airports, Water-Works, Office and Conference Complexes, Public Buildings, Educational Institutions and large centralized Catering and Laundry Units.

They must have had considerable administrative experience associated with engineering activities and must have the ability and personality to control and direct a group of professional engineers and technicians.

Duties.—The Superintending Engineer will be directly responsible both professionally and administratively to the Chief Electrical Engineer or to his deputy for one of the following:—

- (a) The design and installations of electrical engineering services within Government buildings and institutions.
- (b) The installation and maintenance of electrical engineering services within Government buildings and institutions, the technical direction of professional engineers and senior technicians heading maintenance sections in provincial maintenance groups, and the control and direction of the Chief Fire Prevention Officer.

His particular responsibility will be the supervision of the in-service training of technicians and the personal guidance of Assistant Engineers.

Senior Superintendent (Electrical) (Three Posts) (No. 34/79)

Salary scale.—£1,734 to £2,334 p.a. PENSIONABLE or AGREEMENT.

(i) Applicants must possess the East African Certificate of Education or its equivalent.

(ii) They must possess the City and Guilds Electrical Engineering Technician Certificate or a Technical Certificate in Electrical Engineering from the Kenya Polytechnic, final grade with endorsements (Full Technological Certificate) or its equivalent, followed by at least eight (8) years practical experience six (6) of which must have been in a supervisory capacity in two or more of the following:—

- (a) The preparation of design drawings, specifications and estimates for electrical installations in public buildings, hospitals, institutions, etc.

- (b) The installation, operation and maintenance of diesel generating plants and machinery, including H.T. and L.T. distribution services.
- (c) The installation, operation and maintenance of refrigeration and air conditioning plants, cookers, water heaters and general domestic appliances.
- (d) The installation, inspection and testing of electrical installations in public buildings, hospitals, institutions, etc.
- (iii) They must also possess a thorough working knowledge of the current "Regulations for the Electrical Equipment of Buildings" and hold an "A" or "D" licence as appropriate.

Or, serving officers who do not possess the full technological certificates but otherwise meet the requirement of the specification (Clause 2 and 3 above) and who have held the grade of Superintendent Electrical with proven ability for a minimum of three years will be considered.

Senior Superintendent (Roads) (Two Posts) (No. 35/79)

Salary scale.—£1,734 to £2,334 p.a. PENSIONABLE or AGREEMENT.

Applicants should be between 33 and 50 years of age with at least ten years' experience in road maintenance and construction of which seven must have been spent in a supervisory capacity (three years as Superintendent). They should have considerable experience in work planning and programming, preparing and controlling expenditure and also have considerable experience in the use of heavy earth-moving, bitumen surface dressing and paving equipment, and full knowledge of maintenance of bitumen and gravel roads.

Instructor Grade I (Buildings) (One Post) (No. 36/79)

Salary scale.—£1,734 to £2,334 p.a. PENSIONABLE or AGREEMENT.

Applicants should have been educated up to East African Certificate of Education level or its equivalent, hold an Ordinary Diploma in Buildings or its equivalent, hold a Final Proficiency Certificate or a Grade I Trade Test in a relevant trade and have had at least eight years' experience in the construction and/or maintenance of buildings, six of which must have been in a supervisory position. They should also have had at least four years experience in a Technical Instructing capacity with experience in the preparation and application of modern teaching aids and methods.

Duties.—The successful candidate would be responsible to the Principal, Staff Training Department for:—

- (a) Preparation and control of Training Programmes for pre-service trainees, apprentices and in-service trainees (buildings) as required by the Chief Architect.
- (b) Administration of all training matters including liaison with Polytechnics, Directorate of Industrial Training, Directorate of Personnel Management and Private Sector regarding Training Programmes.
- (c) Preparation of claims for re-imburement from Industrial Training Levy.
- (d) Liaison with the Chief Architect regarding staff projections and future training requirements.
- (e) Organizing overseas industrial training courses in conjunction with the relevant branch heads.

Instructor Grade I (Electrical) (Two Posts) (No. 37/79)

Salary scale.—£1,734 to £2,334 p.a. PENSIONABLE or AGREEMENT.

Applicants should have been educated up to East African Certificate of Education level or its equivalent, hold the Electrical Technician's Full Technological Certificate or its equivalent and hold a Class "A" Electricians Licence. They should have at least five years' experience in a supervisory capacity in inspection and testing of electrical installations including maintenance and operation of electrical machines, transformers, refrigeration and air conditioning plants, cookers, water heaters and general domestic appliances.

They should have had at least four years' experience in a technical instructing capacity with experience in the preparation and application of modern teaching aids and methods.

Duties.—The successful candidates would be responsible to the Principal, Staff Training Department for:—

- (a) Preparation and control of training programmes for pre-service trainees, apprentices and in-service trainees (electrical) as required by the Chief Electrical Engineer.

- (b) Administration of all training matters including liaison with Polytechnics, Directorate of Industrial Training, Directorate of Personnel Management and Private Sector regarding training programmes.
- (c) Preparation of claims for re-imburement from Industrial Training Levy.
- (d) To liaise with the Chief Electrical Engineer regarding staff projections and future training requirements.
- (e) To organize overseas industrial training courses in conjunction with the relevant Branch Heads.

Instructor Grade I (Mechanical) (One Post) (No. 38/79)

Salary scale.—£1,734 to £2,334 p.a. PENSIONABLE or AGREEMENT.

Applicants should have been educated up to East African Certificate of Education level, hold a relevant full technological certificate and a Final Proficiency Certificate or a Grade I Trade Test Certificate in a relevant trade, and have had a minimum of five years' practical experience including a minimum of two years in Workshop Administration. They should have had at least four years' experience in a technical instructing capacity with experience in the preparation and application of modern teaching aids and methods.

The successful candidate will be responsible for organizing and administering one of the mechanical training schools within the staff training department including the discipline and guidance of both staff and trainees, the preparation of course patterns, materials and syllabi, the maintenance of all machines and equipment in school and the instructions in all the skills handled by the school. He will be involved in some instruction.

Superintendent (Roads) (Three Posts) (No. 39/79)

Salary scale.—£1,446 to £1,938 p.a. PENSIONABLE or AGREEMENT.

Applicants should be between 30 and 50 years of age with at least eight years' experience in road maintenance and construction of which five must have been spent in a supervisory capacity (three years as Senior Inspector). They should have considerable experience in work planning and programming, preparing and controlling expenditure and also have considerable experience in the use of heavy earth-moving, bitumen surface dressing and paving equipment and full knowledge of maintenance of bitumen and gravel roads.

Executive Officer Grade I (Housing Section) (One Post) (No. 40/79)

Salary scale.—£1,446 to £1,938 p.a. PENSIONABLE or AGREEMENT.

4. Redundancy and severance pay.

1. The Transport & Allied Workers' Union shall hereinafter be referred to as the Claimants and Nairobi Petrol Stations Association shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on the 1st day of February, 1979 and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 4th November, 1978 duly signed by the parties was received by the Court on 27th November along with the statutory certificate signed by the Labour Commissioner.

The parties' last collective agreement was effective from 1st March, 1976 and it expired on 28th February, 1978.

The parties have not been able to agree on the issues in dispute during their negotiations for concluding a new collective agreement.

The Claimants have demanded a 40 per cent flat wage increase for all employees backdated to March 1978 and a further 40 per cent to take effect from March 1979. They argue that this would compensate their members for loss of purchasing power which they had suffered over the years.

The Claimants are also demanding a night shift allowance of Sh. 4 per person per shift.

On the issue of redundancy and severance pay they demand that the words "Subject to a maximum payment of the equivalent of five months' pay. This clause will not apply in case of the Government decision on (Licensing Act)" to be deleted from the existing clause so that the new clause would read as follows:—

"Severance pay on the basis of 14 days for each completed year of service with effect from 1st January, 1967".

The Respondents have very vigorously resisted the Claimants' demand on the ground that they are not in a position to make any offer of wage increase over and above the statutory minimum rates and their main argument for doing so is that their gross earnings on the petrol which represents the bulk of their business turnover is averaging about 5 per cent only and the price is controlled. Furthermore the oil companies have withdrawn all the subsidies which they used to afford the station operators: these subsidies include:

1. Maintenance of equipment.
2. Stationery.
3. Uniforms.
4. Rent for premises.
5. Bonus on volume sale.
6. Delivery cost.
7. Credit facilities for all petroleum products.
8. Light.

The Respondents strongly submitted that they could not afford any wage increases to those who would earn over and above the minimum rates for their respective job groups without serious consequences of redundancies.

The Court has very carefully considered the parties' submissions and notes that the Respondents are an association with a membership of 35 petrol service stations in Nairobi whereas there are over 130 service stations operating in Nairobi. To make matters worse out of the Respondents 57 members in 1974 now the figure had dropped to 35 and these member stations employ approximately 525 workers.

The workers' entitlement under the Guidelines is 25.2 per cent for the two-year duration of the next agreement which means that the maximum to which they are entitled would be 12.6 per cent per year. This would be on the basis of the effective date being 1st March, 1978.

The Court, however, must seriously take into account that economic activities for 1978 slagged as compared to 1977 and according to the Employment Promotion Division the economic forecast for 1979 and beyond is very gloomy and currently the country is experiencing unfavourable balance of trade.

The Court has also got to take into consideration that the Respondents would be engaging about 60 additional employees as a result of the Presidential Directive and this would result in a labour cost increase of around Sh. 21,000 p.m. over and above the Claimants' demand.

In making its award the Court has taken into consideration a very important point that the wage increases awarded by the Court should not lead to a reduction in employment. And the Court has also taken into consideration the difficult financial position of the Respondents' members in that their margin of profit ranges between 4 to 9 per cent depending on the various types of petrol and oil products which they sold.

After careful consideration of all the submissions the Court awards the following wages minimum consolidated per month:

Wages general increment

The Court awards a wage increase of Sh. 30 p.m. to all those workers who were in employment with effect from 1st March, 1978 and another increase of Sh. 30 p.m. wage increase with effect from 1st March, 1979.

These increases are to be added on to the workers individual salaries with effect from the aforesaid dates.

Night shift allowance

The Court awards that an employee working on night shift should be entitled to night shift allowance of Sh. 3 per night with effect from 1st March, 1979.

Redundancy and severance pay

The Court awards that clause 7 (d) (4) of the collective agreement should read as follows:

"Severance pay on the basis of 14 days' pay for each completed year of service with effect from 1st January, 1967."







- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

Kenya Gazette

D.41. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.
