## VACANCIES

APPLICATIONS are invited for the posts shown below. Completed application forms should reach the Secretary, Public Service Commission of Kenya, P.O. Box 30095, Nairobi, on or before 12th July, 1979.

Civil servant applicants should complete Forms PSC. 2A in triplicate (submitting the original through their Heads of Departments) and Cards PSC. 25 and 25A. Other applicants should complete Forms PSC. 2 in triplicate and Cards PSC. 24 and PSC. 24A.

These documents are obtainable either from the Secretary or from other Government offices and are issued free of charge.

Originals of certificates and similar documents should not be submitted unless specifically asked for.

## NOTE

Incremental credits will be granted to successful candidates who are not civil servants for approved previous experience provided the maximum salary is not exceeded. They will also be eligible for benefits and privileges enjoyed by civil servants in accordance with existing Government Regulations.

*Vacancies in the Ministry of Agriculture (Research Division):**Senior Agricultural Officer (Soil Survey) (One Post) (No. 279/79)*

Salary scale.—£2,154 to £2,820 p.a. PENSIONABLE or AGREEMENT.

Applicants must be graduates in Agriculture and have successfully attended post-graduate training in Soil Science with specialization in any branch of soil survey. They should have at least three years' experience in conducting soil surveys besides a demonstrated ability in the co-ordination of the work of multi-disciplinary soil survey team.

The successful candidate will be required to co-ordinate and supervise the activities of a multi-disciplinary soil survey programme. He will be stationed at the National Agricultural Laboratories, Kabete, but will be expected to spend substantial part of the time in the field.

*Senior Technical Officer (Seeds Officer) (One Post) (No. 280/79)*

Salary scale.—£1,734 to £2,334 p.a. PENSIONABLE or AGREEMENT.

Applicants should be serving officers from the rank of Technical Officers Grade I, and would be required to have served for not less than three years at Technical Officer I level. Ability to lead and supervise the technical staff employed in the Seed Testing Laboratory is needed. In addition to this, applicants should have practical experience in Seed Testing and evaluation regarding seed quality, germination, etc. A knowledge of the operation of modern seed testing laboratory equipment is essential.

The successful candidate will be posted to National Seed Quality Control Service Station, Lanet, where he will be expected to take charge of Seed Testing Laboratory with over fifteen technical staff who are involved in the testing of a wide range of agricultural seeds from the farmers and commercial firms. The seed testing laboratory handles over 5,000 seed samples per year.

*Vacancies in the Office of the President:**Analyst Grade I (Government Chemist Department) (Two Posts)*

*Salary scale.*—£1,734 to £2,334 p.a. PENSIONABLE or AGREEMENT.

Applicants should be graduates in Chemistry and should have served in the grade of Analyst II for a period of not less than four years during which time they should have gained considerable experience in forensic science especially in the preparation of forensic reports for presentation to courts of law. Evidence of having attended a post-graduate course relevant to forensic science is an advantage. Successful candidates will be expected to supervise analytical and technological staff engaged in forensic science in the capacity of Government Analysts.

*Executive Officer Grade II (One Post) (No. 282/79)*

*Salary scale.*—£1,170 to £1,554 p.a. PENSIONABLE or AGREEMENT.

Applicants must be civil servants preferably of East African Certificate of Educational standard or its equivalent with at least two years' experience in the grade of Executive Assistant (Registry). A thorough knowledge of Government office routine, Government regulations and ability to control staff and conduct correspondence independently are essential. Preference will be given to those who have successfully completed Office Management Course at Government Training Institute, Maseno, or Kenya Institute of Administration.

Duties of the post include supervision of registry, subordinate staff, maintenance of vehicle registers, placing orders and allocation of stationery and office equipment. The successful candidate may be posted to work in any province within the Republic of Kenya.

*Executive Assistant (Nineteen Posts) (No. 283/79)*

*Salary scale.*—£864 to £1,212 p.a. PENSIONABLE or AGREEMENT.

Applicants must be civil servants preferably of East African Certificate of Education or its equivalent with at least seven years' clerical experience of which at least one year must be in the grade of Senior Clerical Officer. A thorough knowledge of Government regulations, accounting procedures and ability to control staff and conduct correspondence independently are essential. Preference will be given to applicants who have successfully completed an Executive Management course either at the Kenya Institute of Administration, Kabete, or the Government Training Institute, Maseno. A pass in the proficiency examination for Clerical Officers is mandatory.

*Vacancy in the Ministry of Commerce and Industry:**Assistant Director of Industries (One Post) (No. 284/79)*

*Salary scale.*—£2,154 to £2,820 p.a. PENSIONABLE or AGREEMENT.

Applicants should possess a degree in Economics or a related subject and must have considerable experience in industry at a senior executive level. Civil servants without the above qualifications but who are, otherwise, specialized in industrial planning or economic development matters in a responsible position will also be considered. The successful candidate will be required to assist the Director of Industries in the formulation and implementation of industrial policies. He will be expected to supervise and plan the work of junior officers in the Industrial Division of the Ministry.

Applicants should be civil servants with a minimum period of three years' service at Job Group "G". They should have a thorough knowledge of Labour Laws, Industrial Relations as well as prosecutions.

Duties include enforcement of Labour Laws through inspection of employment premises, conciliations and investigations as well as advising trade unions and employers in the settlement of trade disputes as well as advising on the improvement of working conditions of workers.

*Vacancy in the Ministry of Housing and Social Services:**Chief Technical Officer (One Post) (No. 286/79)*

*Salary scale.*—£3,144 to £3,960 p.a. PENSIONABLE or AGREEMENT.

Applicants must have a degree from a recognized university in either Architecture, Economics, Physical Planning, Land Economics and Surveying or be in possession of an equivalent professional qualification in any of the above disciplines. They must have had a minimum of eight years' post qualification experience in housing policy formulation, planning, programming and development co-ordination of which at least three years must be at a level equivalent to Job Group "M" in the Government salary structure.

The successful candidate will head the Department of Housing in the Ministry of Housing and Social Services in which capacity he will be responsible for the direction and co-ordination of the activities of the Economics, Projects and Estate Divisions of the Department as well as the Provincial Housing Units of the Ministry; liaison with the National Housing Corporation, Housing Research and Development Unit of the University of Nairobi, Local Authorities and International Agencies on policy, technical and fiscal matters pertaining to housing. He will be principal housing adviser to the Permanent Secretary to the Ministry.

*Vacancies in the Ministry of Home Affairs:**Assistant Tea Officer (Prisons Department) (One Post)*  
(No. 287/79)

*Salary scale.*—£864 to £1,212 p.a. PENSIONABLE or AGREEMENT.

Applicants must be in possession of a Diploma in General Agriculture from a recognized institution preferably with Credits or Distinctions in Horticulture and Botany. He must have worked in a tea growing district for a minimum period of three years.

The successful candidate will be posted to any one or more of the prisons farms in the Republic where he will be responsible for management and development of tea plantations. He will also be required to instruct both staff and inmates on modern methods of tea production. There are prospects of promotion to a higher grade depending on ability of the successful candidate.

*Technical Teacher Grade I (Children's Department) (One Post)*  
(No. 288/79)

*Salary scale.*—£900 to £1,674 p.a. PENSIONABLE or AGREEMENT.

Applicants should be in possession of a Diploma in Agriculture, Animal Husbandry or Horticulture. The duties of the successful candidate will be to instruct Approved School Students in the three fields mentioned above and to run a large farm which is expected to show a profit. Previous teaching/instructing experience is necessary. Ability to control both junior staff and students is a must. In both cases applicants must have very good character and must not be below 25 years of age.

Applicants with a certificate in either Agriculture or Animal Husbandry plus five years' practical experience in instructing juvenile delinquents will be also considered.

Successful candidate may be posted to any one of the Senior Approved Schools in the Republic to work at abnormal hours.

**KENYA GOVERNMENT OCCUPATIONAL TEST  
NO. III FOR TELEPHONE OPERATORS**

IT IS notified for general information that this year's Occupational Test No. III for Telephone Operators will be conducted as follows:—

- The written English Language Examination will be held on Monday, 10th September, 1979, at 9.30 a.m.
- The Oral English Language Test (for the blind candidates only) (if any) will be conducted here in Nairobi on Monday, 10th September, 1979, at 9.30 a.m. The venue for the oral test will be notified to the candidates concerned through their heads of departments in due course.
- The programme for the switchboard practical test will be drawn up soon after the closing date for the registration of candidates (see paragraph 3 below) and will be released later to all the Ministries/Departments in another circular.

**ELIGIBILITY TO ENTER**

2. The occupational test will be open to civil servants only who must be Kenya citizens and who are either serving in the obsolete Job Group "C" Grade or are Ungraded E.A.C.E. holders who had been employed on telephone duties for a period of at least one year as of 1st January, 1978.

**APPLICATION (ENTRY) FORMS**

3. Candidates should complete their application forms (IN TRIPLICATE) and submit them through their Permanent Secretaries/Heads of Departments. A specimen of the entry forms is shown as the "Appendix" to this circular and it should be reproduced by each Ministry/Department as required. The completed entry forms should be submitted to the Secretary, Public Service Commission of Kenya, P.O. Box 30095, Nairobi, so as to reach him not later than Tuesday, 31st July, 1979. The Permanent Secretaries/Heads of Departments must ensure that the entry forms are—

- filled correctly in triplicate;
- certified correct in all respects;
- accompanied by the correct registration fees of Sh. 10 per candidate;
- from eligible candidates only as stipulated in Personnel General Letter No. 21 of 25th April, 1979.

**REGISTRATION FEES**

4. Each entry form must be accompanied by a registration fee of Sh. 10 only. This fee will not be refundable under any circumstances and should be remitted in either Kenya Postal Order, Kenya Inland Money Order, payable to the Secretary, Public Service Commission of Kenya, or cash. Personal cheques will not be accepted.

**EXAMINATION CENTRES**

5. Provincial Headquarters at Mombasa, Nyeri, Embu, Nairobi, Nakuru, Kakamega, Kisumu and Garissa, will be the Examination Centres for both the written English Language examination and the switchboard tests.

**EXAMINATION STATIONERY**

6. Examination stationery and test papers for the written English examination will be supplied to the candidates by the Provincial Education Officers in charge of the Provincial Centres. Candidates will be required to have their own pens, rulers, pencils and ink. No other items such as books, magazines, etc., will be permitted into the examination room.

**ANSWER BLUE COVERS**

7. It will be necessary for each candidate to write clearly the name of the examination, subjects title, examination index number and the name of the examination centre.

**CONDITIONS FOR PASSING THE OCCUPATIONAL TESTS**

8. In order to be awarded a pass, a candidate is required to pass both the written English Test (or the oral English Test in case of blind telephone operators) and the Switchboard Practical Test in one and the same sitting.

**CERTIFICATES**

No certificates will be issued to the successful candidates but names of the successful candidates will be published in the Kenya Gazette.
