Issue in dispute:—

Deductions and demotions of Messrs. Idi Sigenyi, Wasike Muganda, Mburu Foro, Karilus Okungu and Mwinami Okusumba.

1. The Kenya Local Government Workers' Union shall hereinafter be referred to as the Claimants and the Nakuru Municipal Council shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on the 6th day of June, 1979 and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 13th June, 1978 duly signed by the parties was received by the Court on 6th March, 1979 together with the statutory certificate signed by the Labour Commissioner.

This dispute involves five persons with fairly long services with the Respondents and whose salaries were slashed by almost half with effect from February 1976. The following are the relevant details in respect of these employees:

Towards the end of 1974 the Respondents' Public Health Social Services and Education Committee recommended that the Respondents' business of brewing and selling traditional liquor, beers and other canteen goods carried out in the Councils' breweries and beer halls be discontinued fully on 31st December, 1974 and that with effect from 1st January, 1975 the Council's beer halls be tendered. This step was necessitated because of the huge losses which the Respondents had suffered during 1972, 1973 and 1974.

During this time due to the abolition of G.P.T. the Respondents had also decided to reduce staff in various departments.

It seems that all together it was the intention of the Respondents to declare 74 employees redundant and the Court was told by the Claimants, and this was not challenged by the Respondents, that no one of these employees concerned either lost his job or suffered a reduction in salary except the five persons involved in this dispute.

On 19th February, 1976 a meeting of the Joint Staff Committee took place when this question of demotion of staff was considered and it was decided to make the following recommendation to Staff and Appointments Sub-Committee:

"1. That the decision contained in minute 417 (1) (b) of the minutes of the meeting of the Special Finance, Staff and General Purposes Committee held on 2nd December, 1975 be rescinded.

2. That the seven employees namely Mwinami Okusumba, Idi Sigenyi, Wasike Muganda, Mburu Foro, Karilus Okungu, Wachira Ngorongo and Lukoye Owiti be designated supervisors and they revert to their respective salaries as provided for in the 1976 estimates."

Surprisingly nothing appears to have developed after the above decision of the J.S.C. because at the end of February 1976 the salaries of these five persons were reduced as stated hereinabove.

This dispute was the subject matter of an investigation by the Ministry of Labour and the Ministry's recommendation was in the following terms as conveyed to the parties by the Permanent Secretary:

"In view of the above observations I recommend that the five employees:

1. First and foremost be reinstated to their former salaries, paying in arrears the differences that have accrued due to payments lower than what they used to get.

2. In view of the fact that the section where the five worked was liquidated the Council should get the five employees jobs in other sections of equivalent status as those they held formerly. In the absence of any the parties in dispute through the National Joint Negotiating Council should discuss to decide whether to declare the five employees redundant."

The Claimants' main arguments in support of their demand for these five employees to be reinstated to their former salaries and to be paid the difference in their salaries which they had lost to date are that the Respondents had seriously violated clause 4 of the registered collective agreement for Committee No. 2 which states among other things:

"Neither the rates set out in appendix A nor the gradings by designations of posts in appendix B shall be varied except by a decision of the National Joint Negotiating Council."

The Claimants further stressed that the Respondents had violated clause 42 also which states that:

"Any revision of or amendment to these Terms and Conditions of Service shall be made by the National Joint Negotiating Council, in this case Committee No. 2."

The Claimants criticized the Respondents for creating a situation whereby these five workers had been frustrated and were forced to lower their standard of living by more than 100 per cent.

The Respondents maintained that they had made every effort to find alternative employment for all the persons affected by their decision to discontinue the business of brewing and selling of liquor, beer and other canteen goods formerly carried out at considerable loss to them in their breweries and beer halls. They pointed out that they had offered the lower paid jobs to the persons affected as a last resort bearing in mind that termination of service on grounds of redundancy was not in the interest of the persons affected.

The Court notes the personal details of these five employees as put forward by the Respondents. These are:

The Court has also noted that another employee, W. Ngo-rongo, who was a Superintendent earning K.Sh. 1,080 and who was given the job an Estate Supervisor at a salary of K.Sh. 840 p.m. accepted the new appointment and his dispute is therefore not before the Court. These five employees, however, did not accept the Respondents' decision at any time and the Claimants had all along pursued this matter on their behalf with the result that the matter is now before the Court.

The Court would like to recall that the Ministry of Labour Investigator confirmed that there were about 62 persons from the various departments who were affected by the financial reorganization of the Council but only the five persons suffered a demotion and reduction in salaries.

The Court finds that despite the fact that these five employees have continued to work in their new appointments at almost half their original salaries since February 1976 they have done so under protest as the Claimants had all along pursued this matter on their behalf and have brought this dispute to the Court. In these circumstances the Court finds that there is no implied acceptance by these five employees of the new arrangement and that they had no alternative but to continue working on the conditions imposed on them by the Respondents while their case was being tackled by the Claimants on their behalf.

The Court finds that the Respondents' action in unilaterally deciding to reduce the salaries of these five employees concerned by almost more than half is wrong. The least that they could have done was to discuss the matter with the employees concerned and their trade union and then either to declare them redundant and pay them the benefits due on redundancy or to seek their agreement on the revised terms and conditions of employment that were being offered to them. The Court must emphasize that any revision of terms and conditions of employment affecting any employees has got to be done in consultation with and agreement of the employees concerned and the union representing them.

The Court is satisfied that the Respondents have unwillingly indulged in a serious unfair labour practice whereby they have slashed by almost half their employees' salaries with all the attendant social consequences and hardships which these workers have suffered. The Court must add that the Claimants have raised valid points when they submitted that the Respondents have violated clause 4 and 42 of the collective agreement the relevant parts of which clauses have been set out hereinbefore in the award.

After careful consideration of all the submissions the Court finds that the Respondents were wrong in deducting the salaries of these five employees and also in demoting them to inferior jobs. The Court is aware that the arrears due to these workers for the unlawful deductions which the Respondents have made from their salaries would be over K.Sh. 120,000 but in the interest of justice and fair play the Court has no alternative but to make an award as demanded by the Claimants. The Court accordingly awards that all these five employees should be reverted to their salaries which they were drawing as at the end of January 1976 with effect from February 1976. These employees should be paid all the arrears due to them in 12 equal monthly instalments commencing from 1st October, 1979.

The Court further awards that the Respondents should immediately transfer these five employees to posts which are consistent with those they occupied in January, 1976. In the event of the Respondents not being able to do so then they would be at liberty to embark on such moves as are open to them in the collective bargaining agreement and in the relevant legislation.
