MOMBASA MUNICIPALITY—RESIDENTIAL PLOTS—NYALI ESTATE

THE Commissioner of Lands invites applications for the alienation of plots for residential purposes in the above area described in the Schedule hereto. A plan of the plots may be seen in the Public Map Office or obtained therefrom on payment of Sh. 10.

2. Applications should be submitted to the Commissioner of Lands, Nairobi, through the District Commissioner, Mombasa, P.O. Box 90430, Mombasa, stating the plot required in order of preference. Applications must be on prescribed forms which are available from Lands Department or the office of the District Commissioner, Mombasa.

3. Applications may be sent so as to reach the District Commissioner, Mombasa, not later than noon on Monday, 20th August, 1979.

4. Applicants must enclose with their applications a bank cheque, money order or postal order or cash for Sh. 1,000 made payable to the Commissioner of Lands as deposit. Personal cheques will not be accepted.

The deposit will be dealt with as follows:—

- (a) Credited to a successful applicant.
 - (b) Refunded to an unsuccessful applicant.
 - (c) Forfeited if a successful applicant fails to pay within 30 days of the offer of a plot, and the applicant shall have no further claim thereto.
5. Each application should be accompanied by a statement indicating:—
- (a) The amount of capital it is proposed to spend on the project.
 - (b) The amount of actual capital available for development with bankers letter or other evidence of financial status in support.
 - (c) The manner in which it is proposed to raise the balance required for development if any.
 - (d) Full details of both residential or/and commercial properties owned by the applicant in Mombasa Municipality.
 - (e) Individual applicants to indicate numbers of their identity cards.
 - (f) In case of companies, names of directors to be included.
6. The successful allottee of a plot shall pay to the Commissioner of Lands within 30 days of notification that his application has been successful, the stand premium and proportion of the annual rent together with conveyancing, stamp duty, registration fees, contributions in lieu of rates, road and drains charges and survey fees. In default of payment within the specified time, the Commissioner of Lands may cancel the allocation and the applicant shall have no claim to the plot.

General Conditions

1. The grant will be made under the provision of the Government Lands Act (Cap. 280 of the Laws of Kenya), and title will be issued under the Registration of Titles Act (Cap. 281) or the Registered Lands Act, as the case may be.

2. The grant will be issued in the name of the allottee as given in the letter of application and will be subject to the Special Conditions set out below.

3. The term of the grant will be for 99 years from the first day of the month following the issue of the letter of allotment.

Special Conditions

1. No buildings shall be erected on the land nor shall additions or external alterations be made to any buildings otherwise than in conformity with plans and specifications previously approved in writing by the Commissioner of Lands and the Local Authority. The Commissioner shall not give his approval unless he is satisfied that the proposals are such as to develop the land adequately and satisfactorily.

2. The grantee shall within six calendar months of the actual registration of the grant submit in triplicate to the Local Authority and the Commissioner of Lands plans (including block plans showing the positions of the buildings and systems of drainage for disposing of sewage, surface and sullage water), drawings, elevations and specifications of the buildings the grantee proposes to erect on the land and shall within 24 months of the said actual registration of the grant/lease complete the erection of such buildings and the construction of the drainage system in conformity with plans, drawings, elevations and

specifications as amended (if such be the case) by the Commissioner:

Provided that notwithstanding anything to the contrary contained in or implied by the Government Lands Act, if default shall be made in the performance or observance of any of the requirements of this condition it shall be lawful for the Commissioner of Lands or any person authorized by him on behalf of the President to re-enter into and upon the land or any part thereof in the name of the whole and thereupon the term hereby created shall cease but without prejudice to any right or action or remedy of the President or the Commissioner of Lands in respect of any antecedent breach of any condition herein contained.

3. The grantee shall maintain in good and substantial repair and condition all buildings at any time erected on the land.

Parties:—

Kenya Local Government Workers' Union
and

Kisumu Municipal Council

Issue in dispute:—

Dismissal of Mr. S. G. O. Wanyanga.

1. The Kenya Local Government Workers' Union shall hereinafter be referred to as the Claimants and the Kisumu Municipal Council shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on the 15th day of June, 1979, and relied on their written and verbal submissions. The Claimants also called Mr. Wanyanga to give evidence during the hearing.

AWARD

3. The Notification of Dispute Form "A" dated 21st November, 1977, duly signed by the parties was received by the Court on 8th March, 1978, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

Mr. S. G. O. Wanyanga was employed by the Respondents as their advocate on 7th July, 1972. He was suspended on 21st August, 1975, and dismissed on 13th November, 1975. His salary at the time of his dismissal was Sh. 3,140 per month.

Between 1974 and 1975 the Respondents lost a lot of money to the tune of over Sh. 700,000. One Mr. Odongo who was the Respondents' Revenue Collector was directly involved in the loss of quite a substantial part of this amount.

This matter was discussed on 22nd August, 1975, by the Finance, Staff and General Purposes Committee and in the relevant minute concerning Mr. Wanyanga it stated that the Municipal Advocate whose name was also associated with the said fraud was also called to be interviewed by the Committee. He informed members that Mr. Odongo had not at any time given him Sh. 5,400 as alleged by him. He went on to say that he was totally not aware of Mr. Odongo's activities as regards the loss of money. He accepted that he was in a joint business with Mr. Odongo, Oteng' Okwach, Omondi and Ondere but denied the fact that the money invested in the same business was stolen from the Council because all parties contributed money. He also told the Committee that the incubator alleged to have been bought with the stolen money from the Council had in fact been contributed for by the partners.

The Committee made the following recommendations relevant to this dispute—

"(i) that in view of the circumstances which confronted the officers the names of Messrs. J. C. A. Omondi, S. G. O. Wanyanga and K. Oteng' Okwach having been mentioned in a serious case where the Council is defrauded of Sh. 340,541/55 this Committee is satisfied that their immediate suspension was desirable and proper and hereby approves the same;

(ii) that in view of the fact that the evidence adduced before this Committee do not prove the direct involvement of Messrs. S. G. O. Wanyanga and K. Oteng' Okwach in

the fraud, their cases be dropped and the suspension on Mr. Wanyanga be lifted;

(iii) that this committee however do have serious reservations on their association with very junior fellows, the ones whose conduct is now under serious question."

On 26th August, 1975, this recommendation was considered at a full Council meeting where it was varied and the Council resolved that the suspension of Mr. Wanyanga should stand and his case be forwarded to the police and that the decision on the nature of disciplinary action the Council proposes to take against Mr. Wanyanga and others with the negligence and gross misconduct aspect of the case be deferred for the time being.

Mr. Wanyanga's matter along with the others was re-discussed by the Finance, Staff and General Purposes Committee at a special meeting held on 6th November, 1975, by which time Mr. Wanyanga was still on suspension. This Committee recommended—

"that in view of the fact that cases of serious negligence of duty and gross misconduct have been amply proved against Messrs. David Odongo, F. Ondere, J. Omondi and S. G. O. Wanyanga for their involvement in the embezzlement of the Council's money, they be summarily dismissed from the Council with loss of all benefits."

On 7th November, 1975, the full Council adopted the new recommendation and Mr. Wanyanga received his letter of dismissal on 13th November, 1975.

The Court was told that on or about 6th November, 1975, the Respondents had received a letter from the Minister for Local Government inquiring as to what they were doing in the matter of Mr. Wanyanga and others.

The Court notes that in the main Mr. Wanyanga was summarily dismissed because he was sufficiently implicated in the Respondents' view in the affairs which led to them losing over Sh. 700,000. The Respondents also alleged that he was grossly negligent in his duties and grossly misconducted himself when he joined a group of very junior Council officers in the poultry business of Nyakuno Poultry Dealers when he knew or should have known that the activities of this firm were detrimental to the Council.

It was also held against him that he had admitted having prepared a Memorandum and Articles of Association for the said firm and that he being the Respondents' legal officer should not have offered his legal services to a group of people who were engaged in activities detrimental to the Council. Further he should have realized that the cash being contributed by his partners was beyond their means and he should have suspected and reported their dealings to the Council.

The Claimants having reported a trade dispute to the Minister for Labour an investigation was carried out and the Ministry released its findings to the parties on 14th October, 1977, in the following terms:—

"FINDINGS

The Union did not dispute the alleged loss of a substantial sum of money belonging to the Council. They did not even dispute the claim that the stolen money was used to finance Messrs. Nyakuno Poultry Dealers to which Wanyanga was a partner.

The management on the other hand maintained that there was a financial racket within the Council and since Mr. Wanyanga had a share of the stolen money he had committed a gross misconduct.

From the submissions there is an apparent omission on the part of the Council in that they do not explicitly indicate whether it was against Mr. Wanyanga's contract of service for him to have engaged in business and particularly with poultry one and two whether he violated his contract of service by rendering his professional advice at his own time to his business or that of others. I find another omission on the part of the Council in that once they found out that Mr. Wanyanga was involved in misappropriation of Council's money they did not commit him to Court after their investigation. This omission apparently implies that the Council did not have or could not prove beyond doubt that Mr. Wanyanga was guilty of the offence. However, they had lost confidence in him. Under the circumstances, in the absence of any available proof, the Council should have terminated his services.

RECOMMENDATION

In view of the foregoing observations I recommend that Mr. Wanyanga's dismissal be reduced to mere termination with full benefits."

During the hearing the Claimants have submitted that the Respondents did not at any stage of the proceedings leading to Mr. Wanyanga's dismissal prove any negligence of duty or gross misconduct on his part. There certainly was no question of his being involved in the embezzlement of the Respondents' money because Mr. Wanyanga had at no time been called or interviewed by the police and no charge had been preferred against him.

The Claimants also rejected the suggestion that section 138 of the Local Government Act was contravened by Mr. Wanyanga in helping set up the firm in which he was a partner.

Mr. Wanyanga while giving evidence stated that Mr. Odongo was already a wealthy man when he came to know him. He stated that Mr. Odongo owned the Jonyo Poultry Farm with 2,000 laying hens. He had four cars, a sugar-cane farm, a tractor with a trailer and a posho mill. Further he had two bars and a tourist lodge in addition to his employment. Mr. Wanyanga added that the Town Clerk and the Councillors knew about the financial state of Mr. Odongo.

The Claimants had originally demanded a year's pay in damages amounting to Sh. 37,680 for Mr. Wanyanga's wrongful dismissal but after the hearing they indicated that Mr. Wanyanga still wished to serve the Respondents and they asked or him to be reinstated along with the damages for the wrongful dismissal that he had suffered. They pointed out that his dismissal had smeared his reputation and spoilt his name.

The Respondents emphasized that all the established procedure had been observed before Mr. Wanyanga was dismissed for the reasons which were clearly stated in his letter of dismissal and which have already been mentioned hereinabove in the award. They added that Mr. Wanyanga could not dispute available evidence confirming that some of the money which was embezzled from the Respondents ended in setting up Nyakuno Poultry Dealers, a company which Mr. Wanyanga had formed and managed as a director along with other shareholders. They asked the Court to find that they had acted properly and appropriately in dismissing a man who knowingly misconducted himself as to be unfit for employment in a public institution and in a position which demands, among other things, a high sense of responsibility and integrity.

The Court notes that Mr. Odongo was sentenced to 3½ years imprisonment for having stolen from the Respondents a sum of Sh. 347,604/55 in Criminal Case No. 403/77 in the Resident Magistrate's Court at Kisumu.

The statement which Mr. Odongo had made implicating Mr. Wanyanga has surprisingly disappeared both from the records of the Respondents and from the exhibits in the criminal case! The Court must, however, point out that even if Mr. Odongo had mentioned in his statement that he had given Mr. Wanyanga Sh. 5,400 this in itself would not prove that Mr. Wanyanga was involved in criminal activities with Mr. Odongo or that this money was stolen.

The Court would like to refer to the relevant clause in the terms and conditions of service for employees in the salaried grades which was in force at the time between the parties on termination of employment which is clause 25. In this clause in subsection (e) it is stated as follows:—

"25. (e) Where an officer admits to the commission of an act of gross negligence, gross misconduct or insubordination or any act of omission that would justify summary dismissal without notice under the law relating to master and servant he may be summarily dismissed by the Town Clerk without notice."

It is clearly stated in the above clause that an officer has to admit that he has committed an act of gross negligence, gross misconduct, etc., before he can be summarily dismissed without notice. There is no evidence at all to show that Mr. Wanyanga ever admitted having committed any such acts. On the contrary he consistently denied any knowledge of the criminal activities of Mr. Odongo.

It is not denied that Mr. Wanyanga was a partner in the firm of Nyakuno Poultry Dealers and that he helped set up this firm in business along with three other partners and that he gave his name to the Registrar of Companies as Samuel Ohon. It is also proved that he was in partnership with same other junior officers of the Respondents in this business but the Court has no reason to doubt what Mr. Wanyanga told on oath during the hearing that as far as he was aware Mr. Odongo was a wealthy man in his own right.

After carefully considering all the aspects of this case the Court has come to the conclusion that Mr. Wanyanga did not deserve a summary dismissal as no negligence of duty or gross misconduct was proved against him. There is also no evidence at all to implicate him in the loss of over Sh. 700,000 which the Respondents have suffered.

The Court would like to add that Mr. Wanyanga since his dismissal has been practising as an advocate.

The Court, however, finds having taken into account all the surrounding circumstances of this dispute that the Respondents had lost confidence in Mr. Wanyanga who was their advocate and the Court believes that they had good reasons for doing so. In these circumstances the Court finds that Mr. Wanyanga should have suffered a normal termination which in his case would entitle him to three months' written notice or three months' salary in lieu thereof. The Court accordingly awards that Mr. Wanyanga should be paid his full salary if he has not already been paid up to 13th November, 1975, and that he should be paid three months' salary in lieu of notice from that date. He should also be paid his terminal benefits on a normal termination if there are any remaining to be paid.

Having made the above award the Court rejects the Claimants' demand for Mr. Wanyanga's reinstatement or payment to him of Sh. 37,680 by way of damages.

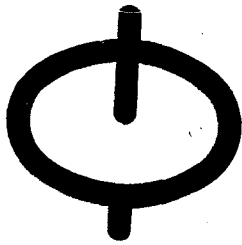

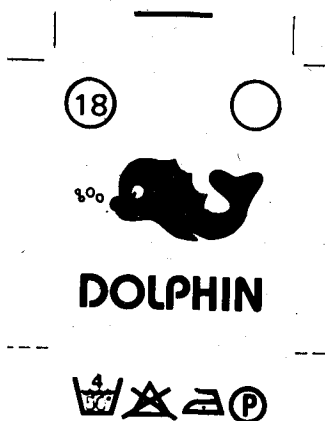

- (3) *Bill Supplement* contains Bills which are for introduction into the National Assembly only.
- (4) *Act Supplement* contains Acts passed by the National Assembly.

All "copy" submitted for publication should be prepared on one side of a foolscap sheet no matter how small the notice or Act, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible, and contain a minimum of alterations.

Particular attention should be paid to the following points:-

- (i) Signatures must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

Kenya Gazette

D.41. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer when ready.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
