Termination of appointment of Watson Wagura.

1. The Kenya Local Government Workers' Union shall hereinafter be referred to as the Claimants and the Mombasa Municipal Commission shall hereinafter be referred to as the Respondents

2. The parties were heard in Nairobi on 3rd July and 1st August, 1979 and relied on their written and verbal submissions. The Claimants also called Mr. Wagura to give evidence on oath.

AWARD

3. The Notification of Dispute Form "A" dated 7th February, 1979 duly signed by the parties was received by the Court on 26th March together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The Minister for Local Government at the time (hereinafter referred to as the Minister) appointed Messrs. James Omollo Kayila and Romesh Chander Kapoor to conduct investigations into the general administration and financial management of the then Mombasa Municipal Council. He did this on 27th August, 1975 in exercise of powers conferred upon him under regula-tion 245 of the Local Government Act (Cap. 265).

The Inspectors carried out their work and presented their report to the Minister. This report is privileged under section 131 of the Evidence Act and is a secret document.

On receipt of this report the Minister invoked the powers conferred by section 252 of the Local Government Act and removed the members of the Mombasa Municipal Council. He appointed a Commission to run the affairs of the Council in accordance with the terms and conditions of the Local Government (Mombasa Municipal Commission) Order, 1976. The Minister also issued certain directions under regulation 248 of Local Government Act (Cap. 265) which directions were marked secret and included among other things the following paragraphs:

"And whereas I am satisfied that the inefficient and wasteful administration is attributed to the conduct of the Councillors, Town Clerk, Town Treasurer and other section heads serving under the Municipality;"

"(2) The Commission terminates the services of any staff who have been found in the Report to be inefficient, negligent, and/or unproductive or have reached their retirement age or are considered excess and unnecessary."

Since the Respondents relied on the Inspectors' report which they made to the Minister the Claimants asked for the contents of the report to be divulged to them and the Court so that they could answer the charges, if any, made against their member.

The Respondents replied by saying that the Inspectors' report and the document giving directions were confidential documents and were privileged under section 131 of the Evidence Act.

After hearing the parties' preliminary arguments on this point the Court made the following order:

"The relevant part of the above two documents, i.e. Inspectors' report and the Minister's directive to be made available to the Court and the Claimants. They will be admitted subject to section 15 (1) of the Trade Disputes Act as requested by the Respondents. The documents to be made available within 14 days of the date hereof."

The Respondents accordingly filed a second submission setting out the relevant parts in the Inspectors' report that led to the termination of Mr. Wagura.

The Respondents held a meeting on 8th January, 1977 and resolved that the appointment of W. W. Wagura, the Stadium Manager, and Y. Datey, Accountant I, be terminated by giving them three months' notice with effect from 15th January, 1977 in accordance with the terms and conditions of service applicable to them and that they be not required to serve the period of notice but be paid in lieu thereof.

On 13th January, 1977 the Town Clerk served Mr. Wagura with a letter of termination and informed him that his services were terminated in accordance with clause 25 (b) of the terms and conditions of service and that he will be paid three months' salary in lieu of notice.

Mr. Wagura was paid the following benefits: K.Sh.

"Three months pay in lieu of notic	ce	10,470.00
711 days terminal leave	••	9,813.45
Provident fund benefits		84,763.55
Total		105,047.00"

The Court was told that the above amount was paid in Mr. Wagura's account and that he had since utilized it.

The Claimants reported a trade dispute on this matter to the Minister for Labour and an Investigator was appointed. The Ministry's findings and recommendations were released to the parties on 16th November, 1978 in the following terms:

"Findings:

Mr. Wagura has worked for the Council for a period of about 19 years without any adverse report.

The Commission has not advanced any reason for the termination of his services other than stating that the services of this officer were terminated under rule 25 (b) of the terms and conditions of employment.

Rule 25 is the termination of employment clause which stipulates various periods of notices of termination, retirement and termination arising out of offences committed by an officer. It is not enough to simply state that the services of an employee were terminated in accordance with the regula-tion without stating reasons for such an action.

Recommendation:

I am of the opinion that the termination of services of Mr. Wagura was wrongful and I recommend that he be reinstated without loss in service."

The Claimants have asked the Court to find that Mr. Wagura suffered a wrongful dismissal at the hands of the Respondents and he should be reinstated to his former job of the Stadium Manager and he should be compensated for all the loss that he has suffered. The Claimants pointed out that the Respondents' chairman had on the first occasion stated that retirement of employees was a normal procedure and it was wrong for other people to interpret this as sacking. This they alleged was completely against the terms and conditions of Mr. Wagura's employment.

The Claiman'ts submitted that the Respondents should have strictly adhered to clause 26, 27 and 28 as laid down in the terms and conditions of employment for salaried grades of Committee No. 1 and that the Respondents had gravely erred in not inviting Mr. Wagura to defend himself.

26th October, 1979

The Court notes that the Respondents thought it fit to act on the Inspectors' report as far as the work of Mr. Wagura was concerned in deciding to terminate his services. The Inspectors' allegations on Mr. Wagura can be summed up as follows:—

"(a) Mr. Wagura was rarely in his office. Indeed it took investigators three days to get him and interview him.

- (b) Mr. Wagura was found drinking on 15th January, 1976 between 2.30 and 3 p.m. at Jomo Kenyatta Avenue Estate when he should have been working. His excuse that he was on sick leave was unacceptable on the grounds that no doctor's certificate was produced and in any case a sick man would not have been expected to be drinking instead of resting in bed especially during working hours.
- (c) Mr. Wagura kept no records of expensive equipment at the stadium such as loudspeakers and amplifiers.
- (d) Nearly 70 passes for free entry into the stadium were found missing and the stadium manager could not give sufficient explanation for this.
- (e) Some retired officers had been left to stay with free passes for the stadium.
- (f) Mr. Wagura did not keep proper records of stadium gate collections."

In addition to above, there is one other very serious allegation against Mr. Wagura and that is that he was absent on sick leave for 100 days in 1974 and that in 1975 he was absent from 23rd July to 28th November on sick leave and in 1976 he was absent from 10th to 21st January. Then when the Inspectors started their work Mr. Wagura did not report sick.

In addition to the above rather serious allegations against Mr. Wagura re: absences due to sick leave which were not denied either by him or the Claimants the allegation against him contained in (b) above is also quite serious.

The other allegations are not so serious at all particularly the ones contained in (a) (d) and (e). The Court accepts the explanation that was given by Mr. Wagura in respect of these allegations.

The Claimants have very vigorously argued that the Respondents were bound to honour the collective agreement between them and the Mombasa Municipal Council. The Court accepts the Claimants' submission on this point as section 252 (2) of the Local Government Act clearly states that a Commission shall be subject to and liable to discharge all the duties of the local authority whose members have been removed. This would entail the collective agreement being honoured.

Mr. Wagura admitted that he owns a bar at Qua Jonvi which he was running in a building which he bought in 1969.

In the collective agreement relevant to this dispute (terms and conditions of service for employees in the salaried grades— Committee No. 1) clause 3 reads as follows:

"Legislation: This code shall be read in conjunction with the Local Government Regulations 1963 or any other Act in substitution therefor and in the event of any conflict the provisions of the Regulations, or of the Act as the case may be, shall prevail."

The above clause makes it quite clear that the Local Government Regulations and the Local Government Act prevail over the provisions of the collective agreement. The Minister gave certain directions to the Respondents in exercise of powers conferred upon him by regulation 248 of the Local Government Act (Cap. 265). One such directive was that the Commission terminates the services of any staff who had been found in the report to be inefficient, negligent and uproductive or had reached retirement age or who was considered excess and unnecessary.

There is no question of either discipline or suspension in the case of Mr. Wagura. Therefore clause 25 is relevant to this dispute which deals with termination of employment. Clauses 25 (b) and (c) read as follows:

"25. Termination of employment:

- (b) In the case of an officer in salary scales A to K inclusive by three months' written notice over the signature of the Town Clerk or three months' salary in lieu thereof.
- (c) The Council may call upon an officer to retire from its service at a notice of six months following the officer attaining the age of 55 years where in the employment of the Municipal Council of Mombasa or 60 years where in the employment of the City Council of Nairobi."

Mr. Wagura at the time of the termination of his services was about 45 years old. So clause (c) above cannot apply to him. This left the Respondents to act under clause 25 (b) in order to terminate his employment.

The Court has looked into the various aspects of this dispute most carefully and has come to the conclusion, mainly on the number of days that Mr. Wagura was sick and absent from duty in 1974, 1975 and 1976 details of which are given above, that he was, to say the least, an unproductive member of the staff. The Respondents, therefore, were justified in handing him out a normal termination which would entitled him to get all his retirement benefits. In fact he was paid K.Sh. 105,047 details of which appear earlier on.

The Court must emphasize that the circumstances prevailing in Mombasa Municipality are very special in that a Commission is running the affairs in place of an elected council. The Commission has been expressly charged to take appropriate measures to reorganize the administration of the Municipality and in addition to terminating the services of any staff for the reasons mentioned above is also empowered to transfer personnel between sections as it deems desirable for more efficient operation of the activities of the Municipality and for the general welfare of the inhabitants of Mombasa.

The Respondents having found Mr. Wagura to be unproductive, and the Court is satisfied that because of Mr. Wagura's prolonged absences due to sickness he was so, the Respondents had no alternative but to act under clause 25 (b) of the collective agreement. The Court finds under the circumstances that no principals of natural justice were offended or violated by the Respondents by not calling Mr. Wagura to answer the charges against him.

After careful consideration of all the submissions the Court finds that the Respondents were entitled to give a normal termination to Mr. Wagura with all terminal benefits. The Court notes that he has already been paid K.Sh. 105,047 and directs that if there be any further terminal benefits due to him on a normal termination then the Respondents should immediately pay him such remaining benefits. The Court finds that the Claimants' demand for Mr. Wagura's reinstatement without loss of any benefits should be rejected.
