Parties:

Kenya Management Staff Association
and
Kenya Cannery Limited

Issue in dispute:

Wrongful dismissal of James M. Kariuki.

1. The Kenya Management Staff Association shall hereinafter be referred to as the Claimants and Kenya Cannery Ltd. shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on the 23rd June, 1980 and relied on their written and verbal submissions. The Claimants also called J. M. Kariuki to give evidence on oath.

AWARD

3. The Notification of Dispute Form "A" dated 5th September, 1979 duly signed by the parties was received by the Court on 15th April, 1980 together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

This dispute concerns J. M. Kariuki who started working for the Respondents in 1969 as a fitter in the cannery department. By the end of December, 1976 as a result of various promotions and progression in his work he was drawing a salary of K.Sh. 1,725 consolidated per month. He was promoted to trainee maintenance supervisor on 1st July, 1973 and confirmed in the position on 1st January, 1974.

Mr. Kariuki was charged on five counts in a traffic case on 24th October, 1977 to which he pleaded guilty and was fined a total of K.Sh. 550. The two serious counts were:

"Fraudulently using another's vehicle's licence contrary to section 114 (1) of the Traffic Act (Cap. 403).

Fraudulently using a mutilated road fund licence contrary to section 114 (1) of the Traffic Act (Cap. 403)."

He was stopped by the police on 21st October, 1977 at Thika and was put in custody until the following day. He reported for duty on 24th October, 1977 and started working. He made this statement in Court while giving evidence on oath and further stated that he again worked on 25th October when he was asked to go and see the factory manager who told him that he had a theft case and therefore he could not be kept employed. He was not given any letter of termination and from there he went to the personnel officer who also, according to Mr. Kariuki, did not speak to him. Here again no letter of termination was served on Mr. Kariuki.

He further explained in evidence that he had picked up an expired road licence from the rubbish burning place at the Respondents' undertaking. He admitted that the expired road licence was in respect of one of the Respondents' vehicles but they had thrown it away for the purpose of being destroyed.

The Respondents did not call any witness.

The dispute was investigated by the Ministry of Labour and the finding and recommendation as conveyed to the parties were as follows:

"Mr. Kariuki submitted that he picked the alleged road licence in a dustbin as they are normally thrown after expiry. The management however accused him of removing it from a company vehicle and displaying it on his. Sufficient evidence has been produced to show that the road licence had expired as further confirmed by his being charged and fined for driving his vehicle with an expired licence. On the other hand management has not adduced any evidence to show that the company has any use of an expired road licence so that it is quite possible that Mr. Kariuki might have picked it from the dustbin. In the circumstances and due to the fact that in the eight years service given to the company by Mr. Kariuki without any warning I find the dismissal wrongful.

I recommend that he be paid his terminal benefits under the termination clause of the collective agreement between the parties and in addition be paid five months for wrongful dismissal."

The Court is satisfied that Mr. Kariuki's services were at no time formally terminated by the Respondents. The Respondents produced a copy of a letter dated 27th October, 1977 written by the Senior Department Head Personnel to A.W. Pries recommending dismissal of Mr. Kariuki but after that there is no evidence to show if in fact the Respondents either dismissed or terminated his services. Probably they completely forgot about it or someone overlooked it. During the hearing the Respondents tried to state that the letter of termination was sent to Mr. Kariuki dated 27th October but the Court does not take that seriously. The Court finds that whereas the Respondents had decided to dismiss Mr. Kariuki they failed to take effective formal steps in this direction. The Court finds that the Respondents erred in this regard and therefore clause (c) of the contract of employment between Mr. Kariuki and the Respondents applies. This clause read:

"Upon successful completion of your probationary period you will be confirmed in your position by a letter of confirmation. Thereafter termination of your appointment will be subject to three months' notice being given in writing by either side."

The Court accordingly awards that the Respondents should pay Mr. Kariuki three months' salary in lieu of notice and further directs that they should also pay him their contribution in addition to Mr. Kariuki's to the provident fund due to him. This is in addition to the other benefits to which Mr. Kariuki was entitled.

The Court has carefully considered the question of compensation to be awarded to Mr. Kariuki as demanded by the Claimants but the Court feels, taking into account all the circumstances, that three months' salary in lieu of notice along with all the terminal benefits due to him would be just and fair.

Issues in dispute:

1. Job classification.
2. Housing allowances.
3. Supply of soap for washing uniforms.
4. General wage increases.

1. The Kenya Engineering Workers' Union shall hereinafter be referred to as the Claimants and Kisumu General Engineering Employers' Group shall hereinafter be referred to as the Respondents.

2. The parties were heard in Nairobi on the 2nd July, 1980 and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 13th December, 1979 duly signed by the parties was received by the Court on 17th April, 1980 together with the statutory certificate signed by the Labour Commissioner.

The parties had a previous collective agreement effective from 1st January, 1977 for a period of two years from that date. The wages for the various grades in this agreement were as follows:

IV All artisans with Grade II Trade Test Cert. or in the employer's opinion with equivalent experience	496
V All artisans with Grade I Trade Test Cert. or in the employer's opinion with equivalent experience	550

The present dispute has arisen as the parties have failed to resolve the four issues in dispute during revising the said collective agreement. During conciliation the Claimants were represented by nine persons and the Respondents had ten representatives under the chairmanship of G. N. Konditi of the F.K.E. On the issue of wages and wage increases the following is recorded:

"The demanded increases of K.Sh. 75 for the 1st year and K.Sh. 75 for the 2nd year of the agreement and that the minimum wages be increased by the same amount. The Group offered increases of K.Sh. 20 for grade I and K.Sh. 25 for grades II to V for each year of the agreement and that the minimum rates be increased by the same amount."

Subsequently the Claimants reported a trade dispute to the Minister for Labour on 3rd March, 1979 but an interesting development took place as on the initiative of Mr. Konditi the Claimants agreed to accept the Respondents' offer of K.Sh. 40 for grades I and II and K.Sh. 45 for all other grades for the first year and similar increase for the second year but then before the matter could be finalized Mr. Konditi informed the

Claimants' general secretary that due to certain developments the agreement could not be finalized. It is obvious that the group backed out of the settlement which had been arranged by Mr. Konditi on their behalf. It should be noted that if the matter had been settled on the lines as suggested by Mr. Konditi the Claimants were prepared to drop all the other demands which are the other issues in dispute.

Now the matter is before the Court and surprisingly the Respondents stated that now they had only three members out of original 19 as all the others had resigned from the group. The Court finds this to be most regrettable and unfortunate. If these firms who backed out from the group have done so under the impression that they would not be bound by the Court award then they are mistaken because the Court will make sure through the Ministry of Labour that all those employers who were in the group when the negotiations commenced comply with the Court award. If an employer wants to leave a group then he must leave it at a time when the Claimants can without wasting any time approach and negotiate with him directly. If these employers are allowed to get away with this sort of manoeuvre it will cause very serious unrest in the country which the Court will not allow.

After the withdrawal of the employers from the agreement as stated above giving the wage increase of K.Sh. 40 and K.Sh. 45 during conciliation the Respondents offered an increase of K.Sh. 10 only. The reason for this as put forward by them is the loss of business due to the closure of Tanzania border and the uncertain situation in Uganda. The Claimants strongly challenged this assertion and maintained that these firms were in serious competition with the major and minor engineering employers' groups in the country.

The 19 members have a workforce of about 208 excluding three firms which have gone out of business. These are F.C. Gahir, Magan Engineering Works and Ruprah Engineering Works.

The Employment Promotion Division analysis reveals that the permissible wage increase compensation for the category of workers involved in this dispute under the wage Guidelines is 24.4 per cent and 17.2 per cent for the lower wage earners and middle income group respectively. The average wage increase comes to 20.8 per cent or an annual wage increase entitlement of 10.4 per cent.

After careful consideration of all the submissions the Court awards that the Respondents should honour the agreement which Mr. Konditi made on their behalf which the Court finds to be most reasonable for both the parties under the circumstances. The Court accordingly awards that all the aforesaid rates for the various grades should go up as follows:

	K.Sh.
Grades I and II	40 p.m.
Other grades	45 p.m.

any worker above these rates should also get similar increases.

These increases should be effective from 1st January, 1979 as agreed between the parties and the Court awards that the workers should get similar wage increases for the second year commencing 1st January, 1980. Since the statutory minimum rates have been revised and are effective from 1st June, 1980 the Court awards that those categories as mentioned in the parties grades which are affected by the Legal Order should be revised with effect from 1st June, 1980 to comply with the statutory rates. These along with those which are above the statutory rates are to continue in force till the end of the year when the collective agreement will expire.

The Court not feel that there is any need for the parties to embark on a job classification exercise as demanded by the Claimants or that there is any need for the quantity of soap for the purpose of washing uniforms to be increased. So both these items are rejected. Finally the Court rules that the consolidated wages as awarded above should continue in force as the workers' entitlement under the Guidelines has been given to them through wage increases.

The Court would like to request the Ministry of Labour to ensure that all the 19 firms or those of them who are still in business when negotiations commenced should comply with the Court award.

IMPORTANT NOTICE TO SUBSCRIBERS TO THE KENYA GAZETTE

THE following notes are for the guidance of persons submitting "copy" for inclusion in the *Kenya Gazette, Supplements, etc.*:-

- (1) *Kenya Gazette* contains notices of a general nature and which do not affect legislation, and may be submitted direct to the Government Printer.
- (2) *Legislative Supplement* contains Rules and Regulations which are issued by the Central Government, and must be submitted through the Office of the Attorney-General.
- (3) *Bill Supplement* contains Bills which are for introduction into the National Assembly only.
- (4) *Act Supplement* contains Acts passed by the National Assembly.

All "copy" submitted for publication should be prepared on one side of a foolscap sheet no matter how small the notice or Act, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible, and contain a minimum of alterations.

Particular attention should be paid to the following points:-

- (i) Signatures must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D-

Kenya Gazette

D.41. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer when ready.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
