THE RABIES ACT

(Cap. 365)

ORDER

IN EXERCISE of the powers conferred by section 8 of the Rabies Act, the Director of Veterinary Services orders that the following provisions shall have effect and be complied with in the area specified in the Schedule hereto, which is in area in which rabies has broken out:

1. For a period of three months from the coming into operation of this order, or for such longer period as the Director of Veterinary Services shall by notice declare, all dogs shall at all times be secured on leads except when in enclosed premises, a dwelling-house, or a building and shall be kept in enclosed premises, a dwelling-house, or a building between the hours of 7 p.m. and 6 a.m.

2. After the expiration of three months or such longer period as aforesaid, all dogs shall be secured on leads at all times when on or near a public road and shall be kept in enclosed premises, a dwelling-house, or a building between the hours of 7 p.m. and 6 a.m.

3. (1) Any dog that is suspected of having been bitten by or been in contact with a rabid animal may, if not destroyed, with the approval of a veterinary officer be secured in a place of isolation as hereinafter provided and kept under observation for a period of at least six months and shall be examined at least once a month by a veterinary officer during such period.

(2) A dog is deemed to have been in contact with an animal if it has been in the same building, kennel, field or other place as the animal.

4. For the purposes of paragraph 3, the dog shall be secured in a suitable place of detention in the immediate neighbourhood of the place where the dog is normally kept or in such other place as may be approved by the Director of Veterinary Services.

5. The place of detention shall comprise a kennel or other enclosure with sufficient adjoining space to provide for the full liberty of the dog in the open air, the whole being so enclosed as to prevent the escape of the dog therefrom or its contact with any other dog:

Provided that in the absence of such facilities the dog may, as a temporary expedient, be detained in such manner as may be approved by a veterinary officer or inspector.

6. A veterinary officer, or any person authorized by him in writing, may destroy any dog not controlled in accordance with the provisions of paragraphs 3, 4 and 5.

7. The carcass of an animal that has died from rabies or that has been destroyed on account of rabies shall be burned or buried by the owner or the person in charge of such animal.

8. No person shall move any dog or cause any dog to be moved out of or into the area specified in the Schedule without the prior written permission of a veterinary officer.

Cameraman II (Two Posts) (No. 423/80)

Applicants must have an East African Certificate of Education preferably with credits in Mathematics and General Science. They must also be in possession of a professional Diploma in Photography from an accredited institution, coupled with at least five years' practical experience in 16 mm. film production, shooting news films, features and documentaries. They must have a thorough knowledge of darkroom operations.

The duties include 16 mm. filming, negative processing, editing, scripting and supervising junior staff. These duties require a dedicated person who must have a very high sense of responsibility and meticulous accuracy.

The successful candidates must be prepared to travel extensively both inside and outside Kenya. They must be prepared to work during odd hours.

Executive Assistant (Registry) (Two Posts) (No. 424/80)

Salary scale.—£1,128 to £1,554 p.a. PENSIONABLE or AGREEMENT.

Applicants should be serving officers preferably of East African Certificate of Education standard or its equivalent with a minimum of six years satisfactory clerical experience in various aspects of general clerical functions and/or registry work. They must have passed the Proficiency Examination for Clerical Officers and must presently be serving in the grade of Senior Clerical Officer.

Ability to control staff in a large registry effectively and conduct correspondence is essential. Preference will be given to applicants who have successfully completed an executive course in office management either at Kenya Institute of Administration, Kabete or the Government Training Institute, Maseno.

Applicants must be civil servants preferably of East African Certificate of Education standard, or its equivalent, who have served as Fingerprint Assistant Grade I for a minimum period of two years.

Ability to organize work, control and conduct correspondence independently is essential. Candidates must have a thorough knowledge of both the National Social Security Fund Act and Registration of Persons Act and other Government Service Regulations.

than three years practical auditing experience gained in a professional audit firm. Serving officers in the grade of Auditor I who possess not less than three years satisfactory experience in co-operative auditing will also be considered.

Successful candidates will be required to take charge of audit teams in busy districts and will be responsible for the auditing, taxation and financial control of co-operative societies within their area of control. Ability to train and supervise staff on audit and taxation work is essential.

*Vacancies in the Ministry of Energy:**Assistant Conservator II (One Post) (No. 427/80)*

Salary scale.—£1,794 to £2,424 p.a. PENSIONABLE or AGREEMENT.

Applicants should have a B.Sc. degree in Forestry or technical training and practical experience in forestry. Adequate knowledge and field experience in tree nursery practices in different zones of the country will be an advantage.

The successful candidate will be required to supervise and develop small and large scale tree nurseries for energy plantations. Planning and budgeting for tree nursery development will be part of his responsibility besides managing a team of junior staff employed in the nurseries.

Assistant Conservator I (One Post) (No. 428/80)

Salary scale.—£2,154 to £2,928 p.a. PENSIONABLE or AGREEMENT.

Applicants must be in possession of a B.Sc. degree in Forestry with a minimum of three years of field experience in forest management. The job includes identification of appropriate species for woodfuel under different climatic conditions of Kenya. It would therefore be an advantage if the candidate has had practical experience in forestry work in different ecological zones in the selection of species to suit different climates.

This is a new and challenging job. The successful candidate will be expected to be initiative with broad knowledge of forestry particularly as it relates to selection, establishment and maintenance of suitable woodfuel species.

Superintendent (Electronics) (One Post) (No. 431/80)

Salary scale.—£1,794 to £2,424 p.a. PENSIONABLE or AGREEMENT.

Applicants must possess the East African Certificate of Education or its equivalent. They should be in possession of an Electronics Engineering Technician Certificate of the City and Guilds or equivalent and must have had at least six years experience in the installation, maintenance and operation of large scale electronics installations and equipment. Some aviation experience is desirable.

Duties will include installation, maintenance and operation of electronic installations and equipment at Airports.

Assistant Instructor (Construction Plant Mechanical) (Two Posts) (No. 432/80)

The successful candidates must be prepared to serve in any department within the Ministry.

- preparing annual and long term staffing plans for the division, reviewing the performance of sectional heads, individual staff and recommends recruitment, training and promotion where necessary.
