Issues in dispute:

Termination of services of Ibrahim Okunda.

THE Kenya Engineering Workers' Union shall hereinafter be referred to as claimants and Panafrica Enterprises (Kenya) Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 1st November, 1983, and in addition to relying on their written and verbal submissions called the following witnesses:

Claimants.—I. Erima.

Respondents.—N. Mukasa.

AWARD

3. The Notification of Dispute Form "A" dated 25th January, 1983, duly signed by the parties was received by the court on 3rd June together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The grievant, Ibrahim Okunda, worked for the respondents from 1st April, 1979, until 18th August, 1981, when he was dismissed for gross misconduct. The claimants stated that he joined the respondents in 1976 but the court is satisfied from the evidence of Nathan Mukasa, the respondents' foreman, that Mr. Okunda had first started working as a casual during which time he taught him how to spray and then from the date as stated by the respondents he was employed on permanent basis.

The incident that led to his dismissal was an allegation that he assaulted Mr. Mukasa who had found him taking a bath in factory premises. The dispute was investigated by the Ministry of Labour whose finding was that although Mr. Okunda in a statement to the investigator explained that he struggled with the foreman because the latter had taken his clothes thereby leaving him naked. This had not been supported by his own chief shopsteward. The ministry further found that he had no right to bathe naked in a public place and found that the termination was justified and the management's decision should be upheld.

During the hearing the court heard the evidence from the claimants' chief shopsteward, and Mr. Mukasa the foreman and it also had the benefit of written and verbal submissions from the parties. It is established that at the material time spray painters were allowed to take bath at twenty minutes to 5 p.m. further because of sanitary problems the toilets and the washrooms had all been closed. However a place had been set aside with corrugated iron sheets where workers could wash themselves. The court also finds it proved that Mr. Mukasa at the request of the grievant's mother had helped him get this job and that he had no *fitina* with the grievant. Mr. Mukasa told the court that on 18th August, 1981, he went around the factory at about 4.30 p.m. and found Mr. Okunda putting on his shoes at a place which had not been assigned for the workers to wash. He asked him what he was doing and got the reply "don't be stupid". Mr. Mukasa picked up the bucket and started taking it to the store where buckets are kept when he felt somebody hit him twice on the back of the head. He turned and saw Mr. Okunda who had then wanted to hit him in the face. Mr. Mukasa had to duck and Mr. Okunda then hit him many blows on the back. A worker intervened and an askari was called and Mr. Okunda was taken outside. The matter was reported to the works manager where Mr. Okunda admitted that he had beaten Mr. Mukasa. In the light of this evidence given by Mr. Mukasa and in the absence of any evidence on oath from the grievant himself who was present in court, the court has no reason to doubt that Mr. Mukasa's version of the incident is true. The fact that he is a Ugandan working here on a work permit cannot affect his credibility if the court is satisfied that he is a truthful witness. The court does not believe that Mr. Mukasa had got Mr. Okunda into trouble because the latter had refused to give him "chai" money.

The court has carefully considered this dispute and had Mr. Okunda been dismissed only for washing his body in the factory premises under the circumstances prevailing at the time, i.e. when the toilets and the washroom were out of order the court might have taken a lenient view of the offence but in this case the matter did not end there. He proceeded to assault his foreman which the court finds inexcusable. It is the court's

duty to ensure that proper discipline is maintained at the work-place and neither the management nor the workers have any right to resort to assaulting anyone as there are laid down channels for solving all disputes. The court finds that Mr. Okunda committed a gross misconduct in terms of clause 21 (d).

The court finds the claimants' argument that the dismissal letter had not been signed by a member of the management without any merit because it was issued on the instructions of the works manager.

The court rejects the claimants' demands made on Mr. Okunda's behalf.

THE Kenya Engineering Workers' Union shall hereinafter be referred to as the claimants and Crown Cork Co. (E.A.) Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 11th and 27th October and 2nd and 3rd November, 1983, and in addition to relying on their written and verbal submissions called the following witnesses to give evidence on oath:

Claimants:

P. Ngure.
A. Obura.
Z. Oriedo.

Respondents:

P. Amamu.
C. L. Shimechero.

AWARD

3. The Notification of Dispute Form "A" dated 22nd February, 1983, duly signed by the parties was received by the court on 3rd June together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

A. Obura started working for the respondents on 30th June, 1972, as a fork lift driver. After he was confirmed in his job he became a member of the claimants. In due course he was elected assistant shopsteward and later became the chief shopsteward in December 1977, remaining in that position until his dismissal on 2nd November, 1981. The letter of dismissal read as follows:

"Further to the incident of 28th October, 1981, that involved you and a supervisor and your subsequent suspension this is to confirm to you that you are summarily dismissed from today 2nd November, 1981, for gross misconduct."

The court notes that in addition to being a chief shopsteward at the respondents' undertaking Mr. Obura was also a branch executive committee member as well as a member of the national executive committee of the claimants.

The facts leading to his dismissal started on 22nd October, 1981, when a crown press operator, one Mr. Oyugi, had broken a pipe on the feeder press and was asked for an explanation which he refused to give. He was summoned by the personnel officer and after he had given an explanation he was booked to be warned for his carelessness and insubordination.

The respondents allege that on 23rd October, Mr. Oyugi brought Mr. Mutua, a union committee member, to the personnel officer and sought to have the warning letter withdrawn. His appeal was turned down. This was however denied by the claimants.

On 27th October, Mr. Obura along with his assistant Mr. Koech and Mr. Oyugi went to the personnel officer and demanded the withdrawal of the warning letter. The supervisor, Mr. Amamu, was called to explain to Mr. Obura the circumstances leading to the issuance of the warning letter. At this point the court was given two versions with the respondents maintaining that when Mr. Obura was told that the warning letter to Mr. Oyugi could not be withdrawn they all went out and Mr. Obura then approached Mr. Amamu and dumped the letter into Mr. Amamu's dust coat in rage saying "you are the supervisor, finish this matter". Mr. Obura on the other hand stated that while in the middle of discussing Mr. Oyugi's matter the personnel officer told them that he had another appointment and he therefore asked all of them to go out and settle the matter and as they went out because Mr. Obura had just come from night duty after a short discussion he and Mr. Koech left for their homes leaving the others discussing the matter. The next day they were to be briefed on the result of their discussions.

The respondents stated that they called Mr. Obura to give an explanation for his misbehaviour towards Mr. Amamu who was his superior and he gave no explanation. Later he was asked to apologize and have the matter settled but Mr. Obura refused to do so and lost his temper and shouted at Mr. Amamu wanting to know why he had reported him. It is alleged that Mr. Obura and two others had another session of shouting with the personnel officer and were ordered out after being told that the issue was closed. Some five minutes later Mr. Obura confronted Mr. Amamu and threatened to fight him over the warning issue after which Mr. Obura was ordered away from Mr. Amamu's place of work. Mr. Obura was suspended on 28th October, 1981, pending investigations into his activities.

On 29th October the respondents' employees went on strike demanding his reinstatement. A return to work formula was signed on the same day with the assistance of the district labour officer, Mr. Ngure, who drafted it. Paragraph (c) of this formula reads:

"Both Mr. Obura and Mr. Amamu will be suspended with immediate effect but on full pay. The investigation into the incident will be conducted as soon as possible and the branch secretary will be involved in the investigation."

The respondents carried out the investigations in conjunction with the claimants' branch secretary and then proceeded to dismiss Mr. Obura on 2nd November which resulted in another major strike which lasted for nearly 19 days but the respondents remained adamant and refused to take him back to work. Eventually the Labour Commissioner had to intervene in the matter and worked out a return to work formula and work resumed on 20th November, 1981. As agreed in this agreement the ministry carried out investigation into the dispute and its finding was that the dispute had been mixed up in the leadership struggle of the claimants which was going on at the time and which has somewhat clouded the real issue. The ministry found that Mr. Obura had acted emotionally in discharging his trade union duties against his employer and not against the other factions he alleges to have disliked. He had a very successful career in the company since 1972 and was able to move up to fork lift driver and had received merit increments. The ministry, however, found that Mr. Obura's enthusiasm to serve the claimants at the shop floor was somehow misguided slipping out of step in his zeal to defend his colleagues with an overwhelming loyalty to his union and not employing good measure of tact. The ministry further found that the management on the other hand handled the issue in a most unprofessional way by reporting on every reaction of Mr. Obura on the issue, to be able to find evidence enough for dismissing him. The ministry recommended that the dismissal should be reduced to termination with the payment of all terminal benefits. The claimants did not accept the findings and recommendation.

During the hearing the claimants' witnesses stated on oath that the respondents' security personnel officer, C. L. Shimechero, had shown interest in the claimants' leadership struggle which was going on at the time between two groups led by Mr. Mulei and Mr. Mboya. It is alleged that Mr. Shimechero asked them why they were supporting Mr. Mulei's group and he was told by them that it was the workers' choice. Mr. Obura in this regard also stated that in February 1981, the respondents' managing director had sent for him and asked him how he was going to perform his duties as an employee of the respondents and at the same time vying for a seat as a union assistant treasurer and chief shopsteward. He told the managing director that he would attend to his trade union activities after office hours and if needed during office hours he would seek proper permission.

It is also established that prior to March 1981, although there had been some complaints and warnings against Mr. Obura they were really not of any serious nature for having misused a fork lift, reading newspaper, being absent, being late and giving a fellow employee an off and so on. On 16th November, 1978, he received a warning on account of lateness and on 21st July, 1980, he received a warning for giving a fellow employee an off. Then on 25th March, 21st April and 7th July, 1981, he received three warnings in a matter of five months. The claimants strongly attacked these warnings and maintained that they were only issued with a view to victimizing Mr. Obura for his trade union activities and for having refused to change support in the trade union leadership struggle as suggested by the respondents. The claimants also stated that every time Mr. Obura was absent he had obtained permission from Mr. Shimechero who eventually became a turn coat and denied having given him any such permission.

It is very unfortunate and a matter of great regret that a small incident which in this case was the issuance of a warning letter to Mr. Oyugi turned into a serious dispute between the respondents and Mr. Obura who apart from being the chief shopsteward also happens to be an important member of the claimants' trade union and held official positions at branch and national level.

Mr. Shimechero the personnel and security manager naturally denied having taken any interest in the leadership struggle but the court is of the view that even if he did not go to the extent of asking the workers to support Mr. Mboya's group he certainly was interested in what was going on. The court cannot completely rule out that the respondents' approach in this whole dispute was somewhat biased against Mr. Obura because the incident of him having put Mr. Oyugi's warning letter in Mr. Amamu's dust coat pocket in itself is not such a serious act of insubordination as it is claimed by the respondents especially keeping in view the fact that both Mr. Obura and Mr. Amamu along with other workers had formed in the respondents' undertaking an Abaluya Welfare Association so Mr. Obura and Mr. Amamu enjoyed friendly relations. This sort of relationship considerably lessens the gravity of the offence.

The incident of 28th October started with Mr. Obura being called to Mr. Shimechero's office where he learnt that Mr. Amamu had reported him. Sometime after that it is alleged that Mr. Obura confronted Mr. Amamu and shouted at him saying a couple of times "today you will see who Mr. Obura is. Why did you report me to Mr. Shimechero?" The court accepts that Mr. Obura did lose his temper at Mr. Amamu as perhaps he did not expect his friend Mr. Amamu to report him on the incident of the warning letter. Mr. Amamu conceded that he was Mr. Obura's friend and they had worked together as friends although he denied that Mr. Obura had fought for his promotion when he was by-passed by another employee in the firm. The court cannot get away from the fact that Mr. Obura and Mr. Amamu enjoyed a special type of relationship which again lessens considering all the circumstances of this dispute, the gravity of the offence of Mr. Obura losing his temper and shouting at him.

The court, however, does not wish to encourage such behaviour from workers towards their superiors however friendly they may be and however important positions they may hold in their respective trade unions. This sort of behaviour if not checked can lead to a complete break down of industrial discipline.

On the second incident between Mr. Obura and Mr. Amamu the court finds that there was no threat of physical violence against Mr. Amamu from Mr. Obura. Mr. Obura had simply lost his temper. The court had the opportunity of seeing both of them and Mr. Amamu certainly appears to be a bigger and heavier man than Mr. Obura so a physical encounter initiated by Mr. Obura seems unlikely.

These aforesaid aspects apart, the court concurs with the views of the Ministry of Labour that although Mr. Obura had acted emotionally and had failed to control his temper the management had also acted most unprofessionally in that after the first strike when the return to work formula was thrashed out and it was agreed that an investigation would be carried out the respondents asked Mr. Shimechero to carry out that investigation whereas he was all along directly involved in the incident of Mr. Oyugi's warning letter and also in what transpired between Mr. Obura and Mr. Amamu. It was alleged that he was an eye witness to these incidents. This investigation should have been entrusted to some other officer and not Mr. Shimechero. Secondly having involved the ministry to settle the strike for them it was the duty of the respondents on completion of the investigation to inform the ministry of the findings of

that investigation and the course of action they intended to follow. This they failed to do and instead in a matter of two days dismissed Mr. Obura which caused another strike lasting 19 days.

The court has very carefully considered all aspects of this dispute and finds that the respondents acted rather prematurely in dismissing Mr. Obura after completing their investigations through Mr. Shimechero who was involved in one way or the other in the incidents. Keeping in view the conditions prevalent at the time it would have been very much in the respondents' own interest to keep the ministry apprised of all the developments which they failed to do and had to suffer the consequences of a 19-day full strike. The court finds that Mr. Obura has suffered a wrongful dismissal because the words he uttered to Mr. Amamu who was in a way his friend although his superior also, under all the circumstances do not amount to a gross misconduct—at least not such a serious act as to warrant dismissal. The court also has reservations about the three warnings that were handed out to Mr. Obura in quick succession in a matter of four months.

The court having found that Mr. Obura has suffered a wrongful dismissal also finds that he was not entirely blameless in this whole affair. He certainly acted very emotionally and failed to control his temper. Keeping all these points in view the court awards that Mr. Obura should be reinstated to his job with effect from the first of the month following the announcement of the award but he should not be paid any salary for the time he was out of employment. His services, however, should continue without a break. The court further directs that there should be a final letter of warning in Mr. Obura's file for his misbehaviour towards Mr. Amamu. This final warning should be accorded treatment in accordance with the parties' collective agreement.

Issue in dispute:

Wrongful dismissal of Ramadhani Kiokote, senior yard foreman grade RB I Mombasa marshalling yard on 18th March, 1978.

THE Railways and Harbours Union (K) shall hereinafter be referred to as the claimants and Kenya Railways Corporation shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 31st October, 1983, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 22nd September, 1982, duly signed by the parties was received by the court on 10th June, 1983, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

This dispute concerns an employee who worked for the respondents for a total of 25 years and at the time of dismissal in March 1978, was a senior yard foreman at Mombasa yard. His salary at the time was KSh. 1,600 p.m.

The incident that led to his dismissal was connected with the loss of coffee from three wagons approximately a load of 120 tons which at that time was valued at nearly KSh. 80,000 per ton. The coffee load from these wagons disappeared from the Mombasa railway yard. Kiokote was arrested on 2nd September, 1977, and charged with stealing goods in transit contrary to section 279 of the penal code. He was also interdicted from duty in accordance with staff regulations G. 9 (a).

The criminal case ended on 27th January, 1978, when the prosecution entered a *nolle prosequi* against him and the others who were charged with him and they were discharged under section 82 of the Criminal Procedure Code. The respondents instead of allowing him to resume duty decided to take disciplinary action against him departmentally. He was asked for an explanation under staff regulation G. 6 (c). The grievant asked to be heard in person and the hearing was conducted by traffic superintendent. The grievant naturally denied any involvement in the allegation that on the night of 1st and 2nd August, 1977, while he was working as a senior yard foreman in charge of shunting operations in Mombasa yard from 2200 to 0600 hrs. he allowed shunting engine turn No. 10/4506 working in Mbaraki Siding to proceed to Kilindini Port area where it was not authorized to work. It is alleged that he contravened SRG 2 (a). After the hearing the respondents took a decision to dismiss him with loss of all privileges. The grievant lodged an appeal which was eventually rejected sometimes towards the end of 1980. The claimants then reported a trade dispute to the Ministry of Labour whose finding was that the dismissal was too harsh and recommended it should be reduced to normal termination and he should be paid all his terminal dues based on retirement in public interest.

The claimants have relied on the staff regulation which states in part that an employee acquitted of criminal charge in any court may not be dismissed or otherwise be punished on any charge on which he has been acquitted.

In this dispute the court has first to decide if the respondents' departmental action against the grievant raised charges on which he had been acquitted in the criminal court. The court has also to decide if the respondents were right in taking departmental action against him under staff regulation G. 6 (c) (under which a lesser punishment than dismissal is accorded to the person involved) and dismissing him whereas there is another regulation G. 5 which entitles the respondents to take action against an employee with a view to dismissing him. The court notes that the respondents do not deny that they had charged Mr. Kiokote under the regulation which prescribes a lesser punishment than dismissal but they argued that this was a mere technicality and a clerical error and that Kiokote knew all along that he had sold out the railways and that stealing leads to dismissal. The court has already ruled on this point in an earlier dispute and cannot accept the respondents' submission that charging under section G. 6 (c) entitles them to dismiss an employee. The proper procedure to be followed should be that a charge under this staff regulation should be withdrawn and the employee should be recharged under regulation G. 5 which would clearly warn him that he faced dismissal and not a lesser punishment. The respondents were obviously in the wrong on this point.

On the other point that the departmental action taken against Mr. Kiokote raised substantially the same charge as that of theft for which he was acquitted, the court cannot accept the claimants' submission on this. The departmental charges were not similar to charges of stealing goods. Departmentally he was charged that he had displayed physical negligence of duty in that he failed to exercise control over engine No. 10/4506. As a senior yard foreman he was overall in charge of the shunting operations in the railways yard and to facilitate his work the respondents had provided him with a scooter which he could use while on duty. The court has carefully considered the parties' submissions on this particular point and finds that the respondents had legitimate cause to charge Mr. Kiokote departmentally as stated hereinabove. Mr. Kiokote knew the time the said engine would take to turn from Mbaraki and when he did not see it come back he should have visited the siding with his scooter. Instead he ignored its absence and proceeded to look for another engine! This is most surprising and the court has no doubt that it was because of this negligence that three wagon loads of coffee were stolen that night.

The court cannot overlook the fact that the years between 1976 and 1979 during the coffee boom had created a situation which had tempted many employees to indulge in coffee business and coffee started disappearing mysteriously all over the country. It is obvious that certain employees had joined hands with racketeers in this unlawful activity.

After careful consideration of all the submission the court finds that had the respondents departmentally charged Mr. Kiokote under staff regulation G. 5 he deserved a dismissal but unfortunately for them they committed a technical mistake in that they charged him under a staff regulation which provided for lesser punishment than dismissal. The court finds that although because of this technicality the grievant has suffered a wrongful dismissal he is not entitled to reinstatement or heavy compensation or to be retired in public interest which would enable him to earn a lifetime pension and other benefits.

Taking into consideration all the circumstances of this dispute and the fact that during his 25 years' service with the respondents he had a very poor disciplinary record involving about 44 incidents the court finds that for the technical error that the respondents committed they should pay Mr. Kiokote three months' salary for the wrongful dismissal he has suffered. The court further rules that he is not entitled to any other benefits from the respondents.
