2. Maintaining a critical record of current activities related to the assessment of global and regional environmental issues that are conducted internationally and, when relevant, by national authonities and institutions, and resulting assessment statements.

3. Collating and reviewing the assessment statements in order to determine their adequacy and their implications for both the short-term and, particularly, the long-term management of the global environment.

4. Deciding which global and regional environment issues can and must be assessed as a matter of priority, and by which bodies.

5. Determining the extent to which UNEP should be involved in the assessment process, including the collection of relevant data, and enlisting the co-operation of United Nations agencies, other organizations, national and private institutions and consultants, as appropriate, in accordance with a timetable to be decided upon in consultation with those involved.

6. Ensuring that appropriate assessment statements are produced according to the agreed timetables.

7. Establishing guidelines for the smooth running of the service.

8. Maintaining operational relations with other parts of UNEP both within and outside the office of the environment programme.

9. Supervising the development and implementation of projects related to environmental assessment, and to this end ensuring close co-operation with appropriate staff in both the environment fund and the co-operating agencies involved.

10. Supervising both professional and general service staff in the environment assessment service.

11. Selecting high-level consultants and directing their work.

- Particular attention should be paid to the following points:(i) Signatures must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D-

Kenya Gazette

"D.14.(1) Communications for the Kenya Gazette should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.

(2) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer when ready."
