1. Title.—PROGRAMME SPECIALIST in environmental sciences (arid land ecology).

Duties and responsibilities.—Under the general supervision and authority of the Director of the Regional Office for Science and

Technology for the Arab States, and in consultation with the division of ecological science at Unesco headquarters, the incumbent will carry out regional and subregional activities of Unesco in the Arab region, related to ecology, land-use planning and terrestrial resources, urban systems and urbanization, and the conservation of nature and the natural resources within the Unesco programme on Man and Biosphere (MAB):

- (a) Contribute to the promotion of the active participation of Arab states in the international environmental programmes conducted by Unesco, including the intergovernmental programme on man and the biosphere.
- (b) Assist in the establishment of national committees set up for Unesco's environmental programmes in the Arab states, and promote active co-operation in projects of mutual interest.
- (c) Assist in the efforts for the training of scientists and technicians needed by member states for land-use planning and rational use of the resources of terrestrial ecosystems, and in strengthening national infrastructures in this field.
- (d) Encourage the preservation of natural sites and the maintenance of the greatest possible variety of genetic, animal and plant resources.
- (e) Promote awareness of the causes of environmental problems and their impact on man, society and the international community, and help contribute to the protection and improvement of environment.
- (f) Help in promoting the establishment and strengthening of research and training facilities in environmental sciences relating to arid land ecology and the fight against desertification.
- (g) Assist in the organization of meetings and in the conduct of surveys necessary for the implementation in the Arab states of regional or subregional activities related to arid land ecology and the fight against desertification.
- (h) Assist in the efforts for strengthening regional or national institutions or programmes dealing with training and/or research on ecology, desertification problems, and integrated surveys, as well as other activities related to planning, land reclamation, and development of arid and semi-arid areas.
- (i) Assist in the implementation of ecological aspects of the recommendations of CASTARAB and ensure that these actions are articulated with those designed to respond to the recommendations of the United Nations Conference on Desertification.
- (j) Perform any other related duties as may be necessary, requested by the director of the office, for the promotion of these programmes in the Arab states.

Qualifications and experience required:

- (a) Ph.D and experience in one of the environmental or natural sciences, with good knowledge of modern ecology and desert technology.
- (b) Substantial experience in teaching/research in the above areas.

Provided that notwithstanding anything to the contrary contained in or implied by the Government Lands Act, if default shall be made in the performance or observance of any of the requirements of this condition it shall be lawful for the Commissioner of Lands or any person authorized by him on behalf of the President to re-enter into and upon the land or any part thereof in the name of the whole and thereupon the term created shall cease but without prejudice to any right of action or remedy of the President or the Commissioner of Lands in respect of any antecedent breach of any condition herein contained.

- 3. The grantee shall maintain in good and substantial repair and condition all buildings at any time erected on the land.
- 4. Should the grantee give notice in writing to the Commissioner of Lands that he is unable to complete the buildings within the period aforesaid the Commissioner of Lands shall (at the grantee's expense) accept a surrender of the land comprised herein:

Provided further that if such notice as aforesaid shall be given-

- (1) within twelve (12) months of the commencement of the term the Commissioner of Lands shall refund to the grantee 50 per cent of the stand premium paid in respect of the land;
- (2) at any subsequent time prior to the expiration of the said building period the Commissioner of Lands shall refund to the grantee 25 per cent of the said stand premium; or
- (3) in the event of notice being given after the expiration of the said building period no refund shall be made.
- (a) The land and buildings shall only be used for shops, offices and flats.
 - (b) Residential.
 - (c) Inoffensive light industry.
- 6. The buildings shall cover the normal site coverage for each user.
- 7. The land shall not be used for the purposes of any trade or business which the Commissioner of Lands considers to be dangerous or offensive.
- 8. The grantee shall not subdivide the land without prior written consent of the commissioner.
- 9. The grantee shall not sell, transfer, sublet, charge or part with the possession of the land or any part thereof except with the prior consent in writing of the Commissioner of Lands. No application for such consent (except in respect of a loan required for building purposes) will be considered until special condition No. 2 has been performed:

Provided that such consent shall not be required for the letting of individual shops, offices and flats.

- 10. The grantee shall pay to the Commissioner of Lands on demand such sum as the commissioner may estimate to be the proportionate cost of constructing all roads and drains and sewers serving or adjoining the land and shall, on completion of such construction and the ascertainment of the actual proportionate cost, either pay (within seven days on demand) or be refunded the amount by which the actual proportionate cost exceeds or falls short of the amount paid as aforesaid.
- 111. The grantee shall from time to time pay to the Commissioner of Lands on demand such proportion of the cost of maintaining all roads and drains serving or adjoining the land as the commissioner may assess.
- il2. Should the Commissioner of Lands at any time require the said roads to be constructed to a higher standard the grantee shall pay to the commissioner on demand such proportion of the cost of such construction.
- 13. The grantee shall pay such rates, charges, duties, assessments or outgoings of whatever description as may be imposed charged or assessed by any government or local authority upon the land or the buildings erected thereon, including any contribution or other sum paid by the President in lieu thereof.
- il4. The President or such person or authority as may be appointed for the purpose shall have right to enter upon the land and lay and have access to water mains, serving pipes and drains, telephone wires and electric mains of all descriptions, whether overhead or underground, and the grantee shall not erect any building in such a way as to cover or interefere with any existing alignments of main or service pipes or telephone or telegraph wires and electric mains.
- 15. The Commissioner of Lands reserves the right to revise the annual ground rental payable after the expiration of the 33rd and 66th year of the term granted. Such rental will be at rate of 4 per cent of the unimproved freehold value of the land as assessed by the Commissioner of Lands.
