8. The proprietor has the sole right to take such action as it deems appropriate to protect the trade marks and the right exclusively to control any litigation or proceedings arising out of any infringement challenge or claim or otherwise relating to the trade marks.

9. The responsibility for compliance with all national state, county, municipal and local laws, ordinances, rules and regulations relating to the manufacture of bottling, advertising, sale and distribution of the goods the authorization of labels, packaging and containers used in connection therewith and the maintenance and operation of their plant or plants and all their equipment shall be that of the user. The user will notify the proprietor of any changes in such laws, ordinances, rules or regulations insofar as they affect any of the above matters on the use or otherwise of ingredients in the preparation of the goods.

10. This agreement shall be deemed to have come into operation on 15th April, 1982 and shall continue for a term of ten years from that date and thereafter shall continue in force for successive periods of five years unless and until determined by either party giving to the other not less than twelve calendar months notice in writing to determine the same expiring at the determination of the first period of ten years or any subsequent period of five years.

11. Either party shall be entitled at any time by notice in writing to the other party to terminate this agreement forthwith in any of the following events: (i) if the other party shall commit any serious or persistent breach of any of the provisions of this agreement; (ii) if the other party shall fail to rectify any breach of any of the provisions of this agreement within thirty (30) days of written notice thereof; (iii) if the other party shall enter into liquidation or shall have a receiver appointed of any part of its undertaking other than for the purpose of reconstruction or re-organization or shall become insolvent or make any arrangement or composition with its creditors; (iv) if any government or agency having jurisdiction should require directly or indirectly alteration or modification of any term or condition of this agreement to the substantial detriment of such party or of the performance of either of the parties hereunder to the substantial detriment of such party or (v) any provision of this agreement shall be held illegal, invalid or unenforceable for any reason.

12. The proprietor shall also be entitled at any time by notice in writing to the user to terminate this agreement forthwith or at any time within twelve months of the following events: (i) If there shall be any sale transfer or other disposition whether by operation of law or otherwise in aggregate of more than 30 per cent of the shares or business of the user. (ii) If the affairs of the user shall cease to be under the effective control of its current owners. For the purpose of this subsection effective control shall mean the possession direct or indirect of the power to direct or influence the management and policies of the user. (iii) If manufacture shall be discontinued for more than thirty (30) days.

13. The proprietor shall also be entitled by notice in writing to the user to suspend the licence and permission granted and the delivery of essences, compounds and fruit materials in the event of *force majeure* affecting due performance by the user of its obligations hereunder or in the event of any breach of the provisions hereof.

14. This agreement shall be deemed to be a contract made in England and in accordance with its laws and as to all provisions thereof shall be construed and interpreted in accordance with such laws.

15. On the termination of this agreement the user shall consent to the cancellation of its registration as a registered user of the trade marks and shall cease forthwith to use the trade marks.
