THE INDUSTRIAL COURT

CAUSE NO. 67 OF 1983

*Parties:*Tailors and Textiles Workers' Union
and

Sunflag Textiles and Knitwear Mills Limited

Issue in dispute:

Dismissal of David Ndeto and Sammy Nzivo.

The Tailors and Textiles Workers' Union shall hereinafter be referred to as the claimants and Sunflag Textiles and Knitwear Mills Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 9th November, 1983 and 23rd February, 1984 and in addition to relying on their written and verbal submissions called the following witnesses:

Claimants.—D. Ndeto.*Respondents.*—G. Oloo.

AWARD

3. The Notification of Dispute Form "A" dated 4th November, 1983, duly signed by the parties was received by the court on 12th July, 1983, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

Grievant.—David Ndeto.

The grievant worked for the respondents from 1st January, 1967, until February, 1982, when it is alleged he absconded from duty when he was transferred from his position as factory security supervisor.

The background to both these disputes is related to the discovery of a racket involving the smuggling of the respondents' goods from their factory and being sold cheaply in the black market. The respondents alleged that their investigations revealed that there was a group of factory workers including Mr. Ndeto who was sustaining this racket and that the bulk of the goods went out from the main factory gates and it appeared that the security personnel were very much aware of it.

On 17th July, 1981, the respondents issued the following memo to their two security supervisors Tariq Khan and Mr. Ndeto:

"We would like to draw your attention to your duties as those connected with security of the factory. It is an open secret that theft of company property is on the increase and surprisingly those concerned have not been apprehended. This is a clear indication that you are not performing your duties to our expectation. We expect to have at least two to three cases a month of those concerned with stealing company property. We would like you to put more initiative on your duties and would appreciate some good results in the near future."

Despite the above letter the losses continued and in fact got more serious. This forced the respondents to seek C.I.D. assistance who unfortunately could not help them in planting some officers in the factory to find out what was happening which forced them to hire private investigators which they did in August/September, 1981. The respondents stated that the investigators' initial report was so alarming that they had to act very fast and remove Mr. Ndeto from his incumbent post to other duties by transferring him on 6th December, 1981, to their factory at Kitui Road.

The private investigators made a comprehensive report on 27th February, 1982, which the respondents alleged seriously implicated Mr. Ndeto among others.

The court had the benefit of this report during the hearing and although the claimants have objected to its admissibility the court feels that an employer is entitled to take such steps as it deems necessary to protect his business and products. The court is not bound by the rules of civil procedure court and has made its position clear in the past that in the field of industrial relations the Industrial Court cannot be too legalistic.

The court would like to refer to the following passages in the private investigators' report concerning Mr. Ndeto's involvement in the unauthorized removal of the respondents' products from the factory:

"On 7th October, 1981, time 2.10 a.m. security officer: Ndeto: The bell rung. Ndeto opened the factory door.

Walter Lando appeared to whom Ndeto handed two complete (polyester) machine rolled suiting material. Lando carried them on his shoulders and went off through the gate.

8th October, 1981. Time 1.05 a.m. Ndeto came inside the factory. He cut 12 meters of suiting material with a razor blade and left with it at 1.15 a.m. He returned again at 1.30 a.m.

21st October, 1981. Time 5 a.m. Charles Nyamu filled a trolley with complete rolls of suiting materials after which he jointly with the security officer Ndeto pushed the trolley to the outside through the main gate at 5.25 a.m. As we were reporting off duty at 7 a.m. we found the trolley empty at the main gate with Ndeto hanging around."

The aforesaid are a few extracts from the investigators' report implicating Mr. Ndeto in the loss of respondents' products. Mr. Ndeto while giving evidence naturally denied any involvement as alleged but the court is satisfied that the investigators having no personal interest in this matter had no reason or motive at all to implicate Mr. Ndeto if he was innocent.

The respondents' personnel manager, G. Oloo stated on oath that Mr. Ndeto was transferred to their Kitui branch to do general duties and that he was not told to go and work as a sweeper.

The claimants had argued that Mr. Ndeto had been asked by the general manager on 29th and 30th March to resign but since he refused to do so he was dismissed on the same day and that although his house had been searched no goods were found there. They further argued that asking Mr. Ndeto to work as a sweeper was a breach of contract.

The Ministry of Labour was in favour of Mr. Ndeto and recommended that he should be paid full terminal benefits and eight months' wages as compensation for the wrongful dismissal. The court, however, after carefully considering the parties' submissions and the evidence adduced by them has come to a different conclusion from the ministry which is that the respondents had every justification for losing confidence in Mr. Ndeto as a factory supervisor and were therefore within their rights to transfer him to their Kitui Road department. The court is satisfied that he was to be allocated general duties and that he refused to accept the transfer and appears to have absconded.

In these circumstances the court cannot help Mr. Ndeto and rejects all the claims made by the claimants on his behalf. The court would not like to encourage a situation whereby the factory security supervisors are allowed to get away after actively taking part and conniving in the unauthorized removal of their employers' property from their factories.

Grievant.—Sammy Nzivo

In this case the Ministry of Labour's findings were that Mr. Nzivo who was employed as a machine operator had been transferred by the respondents to work as a gate watchman and although the respondents said he was there for only seven days the ministry found that Mr. Nzivo had not disobeyed the instructions and had continued to act as a watchman even after the lapse of seven days when he naturally complained about his continued stay on the new job as he was basically a machine operator.

The ministry found that he had suffered a wrongful dismissal and recommended that he should be paid his full terminal benefits plus six months' wages for the wrongful dismissal.

During the hearing the respondents indicated that they would be prepared to accept the ministry's recommendation which the claimants had accepted on 21st October, 1982.

The court while noting that the claimants asked for his reinstatement without loss of wages, service and privileges deems it fair that an award should be made in terms of the ministry's recommendation in favour of Mr. Nzivo and the court accordingly awards that he should be paid two months' salary in lieu of notice for the days worked, for leave due, plus travelling allowance and six months' salary by way of compensation for the wrongful dismissal that he has suffered.

- (i) Signatures must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—**Kenya Gazette**

"D.14.(1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*."
