the case) by the local authority proved that notwithstanding anything to the contrary contained or implied by the Trust Land Act, if default shall be made in the performance or observance of any of the requirements of this condition it shall be lawful for the county council or any person authorized by the county council to re-enter into and upon the land or any part thereof in the name of the whole and thereupon the term created shall cease but without prejudice to any right of action or remedy of the county council in respect of any antecedent breach of any condition herein contained.

3. The grantee shall maintain in good and substantial repair and condition all buildings at time erected on the land.

4. Should the grantee give notice in writing to the county council that she/he/they/is/are unable to complete the buildings within the period aforesaid the county council shall (at the grantee's expenses) accept a surrender of the land comprised herein.

Provided further that if such notice as aforesaid shall be given within twelve (12) months of the commencement of the term the county council shall refund to the grantee 50 per cent of the stand premium paid in respect of the land or (2) at any subsequent time prior to the expiration of the said building period the county council shall refund to the grantee five per cent of the said stand premium. In the event of notice being given after the expiration of the said building period no refund shall be made.

5. The land and the buildings shall only be used for purposes prescribed in the schedule hereto.

6. The buildings shall not cover a greater area of the land or such lesser area as may be laid down by the local authority in its by-laws.

7. The land shall not be used for the purpose of any trade or business which the local authority considers to be dangerous or offensive.

8. The grantee shall not subdivide the land without prior consent in writing of the county council and the Commissioner of Lands.

9. The grantee shall not sell, transfer, sublet, charge or part with the possession of the land or any part thereof or any buildings thereon except with the prior consent in writing of the county council. No application for such consent (except in respect of a loan required for building purposes) will be considered until special condition No. 2 has been performed.

10. The grantee shall pay to the local authority on demand such sums as the local authority may estimate to be proportionate cost of constructing all roads and drains and sewers serving or adjoining the land and shall on completion of such construction and the ascertainment of the actual proportionate cost either pay (within seven (7) days of demand) or be refunded the amount by which the actual proportionate cost exceeds or falls short of the amount paid as aforesaid.

11. The grantee shall from time to time pay to the local authority on demand such proportion of the cost of maintaining all roads and drains serving or adjoining the land as the local authority may assess.

12. Should the local authority at any time require the said roads to be constructed to a higher standard the grantee shall pay to the local authority on demand such proportion of the cost or such construction as the local authority may assess.

13. The grantee shall pay such rates, taxes charges, duties, assessments or outgoings of whatever description as may be imposed, charged or assessed by any government or local authority upon the land or the buildings erected thereon including any contribution or other sum paid by the local authority or the council in lieu thereof.

14. The county council or such person or authority as may be appointed for the purpose shall have the right to enter upon the land and lay and have access to water mains service pipes and drains telephone or telegraph wires and electric mains of all description whether overhead or underground and the lessee shall not erect any building in such a way as to cover or interfere with any existing alignments of m in or service pipes or telephone or telegraph wires and electric mains.

15. The county council reserves the right to revise the annual ground rental payable hereunder after the expiration of the

33rd and 66th years of the term granted; such rental will be at the rate of 4 per cent of the unimproved freehold value of the land as assessed by the county council.

Annual paid leave.  
Service benefits/gratuity payment.  
Safari allowance.  
Redundancy payments.  
Sick leave.  
Job grading and classifications.  
Effective date/duration.

THE Kenya Chemical Workers' Union shall hereinafter be referred to as the claimants and Didy Pharmaceuticals Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 16th April, 1984, and relied on their written and verbal submissions.

## AWARD

3. The Notification of Dispute Form "A" dated 18th September, 1981, duly signed by the parties was received by the court on 6th December, 1983, together with the statutory certificate signed by the Labour Commissioner.

The parties to this dispute appeared before the Industrial Court in 1978, vide cause No. 22 of 1978 and the issues before the court are again the same except that this time there is an additional issue of redundancy payment. The parties signed a collective agreement effective from 1st August, 1976, for a period of three years.

It is indeed a sad state of affairs that although the next collective agreement should have been implemented with effect from 1st August, 1979, the parties were not able to conclude the matter until the dispute was referred to the court on 6th December, 1983, although the parties had signed the Notification of Dispute Form "A" on:

The claimants.—18th September, 1981.

The respondents.—27th July, 1982.

It is ironical that the matter should have been delayed so much and the parties involved in such serious confrontation

in a dispute which involves only three permanent employees although the claimants alleged that in addition to these the respondents employed about 13 casual workers also.

The respondents are a small family company and are engaged in the manufacture of medicines which include mixtures and syrups. The court notes from the price list of their products that their products listed therein are over 50.

The court is satisfied that they compete in their products with other pharmaceutical firms like:

Macs Pharmaceutical Ltd.  
Elys Chemicals Ltd.  
PAC Laboratories Ltd.  
Boots Co. Ltd.  
Manhar Brothers Ltd.  
Nicholas Laboratories Ltd.  
Sterling Products International Ltd.  
Dawa Pharmaceuticals Ltd.

The aforesaid firms employ far more workers than the three in permanent employment of the respondents with 13 or so casual workers. The respondents have four working directors and they have seven different machines and one oven. The court was told that the machines are operated by some of the directors.

The claimants were very bitter at the respondents' attitude towards negotiations and accused them of having delayed the dispute by over four years whereas the respondents stated that they could not understand the claimants' attitude and the approach to negotiations as their demands had been inconsistent and unrealistic on a number of issues like annual leave, leave allowance, service benefits, wages and job grading.

The court is satisfied that the respondents have not created any significant number of new jobs, in fact if anything they have reduced their permanent labour from five to three. The claimants naturally criticized them for this because they maintained that the guidelines had been issued by the government in order to encourage employers to create new jobs.

The court can see no reason why the respondents should not compensate their few employees in accordance with their entitlement under the guidelines. Due to this extraordinary delay in finalizing the collective agreement the workers' entitlement will have to be worked out in accordance with the 1979 guidelines and depending on the duration period which the court will decide to award the August, 1982, guidelines also have to be taken into consideration.

The court would first like to apply its mind to the effective date and duration of the collective agreement in view of the exceptional circumstances of this dispute which has resulted in a situation where the normal three-year duration period as in the past, i.e. from 1st August, 1979, to 31st July, 1982, has already expired without the workers having received any increases. During the hearing the parties indicated that they would not mind having the duration period of six years and the court after careful consideration of all the submissions awards that the effective date of the collective agreement should be 1st August, 1979, and that it should remain in force for a period of six years from that date.

In view of the above, the court will now proceed to work out the workers' entitlement under the relevant guidelines at the material time. The D.M.P.D. report shows that under the 1979 guidelines which would be relevant to the first three years of the collective agreement their entitlement would be about 16.5 per cent whereas the parties' position on wages for the first three years was as follows:

The workers' entitlement for the next three years, i.e. 1st August, 1982 to 31st July, 1985, would be 46.2 per cent representing an annual increase of 15.4 per cent.

After careful consideration of all the submissions the court awards that the respondents should pay the following wage increases for the six years commencing from 1st August, 1979—

4th year	15.5
5th year	15.5
6th year	15.5

The court directs that the workers' yearly entitlement should be worked out after adding the percentage increase granted for the previous year and the court further directs that the minimum rates should also be increased by similar percentage figures.

**Annual paid leave.**—The claimants' demand the current entitlement of 21 working days annual leave to 30 working days. The respondents have resisted this demand. The court awards that the annual paid leave should be increased to 24 working days with effect from 1st August, 1982.

**Leave allowance.**—The claimants would like the current leave allowance of KSh. 60 to be KSh. 300 and the respondents are offering an increase of 15 per cent only taking it up to KSh. 75 per year.

The court awards that for the first three years of the collective agreement the leave allowance should be KSh. 90 and for the next three years it should be increased to KSh. 120 per year.

**Service benefits/gratuity.**—The claimants demand that the current provision which appears under clause 15 (a), (b) and (c) should be amended so that the employees would be entitled to one month's salary for every completed year of service. The respondents would not like to see any change in this clause.

The D.M.P.D. analysis shows that for chemicals and related products industry workers are entitled to an average of 14.5 days' salary for every completed year of service ranging from 12.5 days to a maximum of 18 days' pay for each completed year of service.

The court has carefully considered this item and awards that the existing provisions should remain in force as employees with one to 15 years of service are entitled to two weeks' pay for every completed year of service prior to the introduction of N.S.S.F. and employees with more than 15 years' to three weeks' pay and those who are not covered by the N.S.S.F. are entitled to a service benefit for the whole of their service.

**Safari allowance.**—The claimants demand the following under this item—

making a total of KSh. 100 as against the present total of KSh. 50. The respondents have offered KSh. 64.50.

The court awards that for the first three years safari allowance should be as follows:

Breakfast ... ..	7.50
Lunch ... ..	10
Supper ... ..	12
Night stop ... ..	35

The court further awards that for the next three years the safari allowance should be in accordance with claimants' demands.

**Redundancy payment.**—The dispute under this item hinges on the claimants' demand that this clause should be redrafted to conform with the statutory provisions and that clause 21 (f) (iv) should be amended to 15 days instead of 10. The respondents have offered to increase the benefit from 10 to 12 days.

The court has carefully considered this issue and finds that the claimants' demand is reasonable and the court so award.

**Sick leave.**—At present the workers are entitled to 30 days with full pay and further 30 days with half pay which the claimants want to increase to 45 days on full pay and 45 days on half pay.

The court finds no merit in the claimants' demand and rules that the existing provision should continue.

**Job grading and classification.**—The court agrees with the respondents' submission that this is a purely academic and pointless demand in the respondents' undertaking especially in view of the fact that they have no plans to expand their operations in the near future. The court has always refused to be involved in academic exercise and this demand is accordingly rejected.

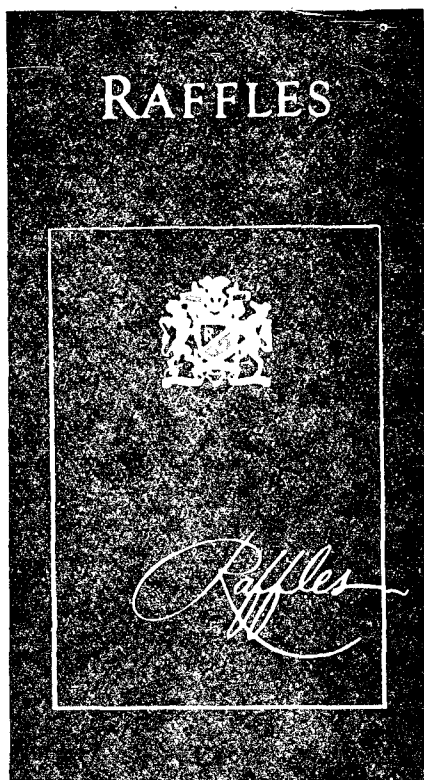

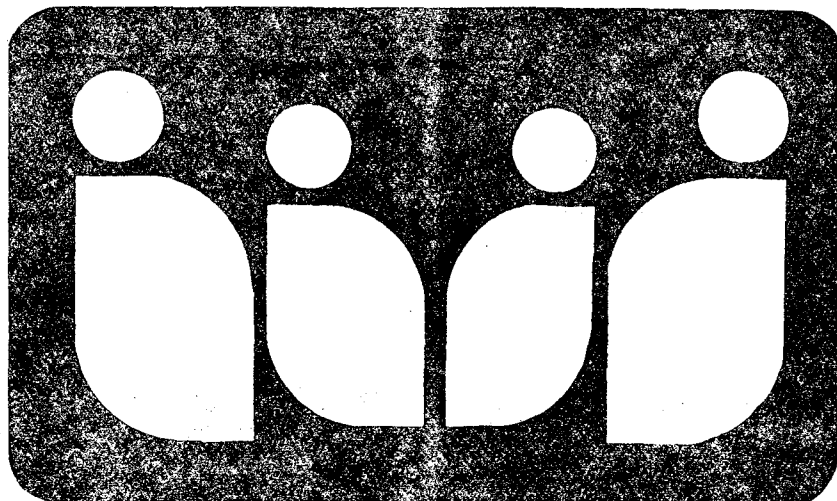
