- (e) notify in writing the Registrar of Trade Unions before the end of each month of the total amount of any payments made into the account of that trade union and that organization in that month.

Duties and responsibilities.—Under the authority of the chief of the co-ordination and evaluation unit, the holder of the post will be responsible for:

(5) Assisting the chief of the unit in dealing with the everyday business of the unit.

(6) Discharging any other tasks assigned to him/her by the chief of the unit or by the ADG/PRS.

Qualifications and experience required:

(a) University degree or equivalent training.

(b) Knowledge of the working methods of the secretariat of Unesco.

(c) Wide general culture.

(e) Very good knowledge of French and/or English; practical knowledge of Spanish desirable.

THE INDUSTRIAL COURT CAUSE NO. 116 OF 1983

Parties:

Amalgamated Union of Kenya Metal Workers and

Venus Metal (Africa) Ltd.

Issue in dispute:

Recognition.

THE Amalgamated Union of Kenya Metal Workers shall hereinafter be referred to as the claimants and Venus Metal (Africa) Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi, on 3rd May, 1984, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 7th March, 1983, duly signed by the parties was received by the court on 15th December together with the statutory certificate signed by the Labour Commissioner.

The claimants have brought this dispute against the respondents for recognition on the ground that their registed constitution caters for the interest of employees employed in an undertaking like that of the respondents, that they have recruited more than 50 per cent of their employees and there is no other rival trade union claiming to represent the respondents' employees.

The respondents have very strongly resisted this demand on the ground that their trade or industry was not in any way concerned with any manufacturing activity or other activities connected with metal trade or metal industry. They maintained that they were general merchants dealing in general hardware, building materials, sanitarywares, etc.

The respondents produced their licences which clearly confirmed that they are engaged in the import/export wholesale and retail trade. They further pointed out that they had fourteen unionizable employees in their employment and sixteen management staff making a total of thirty and strongly denied over having received the check-off list from the claimants. Later in the proceedings the claimants' representatives conceded that they had not submitted the original check-off list to the respondents as they feared the workers would be victimized but they produced this list during investigations. They added that the workers paid their union dues direct at their offices.

The court has no reason to doubt that the claimants have recognition agreements with E. Auto Tools Ltd. and United Auto Tools Ltd. although both these firms are not minufacturing metal products. The point, however, to be remembered is that when it comes to an Industrial Court award which creates a precedent, the court has to come to its decisions taking into account the existing industrial relations system and practice in the country and the evidence that is produced before it during the hearing. The court finds that the claimants' constitution under rule 2 (a) states:

"The union shall consist of workers in metal industry with all its branches and including in particular the following workers' group: motor trade group, electrical trade group, tyre manufacture and retreading group, battery manufacturing group and allied industries to the metal trade."

The court has carefully studied the above constitution and finds that a firm dealing in wholesale and retail trade cannot be considered to fall within the definition of allied industries to the metal trade as every shop invariably deals with metal products.

The only point in favour of the claimants in this dispute is that they have recruited the respondents' employees but that point in itself cannot persuade the court to come to a decision which would be patently wrong.

The court finds that the Ministry of Labour's finding and recommendation leaves a lot to be desired in this dispute. The Ministry's finding states that there are thirty members of the

claimants whereas there are only fourteen unionizable employees and the recommendation seems to be mainly based on the fact that there is no other trade union which is interested in representing the interest of the rspondents' employees!

The court would like to point out that an employer is within his rights to state that he will establish a relationship with a trade union which is the proper trade union for his industry. This is exactly what the respondents are doing in this case.

The court has previously mentioned that it has to be extremely careful in cases of this nature concerning recognition other-wise it will create a lot of mix-up and confusion in the trade union movement in the country and their relationship with the various employers.

After carefully considering all aspects of this matter the court finds that the claimants' demand for recognition against the respondents is not valid and the court accordingly rejects it.
