Issue in dispute:

Wrongful dismissal of James Okwiri.

THE Tailors and Textiles Workers' Union shall hereinafter be referred to as the claimants and E.A. Bag and Cordage Co. Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 24th July, 1984, and in addition to relying on their written and verbal submissions called the following witnesses:

Claimants.—J. Okwiri.

Respondents.—J. K. Mongare.

AWARD

3. The Notification of Dispute Form "A" dated 14th May, 1983, duly signed by the parties was received by the court on 13th February, 1984, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The grievant in this dispute, James Okwiri, worked for the respondents from 1964 until 14th January, 1982, when he was dismissed. It is not disputed that during his eighteen years' continuous service he had not received even a single warning.

The incident that led to his dismissal took place on the night of 28th November, 1981, when Mr. Okwiri was working in the night shift as a boiler attendant. At about 1 a.m. he reported to the boiler superintendent that the boiler had broken down; during that night work proceeded after the smaller boiler was run. On 29th November investigations were carried out regarding the incident and it was found that the breakdown of the boiler was due to lack of water in it and it is alleged that Mr. Okwiri had failed to start the feed pump to maintain the required water level in the boiler as per the indicator on the boiler. The respondents alleged that Mr. Okwiri had been grossly negligent in the performance of his duties and they suspected that he had left his place of work to attend a function organized by his tribesmen in the housing estate.

The claimants took up the matter on his behalf and the Ministry of Labour got involved in the dispute whose finding was that Mr. Okwiri had worked for the respondents for over

sixteen years with a clean record and that although the boiler had been damaged there was no conclusive evidence to show that the damage was due to Mr. Okwiri's negligence. The ministry found his dismissal to be rather harsh and recommended that it should be reduced to normal termination so that he is paid all his terminal benefits plus four months' salary as compensation for loss of employment. The respondents rejected the findings and recommendation and the dispute is now before the court.

During the hearing the grievant gave evidence and the respondents' works service superintendent also gave evidence. The court notes that the respondents called no evidence whatsoever in support of their suspicion that Mr. Okwiri had left his place of work to attend a party in honour of the newly posted district officer in that area. Mr. Okwiri maintained that he could not have left the factory without a pass. The court feels that if he had indeed attended the party the respondents should have been able to prove that he did so.

The respondents had enlisted the services of a boiler inspector to give his expert opinion and in the report which he made to the chief inspector of factories on 7th December, 1981, he stated as follows:

"The boiler is manual operated, it appears the operator failed to start the feed pump to maintain water level. The consequent overheating caused several of the life expired smoke tubes to perforate and spring."

It is obvious from the above that even if the boiler attendant had failed to start the feed pump the life of smoke tubes which were in use at the time had expired notwithstanding the fact that the respondents had a licence to operate the boiler. The tubes were old and this no doubt also contributed to the breakdown of the boiler.

The court notes that the respondents claim that they had suffered a loss as a result of this incident to the tune of KSh. 120,000 but then the respondents conceded that they had claimed this loss from the insurance company.

The court has carefully considered the parties' submissions and the evidence of the two witnesses and finds the Ministry of Labour's finding and recommendation to be very fair and reasonable in this dispute and the court has decided to support it. The court accordingly finds that Mr. Okwiri's summary dismissal was indeed harsh and therefore wrongful although Mr. Okwiri may have also contributed to the breakdown of the boiler.

The court awards that the respondents should pay Mr. Okwiri all his terminal benefits as per the parties' collective agreement and other lawful dues and in addition pay him four months' salary by way of compensation for the wrongful dismissal.

#### CAUSE No. 71 OF 1983

#### Parties:

Kenya Chemical Workers' Union  
and  
Polycans Ltd.

#### Issue in dispute:

#### Recognition agreement.

THE Kenya Chemical Workers' Union shall hereinafter be referred to as the claimants and Polycans Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 8th May, 1984, and relied on their written and verbal submissions.

#### AWARD

3. The Notification of Dispute Form "A" dated 3rd March, 1982, duly signed by the parties was received by the court on 15th August, 1983, together with the statutory certificate signed by the Labour Commissioner.

This dispute started in 1977 after the claimants had recruited about 47 of the respondents' employees into their membership. On 6th May, 1977, the claimants forwarded a draft recognition agreement to the respondents who pointed out to the claimants

that the workers which they had recruited into their membership and in respect of which they had submitted a check-off list were employed by them on a daily basis and were paid daily or weekly by arrangement with the workers.

The Registrar of Trade Unions was also involved in this matter at that stage and eventually the Ministry of Labour was involved as the claimants on 19th December, 1978, reported the dispute to the Minister for Labour on matter of recognition. The issue in dispute was the "company's refusal to recognize the claimants". The ministry appointed a conciliator on 16th January, 1979. The conciliator arranged meetings between the parties but the respondents refused to sign the recognition agreement and proposed amendments to the model recognition agreement which the claimants had submitted to them. In the meantime the ministry had changed the conciliator. By February, 1980, the respondents had suggested that clause 2 (e) of the recognition agreement should read as follows:

"In particular, it having been recognized and accepted by the company and the union that the company is to a very large extent dependant on the export market for the sale of its products and that such markets have through past experience and to the knowledge of the union and the company been subject to sudden sharp declines, it is hereby expressly agreed that the engagement, control and discharge of all employees not on the roll of permanent employees of the company and being casual workers and all matters pertaining to such employees whether union members or not, shall be at the sole discretion of the company and not subject to any involvement or interference by the union and the company undertakes to pay to such employees such wages as are by law lawfully due to them."

The claimants rejected these amendments and the dispute now before the court again hinges on this very issue as the respondents maintain that they are prepared to sign the recognition agreement provided clause 2 (e) is worded as set out hereinabove.

During the hearing the claimants maintained that their members had been frustrated, demoralized and exploited for a considerable length of time by the respondents because they had refused to sign the recognition agreement and to negotiate a collective agreement with them.

The claimants referred the court to the Industrial Relations Charter which was formulated way back in 1962 and stressed that the model recognition agreement had stood the best test of time since then and was a reflection of the country's approach to good industrial relations machinery. They warned that any deviation from the model recognition agreement would be creating a most undesirable precedent and the court should under no circumstances allow an employer to impose amendments to this model recognition agreement. They asked the court to direct the respondents to sign the recognition agreement as based on the model agreement which is part of the Industrial Relations Charter and further rule that there can be no amendments to this model agreement until the three parties to the charter—Government, COTU and FKE—amend or vary it. Finally they agreed that the respondents had failed to produce any strong reasons why they should not sign the model recognition agreement.

The respondents submitted that they had signed the recognition agreement on 14th October, 1980, which included the amendment proposed by them. They explained that the nature of their business necessitated their employing casual workers when they secured an order or orders for substantial quantities of their products from their clients. They gave the details of the work which these employees were required to carry out and added that at the conclusion of the order on hand the casual employees are no longer required by them until a substantial order is received by them. They gave the details of the casual employees employed by them as follows.

They pleaded that in view of the aforesaid trend of casual employment by them they did not want their discretion of hiring and firing such employees to be hindered in any way except as provided for under the law. They did not want to have to seek the approval of the claimants for the termination of the employment of the casual employees employed for any particular order.

The respondents asked the court that the claimants should be directed to sign the recognition agreement as amended by them and forwarded to the claimants on 14th October, 1980. In the alternative they pleaded that should the court order them to sign the recognition agreement as contained in the appendix of the Industrial Relations Charter then the court should give further directions that in the subsequent agreement to be negotiated and signed between the parties a paragraph in the terms as suggested by them and which appears hereinbefore in the award should be incorporated in it.

The court has given very anxious thought to this dispute and it fully appreciates the respondents' concern on the matter of casual employment by them and which has prompted them to suggest certain amendments to the model recognition agreement

which is an appendix to the Industrial Relations Charter. The court, however, after careful consideration has come to the conclusion that it cannot deviate from the model recognition agreement which has been accepted by all the employers and the trade unions and the Government of Kenya since 1962. The court is of the view that the respondents will be free to put forward their stand on the employment of casual labour when the parties sit down to negotiate a collective agreement and this matter will no doubt be dealt with at that stage. At the present time the court directs the respondents to enter into a recognition agreement with the claimants based on the model recognition agreement which is an appendix to the Industrial Relations Charter.

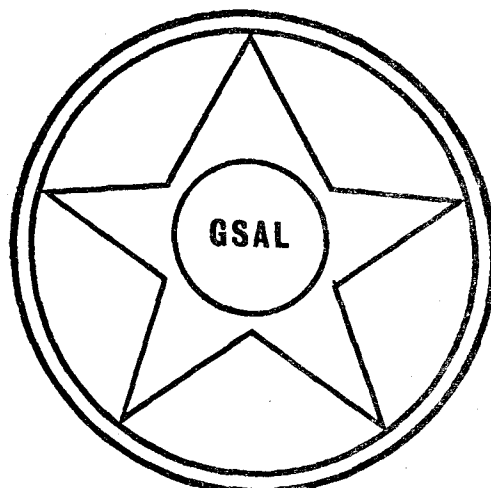
