Background.—The products concerned in the project are functional items in addition to decorative products and curios hand carved in wood, ivery and bone.

The estimated value of the carving and turning craft industry of Malawi is as follows:

- (a) annual output MK 800,000.

Existing markets are local, southern Africa and U.S.A. The potential additional markets are E.E.C. countries. All raw materials are locally produced and worked by indegenous technologies and skills.

The proportions of wood carvers to the total labour force in paid employment (365,000 as shown in the Malawi Government Economic Report, 1982) is 0.17 per cent.

The contribution to the gross domestic product is estimated at 0.05 per cept.

The proportion of export revenue generated by this sector of industry is estimated at 0.18 per cent.

Present levels of capacity utilization are medium to low. Value added locally is 100 per cent, Constraints on growth of output are caused by use of inefficient equipment, lack of technical know-how and lack of training and organizations.

The government's plan for the development of craft industry sector as a whole, is to set up a Pilot Craft Development Centre (C.D.C.). Apart from a basic training function the C.D.C. will develop the infrastructure and business linkages through area craft associations. The centre will also become the central marketing point through which orders for products obtained as a result of promotional and marketing drives of M.E.P.C. will be channeled or distributed. Additional C.D.C.'s will be set up at key areas in the country.

Promotion and marketing will be undertaken by M.E.P.C.; which will include projected marketing surveys in E.E.C. countries and other target markets. These will be followed where appropriate by trade fair participation.

Estimated annual export value to selected markets is MK475,000. Constraints on expansion of exports are lack of infrastructural development, sporadic and unreliable production and lack of product development and quality.

Duties.—The adviser will be required to carry out the following

- (2) to advise and introduce improved production methods so as to increase productivity and competitiveness:
- (3) to train counterpart in all aspects of fine relief and three dimensional carving.

Qualifications and experience.—The adviser should have either served an apprenticeship as a carver or successfully completed a training course at a recognized school of crafts. He should have at least five years of professional experience after the completion of training and be thoroughly experienced in working in wood, ivory and bone. Experience in working with rural craftsmen in a developing country is essential.

COMMONWEALTH SECRETARIAT COMMONWEALTH FUND FOR TECHNICAL CO-OPERATION

TERMS AND CONDITIONS OF SERVICE FOR FIELD ASSIGNMENTS OF SIX MONTHS OR MORE

THIS statement gives, in a condensed form, the terms and conditions of service for field assignments of six months or more.

The emoluments and allowances C.F.T.C. experts are exempt from income tax in the country of assignment. These include—

- (a) basic salary;
- (b) inducement allowance;
- (c) housing allowance.—To cover the rent of reasonable accommodation plus a contribution in local currency towards the cost of utilities;
- (d) service gratuity.—15 per cent per annum of basic salary in lieu of employers pension contribution; service gratuity is payable in arrears at six monthly intervals;
- (e) salary advance.—Free of interest, £2,400 for appointments of twelve months or more or of one month's basic salary for assignments of shorter periods will automatically be provided. The advance will be recovered from emoluments;
- (f) education allowance.—Each dependent child who is under twenty-one years of age and normally resident in the expert's household and in full time attendance at an educational institution, for reimbursement of tuition and boarding fees, actual and accounted for up to £2,000 p.a. at an approved pre-primary, primary, secondary or tertiary institution. Where the period of service does not cover the full scholastic year, the allowance will be reduced proportionately;

THE INDUSTRIAL COURT CAUSE No. 14 of 1983

Parties:

Kenya Local Government Workers' Union and

Eldoret Municipal Council

Issue in dispute:

Dismissal of Martin Ombewa.

THE Kenya Local Government Workers' Union shall hereinafter be referred to as the claimants and Eldoret Municipal Council shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 9th February, 30th May and 28th June, 1984, and in addition to relying on their written and verbal submissions called the following witnesses:

Claimants.—M. Ombewa.

Respondents .- D. K. Gitau.

AWARD

3. The Notification of Dispute Form "A" dated 27th September, 1982, duly signed by the parties was received by the court on 4th February, 1983, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The grievant in this dispute worked for the respondents from 1st August, 1974, until 31st January, 1980, when he was summarily dismissed. His dismissal was backdated to 12th August, 1977. He had, however, been suspended with effect from 12th August, 1977.

On 15th September, 1978, Mr. Ombewa was charged with the offence of stealing by servant and on 23rd October, 1979, he was found not guilty of the offence. The learned magistrate who tried him stated in his judgment that Mr. Ombewa was utterly incompetent in his job as a water superintendent and that the manner in which he had carried out his functions has resulted in financial loss to the respondents and that they were fully justified in dismissing him and even dismissing summarily. He concluded his judgment by finally stating that "I would, however, add as a final rider that the municipality should under no circumstances re-employ the accused".

The claimants took up the matter on his behalf and reported a trade dispute to the Minister for Labour and the ministry's finding was that the grievant had apologized to the respondents on 16th December, 1977, about the unaccounted seven pieces of piping which was an admission of the loss. The ministry also noted that he was acquitted in the criminal case but the acquittal did not clear him of the loss of confidence by the respondents in him in the light of his admission. It recommended that the dismissal should be reduced to normal termination and he should be paid his terminal dues.

In this dispute the grievant had the benefit of three detailed investigations, directly or indirectly. The court has gone through the criminal record and finds that the prosecution called nine witnesses who gave evidence on oath and the defendant also gave evidence and although he was acquitted the learned magistrate took the rather unusual step of concluding his judgment by saying that he should under no circumstances be re-employed by the respondents. Earlier, the magistrate had said that Mr. Ombewa deserved summary dismissal.

This was followed by an investigation by the Ministry of Labour and finally a full hearing before the Industrial Court.

The court finds that Mr. Ombewa who claims that he is a civil engineer as he is an associate member of the Society of Engineers, U.K. and also a member of the Royal Society of Health carried out his duties as a water superintendent without due regard to the established procedures. Some of the allegations against him and which were proved during the hearing were that he had received a sum of KSh. 700 in June, 1977, from a person for water supplied and had connected water supply to the applicant's plot but no record of this transaction appeared in the respondents' official books which resulted in the applicant getting free water for several months. The respondents also did not get the KSh. 700. Another incident was that he had received a sum of KSh. 760 on 8th August, 1977, at a certain farm from another applicant for water connection which money he still had in his possession and failed to remit it to the council to enable the water connection to be made.

His case was thoroughly discussed by the respondents' Finance, Staff and General Purposes Committee on 21st December, 1977, where Mr. Ombewa was also present by invitation. From the minutes of this meeting it appears that there was a thorough

hearing on the matter of his suspension. It was finally resolved that Mr. Ombewa had a case to answer of not accounting for the respondents' property he requisitioned from the stores and that before deciding on the disciplinary action to be taken against him he should be asked to pay the total cost of the loss less what had been returned to the respondents' stores.

The matter was again discussed by the same committee on 22nd December, 1977, during which meeting Mr. Ombewa asked the committee either to pardon him or to dismiss him from service or to report the matter to the police! The committee then decided that the matter should be referred to the police which resulted in the aforesaid criminal case and his acquittal but which contained severe strictures against him in the learned magistrate's judgment.

During the hearing the court was treated to further lengthy investigation reports and Mr. Ombewa's detailed explanations in reply thereto. The court has carefully considered all the evidence and finds it proved that Mr. Ombewa was indeed negligent in his work in that he failed to ensure that unused piping materials were returned to the respondents' stores for safe keeping, that he failed to use the pipes so requisitioned from the stores for purposes of work for which they had been obtained and that generally he was very negligent in his supervision of the work of his subordinates.

Halfway through the hearing before this court, Mr. Ombewa's lawyer abandoned him but the court gave him every facility to conclude the case.

The court has very carefully considered all aspects of this dispute and finds itself in total agreement with the sentiments expressed by the learned magistrate when he acquitted Mr. Ombewa of the criminal offence that Mr. Ombewa was utterly incompetent in his job as a water superintendent, that the manner in which he carried out his duties resulted in financial loss to the respondents and that they were fully justified in summarily dismissing him. The court accordingly rejects all the claims made by the claimants on Mr. Ombewa's behalf.

AWARD

3. The Notification of Dispute Form "A" dated 19th May, 1983, duly signed by the parties was received by the court on 25th October together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The grievant in this dispute, Z. Imbila, used to work for Pfizer Laboratories Ltd. up to December, 1981, when the respondents bought their Nakuru plant with effect from 1st December, 1981. Mr. Imbila was paid by Pfizer Laboratories

Ltd. a sum of KSh. 8,797 being his terminal benefits on being declared redundant.

With effect from 1st December, 1981, he started working for the respondents as a factory process worker earning KSh. 1,229 plus house allowance of KSh. 80 per month. As a result of an incident that took place on 29th January, 1982, during which it is alleged that Mr. Imbila had refused to obey the instructions of the plant manager and later had become furious and advanced wildly in karate style towards the manager, he was suspended and then dismissed on 4th February, 1982.

The claimants' branch secretary took up the matter on his behalf and it appears that he involved the district labour officer, Nakuru, in this affairs who arranged three meetings in March, 1982. The grievant and the two shopstewards and the branch secretary attended the meetings and the district labour officer recommended that the matter be settled by paying him a month's wages in lieu of notice.

The claimants' having rejected the recommendation of the district labour officer then formally reported the dispute to the Ministry for Labour and the ministry carried out a formal investigation and its findings established that Mr. Imbila was disrespectful to the management and was out to use physical means to settle his differences with the plant manager. This promoted the respondents to take disciplinary action by suspending him from duty and then of dismissing him.

After a careful evaluation of the evidence the court is satisfied that on 29th January, 1982, Mr. Imbila while engaged on offloading work on a railway wagon was performing his duties rather recklessly when he was throwing salt bags to the other gang which was standing outside the wagon with the result that the salt bags were being damaged. He was instructed to hand over the salt bags to the workers but instead of obeying he started arguing. Eventually he was asked to get out of the wagon and instructed to put the spilled salt back into the bags which made Mr. Imbila very angry. At about 10 a.m. the matter was reported to the plant manager who asked Mr. Imbila for an explanation which he refused to give saying that he had nothing to say. When the work recommenced Mr. Imbila again went into the wagon and when the plant manager came to see how the work was progressing he asked Mr. Imbila what he was doing and Mr. Imbila started shouting and there was an exchange of words between him and the plant manager during which Mr. Imbila got very annoyed and jumped towards the plant manager waiving his arms and legs in karate style. On hearing the noise and seeing what was happening another worker Mr. Imbenzi shouted in Kiswahili "usijaribu" on hearing which Mr. Imbila retreated.

The court was very impressed by the evidence of Mr. Imbenzi and the court finds him to be a truthful witness despite the fact that he lives in the servants' quarter in the house occupied by the wife of the plant manager. His evidence taken with the evidence of the other witnesses has convinced the court that Mr. Imbila did misbehave and although during several meetings to which the court does not intend to refer he was given an opportunity of apologizing to the plant manager but he refused to do so.

Considering the fact that Mr. Imbila had really worked for the respondents for only about two months and his non-repentant attitude, the court is in total agreement with the Ministry of Labour's recommendation that his service should be terminated by giving him one month's notice or salary in lieu thereof. The court would like to impress upon the workers that they must refrain from resorting to physical violence in settling their real or alleged differences with the management. In Kenya we have a well established industrial relations machinery to which workers and employers are entitled to resort to at any time

The court finds that the claimants have made a vigorous attempt in this dispute on behalf of Mr. Imbila but finds that they have failed to convince the court by a very wide margin on the innocence of Mr. Imbila. The court also accepts the evidence of T. Jason that he at no time agreed to Mr. Imbila's reinstatement when he was journeying towards Nakuru with an official of the claimants. The court accordingly rejects the claimants' demand made on Mr. Imbila's behalf and awards that the respondents should change Mr. Imbila's summary dismissal to a normal termination of service which would entitle him to one month's notice or pay in lieu thereof and his other lawful termination dues.

THE TRUST LAND ACT (Cap. 288)

PLOTS FOR ALIENATION—HOMA BAY TOWNSHIP

THE Commissioner of Lands invites applications for alienation of plots in the above-mentioned area described in the schedule hereto. A plan of the plots may be seen in the Public Map Office, Lands Building, city square, or obtained therefrom on payment of KSh. 10 or in South Nyanza County Council offices.

- 2. Applications may be sent so as to reach the Clerk to Council, County Council of South Nyanza, P.O. Box 20, Homa Bay, not later than 12 noon, on Friday, 12th October, 1984, and should not be sent direct to the Commissioner of Lands, Nairobi. Applications must be on the prescribed forms which are available from Lands Department of office of the Clerk, County Council of South Nyanza.
- 3. Applicants must enclose with their applications a bank cheque, postal order, money order or cash for KSh. 1,000 made payable to the Commissioner of Lands as deposit. Personal cheques will not be accepted.

The deposits will be dealt with as follows:

- (a) Credited to a successful applicant.
- (b) Refunded to an unsuccessful applicant.
- (c) Forfeited if a successful applicant fails to pay within thirty (30) days of the offer of a plot from the date of the letter of allotment, and the applicant shall have no further claim thereto.
- 4. Each application should be accompanied by a statement indicating:
 - (a) Amount of capital available for the purchase of the plot.
 - (b) The aim of capital available for the development of the plot. Attach a bank statement or letter from a bank or any other financial institution indicating the amount of development loan they are prepared to give you if you are allocated with a plot.
 - (c) The manner in which it is proposed to raise the balance required for development, if any.
 - (d) Full details of other plots owned by the applicant in this township.
 - (e) Individual applicants must quote their identity card numbers and their nationalities.
 - (f) In case of companies, names of directors must be included and a photostat copy of the company's registration certificate.

General Conditions

- 1. The grant will be prepared under the provision of the Trust Land Act and title will be issued under the Registered Land Act (Cap. 300).
- 2. The grant will be made in the name(s) of the allottee(s) as given in the letter of application and will be subject to special conditions set out below.
- 3. The term of the grant will be for ninety-nine (99) years from the first day of the month following the issue of letter of allotment.

Special Conditions

- 1. No buildings shall be erected on the land nor shall additions or external alterations be made to any buildings otherwise than in conformity with plan and specifications previously approved in writing by the local authority. The local authority shall not give approval unless it is satisfied that the proposals are as such as to develop the land adequately and satisfactorily.
- 2. The grantee shall within six calendar months of the actual registration of the lease submit in triplicate to the local authority plans (including block plans showing the positions of the buildings and system of drainage for the disposal of sewage surface and sullage water) drawing elevations and specifications of the buildings the grantee proposes to erect on the land and shall within twenty-four (24) months of the actual registration of the lease complete the erection of such buildings and the construc-

tion of the drainage system in conformity with such plans, drawings, elevations and specifications as amended (if such be the case) by the local authority provided that notwithstanding anything to the contrary contained or implied by the Trust Land Act, if default shall be made in the performance or observance of any of the requirements of this condition it shall be lawful for the county council or any person authorized by the county council to re-enter into and upon the land or any part thereof in the name of the whole and thereupon the term created shall cease but without prejudice to any right of action or remedy of the county council in respect of any antecedent breach of any condition herein contained.

- 3. The grantee shall maintain in good and substantial repair and condition all buildings at the time erected on the land.
- 4. Should the grantee give notice in writing to the county council that she/he/is/are unable to complete the buildings within the period aforesaid, the county council shall (at the grantee's expenses) accept a surrender of the land comprised herein.

Provided further that if such notice aforesaid shall be given within twelve (12) months of the commencement of the term, the county council shall refund to the grantee 50 per cent of the stand premium paid in respect of the land or (2) at any subsequent time prior to the expiration of the said building period the county council shall refund to the grantee five per cent of the said stand premium. In the event of notice being given after the expiration of the said building period no refund shall be made.

- 5. The land and the buildings shall only be used for the purposes prescribed in the schedule hereto.
- 6. The buildings shall not cover a greater area of the land or such lesser area as may be laid down by the local authority in its by-laws.
- 7. The land shall not be used for the purpose of any trade or business which the local authority considers to be dangerous or offensive.
- 8. The grantee shall not subdivide the land without prior consent in writing of the county council and the Commissioner of Lands.
- 9. The grantee shall not sell, transfer, sublet, charge or part with the possession of the land or any part thereof or any buildings thereon except with the prior consent (except in respect of a loan required for building purposes) will be considered until special condition No. 2 has been performed.
- 10. The grantee shall pay to the local authority on demand such sums as the local authority may estimate to be proportionate cost of constructing all roads and drains and sewers serving or adjoining the land and shall on completion of such construction and the ascertainment of the actual proportionate cost either pay (within seven days of demand) or be refunded the amount by which the actual proportionate cost exceeds or falls short of the amount paid as aforesaid.
- 11. The grantee shall from time to time pay to the local authority on demand such proportion of the cost of maintaining all roads and drains serving or adjoining the land as the local authority may assess.
- 12. Should the local authority at any time require the said roads to be constructed to a higher standard the grantee shall pay to the local authority on demand such proportion of the cost or such construction as the local authority may assess.
- 13. The grantee shall pay such rates, taxes, charges, duties, assessments or outgoings of whatever description as may be imposed, charged or assessed by any government or local authority upon the land or the buildings erected thereon including any contribution or other sum paid by the local authority or the council in lieu thereof.
- 14. The county council or such person or authority as may be appointed for the purpose shall have the right to enter upon the land and lay and have access to water mains, service pipes and drains, telephone or telegraph wires and electric mains of all description whether overhead or underground and the lessee shall not erect any buildings in such a way as to cover or interfere with any existing alignments or main or service pipes or telephone or telegraph wires and electric mains.
- 15. The county council reserves the right to revise the annual ground rental payable hereunder after the expiration of the 33rd and 66th years of the term granted such rental will be at the rate of 4 per cent of the unimproved freehold value of the land as assessed by the county council.

- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D-Kenya Gazette

"D.14.(1) Communications for the Kenya Gazette should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.
