VACANCIES OFFERED BY UNESCO

Title.—PROGRAMME SPECIALIST (technical education).
 Post No.—ED-909 and ED—923.

Category and level.-Professional category (P-5).

Organizational location.—Educational finance division education sector.

Duties and responsibilities.—The incumbents will be staff members of the division which is responsible for the execution of the co-operative programme with the World Bank. This programme was established in 1964, by memorandum of understanding under which the two organizations agreed to co-operate in, among other things, the following tasks—

- (a) assisting countries of common membership in conducting education sector studies, and identifying and preparing education projects;
- (b) appraising such project;
- (c) supervising the implementation of such project;
- (d) evaluating completed projects.

These tasks may be modified as a result of the impending review of the co-operative programme.

In the execution of this programme, the incumbents will participate primarily in the various missions required to carry out (a) and occassionally (b), (c) and (d). They may also undertake other assignments that may be mutually agreed upon between Unesco and the World Bank. The work required of the incumbents will vary with the type of mission to which they are assigned. Education sector study and project identification missions undertake analyses of educational systems and their current problems with the aim of identifying priority areas and project items for external financing. Such work is conducted in close collaboration with the national authorities concerned, and it involves careful study of alternative educational policies and programmes and of the human, material and financial resources that are required for their implementation. After a period (normally around four weeks) in the country concerned, a detailed report is prepared at headquarters.

Project preparation (normally four to five weeks) involves the detailed definition of projects. It specifies the technical features of each project item such as location of educational institutions, enrolment, curriculum, teacher supply, schedule of accommodation, administrative structure and capital and recurrent costs.

Members of the division are expected to travel at least three to four months a year and work as a team consisting usually of four to five specialists. They may also be required to participate in bank appraisal or economic survey missions involving studies similar to the above though with greater emphasis on economic and financial aspects. They may also be required to participate in supervision of end-use project completion/evaluation missions.

While under the supervision of the director of the division, the incumbents are responsible for the professional content of his work. Questions arising during project preparation are settled in collaboration with team members on the spot. They decide as a team on projects identified, subject to revision after a discussion with their colleagues in the division and other interested sectors in the secretariat. They may, with sufficient experience, be called upon to act as mission leaders.

Staff members of the division may also be required to contribute to the regular programme of Unesco in accordance with their competence and qualifications.

With the framework of the above general duties, the technical education specialist has the following specific tasks—

- (1) to analyse, review and make suggestions pertaining to the improvement of the technical education and vocational training system of the country, at all levels, including aspects of institutional set-up and management, curricula as well as training programmes, and teacher/instructor requirements in qualitative and quantitative terms in a variety of fields;
- (2) to make suggestions relative to project components that may be suitable for external financing by the World Bank or other funding agencies, and to elaborate detailed project design other than architectural aspects, as may be required,

giving particular attention to the requirements for equipment and the needs for consumable training materials;

- (3) to undertake missions in his field to assist countries in the implementation of projects financed by the World Bank, or undertaken in agreement between the country in question and Unesco or the World Bank;
- (4) to prepare clear and concise reports concerning the above.

These tasks will be performed with the due regard to continuity of project or country assignments, but without such assignments being given on a permanent basis. As a consequence the incumbents may be required to work in the frame of widely differing educational systems and socio-cultural conditions.

Qualifications and experience required:

- (a) Candidates should have maturity, breadth and variety of experience in technical education and/or vocational training for a duration of several years, having passed through assignments of varied but increasing responsibility. A proven ability to prepare clear and concise reports in this field is essential.
- (b) Professional experience as planner or administrator at the international or national level would be an important asset. Experience in developing countries is essential.
- (c) Candidates should have an advanced degree or equivalent experience in one of the following fields: engineering, technical education or vocational training. Teaching experience is desirable. Experience in the design of curricula for technical education or training programmes in vocational training, as well as experience in high-level planning offices would be an asset.
- (d) Candidates should have knowledge and experience of technical education and vocational training systems in various countries. Practical experience in industry would be an asset.
- (e) Ability to negotiate at a high level, and to work cooperatively with different cultural and ethnic groups. Proven ability to work in a team is essential.
- (f) Candidates should be fluent in English or French and have a good working knowledge including ability to draft, in the other of these two languages or in Spanish or Arabic.

Salary and allowances.—Initial appointment will be at P-5 grade with a salary equivalent to US\$33,318 (US\$30,776 if without dependants) per annum, payable mainly in French francs, plus the prescribed annual allowances, e.g. post adjustments, at present US\$12,750 for staff members with dependants, US\$11,781 for staff members without dependants, family allowances of US\$700 for each dependent child (if there is no dependent spouse, this indemnity is not payable in respect of the first dependent child). These emoluments are normally exempt from all direct taxation. Income tax on such remuneration, if levied, is reimbursed in accordance with staff regulations and rules.

2. Title.—PROGRAMME SPECIALIST.

Category and level.—Professional category (P-3).

Organizational location.—Higher education section, division of higher education and training of educational personnel.

Duties and responsibilities.—Under the supervision of the director of the division of higher education and of the training of educational personnel and at the direction of the chief of the higher education section, the incumbent will take part in carrying out the organization's programme in the field of higher education. To that end, he or she will—

- (a) assist the chief of the higher education section in activities related to regional and international co-operation with a view to developing and improving higher education for social progress, including co-operation between Unesco and the NGOs concerned with higher education;
- (b) will be responsible for carrying out certain activities in the framework of the programme of participation and cooperation with the member states and certain activities connected with higher education's contribution to the development of the educational system as a whole;
- (c) take part in the preparation of meetings and the drafting of documents for higher education programmes and in the implementation of study programmes; and
- (d) be responsible for, or participate in, other activities of the higher education section as required.

- (a) University degree, preferably in education or the humanities or equivalent; post-graduate training would be an asset.
- (b) Familiarity with the problems of higher education acquired through experience in teaching, administration or research at the national or international level.

- (d) Experience in international co-operation, particularly multilateral co-operation.

- (a) Supervising the work of the unit in its endeavours to maintain volumes I and II of the Unesco manual up to date.
- (b) Organizing and co-ordinating the preparation of texts on administrative policies, procedures and practices of the secretariat, seeking their improvement and simplification for issue in the manual; to this end, taking initiative, on his own or upon request of units concerned, to negotiate the revisions and amendments to the manual, to draft new items necessitated by administrative instruction and/ or structural changes, to obtain the concurrence of interested parties; to organize meetings with A.Os, etc.
- (b) Supervising the issue of administrative circulars for the secretariat and incorporating relevant texts therefrom and from standing instructions of the D.G. into the manual.
- (c) Controlling the Unesco forms proposed to be issued on behalf of PER.
- (d) Performing other related duties as may be assigned.

Qualifications and experience required:

- (a) University degree in administration or in a related field, or equivalent experience.
- (b) Several years of progressively responsible experience in the application of administrative procedures.
- (c) Excellent knowledge of and ability to write clearly and concisely in English or French; good working knowledge of the other language.

- (a) Editing the quarterly, impact of science on society, within the framework of the policy defined by the general conference, including the selection of topics and authors of articles, revision, illustrations, editing or rewriting articles submitted for publication, the verification of translations and proofs and co-operation with the office of, publications in promotion, printing and distribution.
- (b) Supervision of the science in the contemporary world section of the division of scientific research and higher education.
- (c) Keeping abreast of the most significant developments relating to the interaction between science, society and technology through conferences, publications and personal contacts.
- (d) Planning, arranging and supervising, in collaboration with the office of public information, multi-media treatment of Unesco's activities in the natural and engineering sciences.

Qualifications and experience required:

- (a) University degree(s) in science or engineering, coupled with wide scientific and technical knowledge and experience in editing, publishing or audio-visual production dealing with science and public affairs.

ANNEX

Background.—One of the immediate tasks facing Namibia upon attainment of independance will be the development of an effective system of national education. At present there is a dearth of trained Namibia educational personnel and a need for both quantitative and qualitative improvement of the education system. The U.N. Institute of Namibia (UNIN) was established in Lusaka in 1976, to provide post-secondary training in key areas for the administration of an independent Namibia. e.g. agriculture and land resources, constitutional and legal affairs, economics, history and politics, and social and education affairs. UNIN quickly initiated plans to cope with the obvious need for teacher education programmes to train the many unqualified teachers working in SWAPO's primary and secondary schools in Angola and Zambia. These teachers, for the most part, have no post-secondary school qualifications. Implementation of UNIN's plans was delayed for several years due to the impossibility of releasing the SWAPO teachers from their duties in order to participate in the teacher education programmes. To deal with this problem, UNIN has now developed a two-pronged approach: first, the mounting of a two-year residential up-grading programme for UNIN graduates in development and management studies who have not yet taken up teaching appointments; second, a series of two to three weeks seminars or workshops to be held during vacation periods for the practising SWAPO teachers.

The first intake into the residential programme took place in January, 1982 and numbered 22. A syllabus has been prepared, and a curriculum has been developed. The programme consists of six terms focusing on content courses, education courses, and teaching practice.

The vacation in-service programme was initiated in April, 1982, with a workshop on the teaching of English as a foreign language for 57 SWAPO teachers from Angola and Zambia. (English will be the official language of Namibia and medium of instruction). Four workshops are now held annually on themes considered important by SWAPO, UNIN and the teachers themselves.

Although the senate of UNIN approved the establishment of a teacher training and up-grading division to mount the teacher education programmes, external assistance is needed to supplement the budgetary and staffing provisions. Unesco, with financial assistance from the U.N. fund for Namibia, has been requested to provide the services of a specialist in curriculum development for teacher education and assistant experts in the teaching of English as a second language and in reading in order to strengthen further the division as the programmes expand and gain momentum. The project will also recruit a secretary and a driver for the project and provide necessary equipment and publications.

The project commenced operations in June, 1983, and is expected to continue at least until the end of 1985.

National character of the project:

Operational projects benefiting from Unesco assistance are national projects and it is up to the beneficiary country to assume responsibility for directing the project as well as ensuring its proper implementation.

It is understood that, within the outline of activities defined in the project, the national responsibility will include as well the use of equipment including furniture and vehicles.

As a result, the international specialists will carry out the mission entrusted to them under the guidance of the social and education division of the U.N. Institute for Namibia and the co-ordinator of the teacher training programme.

THE INDUSTRIAL COURT CAUSE No. 99 of 1983

Parties:

Kenya Union of Domestic, Hotels, Educational Institutions, Hospitals and Allied Workers

and

University College of Eastern Africa

Issue in dispute:

Termination of employment of Marko Biwott.

THE Kenya Union of Domestic, Hotels, Educational Institutions, Hospitals and Allied Workers shall hereinafter be referred to as the claimants and University College of Eastern Africa shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 4th September, 1984, and relied on their written and verbal submissions.

AWARD

3. The Minister for Labour referred this dispute to the Industrial Court in accordance with section 8 of the Trade Disputes Act, which dispute was received by the court on 25th October, 1983.

During the hearing the respondents raised a preliminary objection to the dispute being heard by the court on the ground that the grievant was not a member of the claimants at the material time. The claimants, however, strongly resisted this objection on the ground that the grievant had joined them along with 31 other employees of the respondents on 14th April, 1981, and that his membership No. was 4408.

The court having persued the Ministry of Labour's finding and recommendation referred the parties to the fact that the claimants had indicated their willingness to accept the report. The court inquired from the respondents if they were now prepared to accept the said report and they agreed. As a result by consent of the parties the court awarded that the respondents should pay KSh. 600 to Marko Biwott as compensation in addition to KSh. 1,130 already paid to him by them. This does not in any way signify the respondents recognizing the claimants as recognition is not part of this dispute.

THE Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the claimants and Kenya Breweries Ltd. shall hereinafter be referred to as respondents.

2. The parties were heard in Nairobi on 25th and 27th June and 6th July, 1984 and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 13th September, 1983, duly signed by the parties was received by the court on 6th December together with the statutory certificate signed by the Labour Commissioner.

The parties have already signed a collective agreement on 25th October, 1983, which is effective from 1st March of that year, on most of the terms and conditions of employment covering the respondents' employees and decided by agreement that the aforesaid issues in dispute should be referred to the Industrial Court for arbitration. The said collective agreement has been registered by the Industrial Court under RCA 267/83 and is to remain in force for a period of two years from 1st March, 1983. The intention of the parties is that the award of the court on the items in dispute would also be part of that collective agreement.

Out of the ten issues that were originally referred to the court the parties have agreed on new amendments on some of these items and a few other items have been withdrawn by the claimants. These are chauffeurs allowance, vehicle testing allowance, leave allowance, provident fund and transfers. This leaves only five items for arbitration before the court.

Overtime

The parties have elaborate clauses on hours of work and overtime and the claimants' demand is that clause 9 (b) (iii) should be deleted from the current agreement. This clause reads:

"Overtime rates are only payable after the 45 basic hours have been worked."

Their argument is that this subclause contradicts clause (i) and (ii) of the same clause. These clauses deal with the payment of overtime rates on weekdays and Saturdays, Sundays and rest days. The claimants submitted that overtime should be worked out on a daily basis as opposed to it being calculated on weekly basis.

The claimants' demand has to be viewed with the provisions on the hours of work which is clause 5. The relevant part of this clause is that the basic working hours shall be 45 per week and where possible and practicable the respondents will make atrangements for them to be covered between Monday and Friday. It is also stated that normal eight consecutive hours of work exclusive of mealtimes constitutes a working day from Mondays to Fridays and five consecutive hours of work on Saturdays.

The court has carefully studied the claimants' demand and finds that it would not be a practical proposition to delete subclause (iii) of clause 9 (b) in isolation because the parties have no dispute on clause 5 dealing with hours of work and this clause read together with clause 9 (b) (i) and (ii) clearly implies that the workers are required to work 45 hours per week before they are entitled to any overtime payment.

The court was told that the respondents have all along required their workers to work the number of hours as agreed, i.e. there is no short timing and this has been confirmed by the D.M.P.D. report which states that there is no short timing even during breakdowns. The court is satisfied that the respondents have all along granted the claimants the normal hours provided the workers present themselves to the place of work. The respondents, however, short time the workers when they are absent from their work without permission. This of course they do in order to enforce discipline.

The court has come to the conclusion that the claimants' demand is rather anticipatory and the court is not inclined to award any variation of the existing clause on overtime as requested by the claimants on the promise that sometime in future the respondents may short time their employees during daily working hours. If in future the respondents do so then the claimants can raise this item but for the time being it is rejected.

Night shift allowance

At present an employee who works on night shift between the hours of 7 p.m. and 5 a.m. received payment of 80 cents per hour for each hour actually worked. This allowance is not paid when overtime is paid. During the early stages of negotiations the claimants had demanded the extension of the hours from 6 p.m. to 6 a.m., the rate to be increased to KSh. 3 from 80 cents and in addition they had demanded a shift allowance of KSh. 300 p.m. During the hearing they had reduced their demand to KSh. 2 per hour for the work between 6 p.m. to 6 a.m. The respondents made no counter offers and submitted that there was no justification whatsoever for making any alteration to the existing clause. They pointed out that their employees enjoyed free transport, light refreshments during tea breaks in addition to attractive wages.

The court does not find the claimants' argument that the existing hours should be amended on the basis of when it is light and when it is dark to be tenable. The court accordingly rejects their demand for altering the hours in this item from 7 p.m. to 5 a.m. to 6 p.m. to 6 a.m.

The court is also not impressed by the respondents' argument that because the current rate of 80 cents per hour was fixed in 1980 it should not be changed because level of inconvenience suffered by workers on night shift has not in any way increased. The fact remains that there has been a big increase in the cost of living since then and the court finds that the current rate of 80 cents needs adjustment. The court accordingly awards that this rate should be increased to KSh. 1.20 per hour.

Safari allowance for drivers

This item affects about 300 drivers. At present these long distance drivers get a long distance allowance when they are required to drive a motor vehicle with over 10 ton capacity for a journey of over 112 km. radius. This allowance is paid at the rate of 90 cents per out km. and it is doubled on a journey starting on a Sunday or public holiday and one and a half times for a journey starting on a Saturday or a day before public holiday. Where, however, this allowance is paid no overtime can be claimed as eight hours a day are not applicable. In addition to this they are entitled to a subsistance allowance at a flat rate of KSh. 70 which is paid if the journey necessitates an overnight stop. For the journey of over 112 km. radius not calling for a night stop the allowance is KSh. 20.

The claimants demand that in addition to the aforesaid long distance allowance and subsistance allowance these drivers should also be entitled to safari allowance because a safari allowance is paid to a worker when he works away from his usual place of work. They strongly submitted that these drivers are workers also within the definition of a worker in clause dealing with safari allowance.

The respondents have vigorously opposed this demand on the ground that the parties had over the years agreed on special arrangements for these long distance drivers which gave them allowances on the basis of the distance covered and on top of it a fixed subsistance allowance. This had been clearly on the understanding that the drivers are not covered under the safari allowance clause. The respondents pointed out that this new demand by the claimants was contrary to the known practice in the transportation industry. They referred the court to the average take home salary of a driver in any given month which ranged between KSh. 6,500 and KSh. 8,000 and added that on any journey over 70 km, there are two qualified drivers in every vehicle.

The court finds the claimants' demand to be unreasonable as to grant it would mean giving these drivers double benefits. The court, however, feels that although the current arrangement should continue in force and these drivers should not get the safari allowance, the current rate of subsistance allowance for them should be increased to KSh. 110 and for the journey over 112 km. radius not calling for a night stop the allowance should be increased to KSh. 45.

Medical reimbursement scheme

At present the respondents operate three clinics for their plants at Nairobi, Kisumu and Mombasa. The Nairobi clinic is run by a sister in charge with the assistance of two clinical officers, two registered nurses and three clerical officers. In addition there is a company doctor from Nairobi Medical Centre who visits the clinic daily and takes two to three hours examining patients. The estimate cost of running the clinics is KSh. 150,000 per month and the respondents spend about 1.8 million shillings per year on drugs only.

There is a provision in the collective agreement which states that the employees are entitled to the option of taking advantage of the provision of the company medical reimbursement scheme It is also provided that the respondents will pay the expenses of medical treatment by an approved medical authority in respect of an employee's wife and four children as registered with the respondents and it is stated that an employee can claim medical reimbursement up to the maximum of KSh. 3,000 p.a. There are other provisions also which are not strictly relevant to the dispute.

The claimants are demanding as follows:

"(a) All employees shall be entitled to the option of joining the company medical reimbursement scheme.

- (b) The company will pay the expenses of medical treatment in respect of an employee's wife/husband and children, the medical expenses being those not refundable by NHIF.
- (c) The company shall settle immediately the whole hospital bill (i.e. 100 per cent with the medical institution concerned and claim from the same what is due under NHIF."

The claimants' main argument in support of their demand is that the medical scheme is discriminatory in favour of the management staff and there is no reason for it to be so.

The respondents have resisted this demand on the ground that the issue is not negotiable but without prejudice to this they argued that a blanket reimbursement of 100 per cent for in-patient treatment would cause a widespread abuse that would cost them a fortune. They added that they had 3,302 unionizable employees and if they had to pay reimbursement to all their employees and their families the expenses would be enormous as it would affect 16,510 persons. The court notes that recently in case of two employees who were both treated in Nairobi Hospital as in-patients the respondents paid KSh. 40,000 and KSh. 42,000 respectively but on the other hand the claimants were not really able to satisfy the court about any cases of hardship to support their demand of 100 per cent reimbursement.

The court has very carefully considered this item and finds that the ceiling of KSh. 3,000 should be raised to KSh. 5,000 and the court so awards. All the other provisions under this item to remain as they are.

Sliding scales

Currently the following sliding scales are in force which were agreed on 1st March, 1976:

The above sliding scales ceased to have any practical effect in 1982 and the claimants are now demanding that the length of scales in each grade should be extended to ten years and that the increment rate should be 5 per cent of the entry point of the grade. They stated that since 1982 many employees who have reached the peak of their scales are marking time and they should be rewarded. They bitterly attacked the respondents for their complete refusal to have any meaningful discussions on this issue.

The respondents feared that if the sliding scales were revised it would lead to enormous anomalies of overlapping. They stated that the existing scheme can be allowed to continue for all new joining employees but once they reach their ceiling they should accept that as an end. They dubbed the statement by the claimants as an intricate way for seeking further wage increases besides the general wage increases they are usually assured of.

The court feels that the respondents' attitude in refusing to negotiate on this item to be improper. This particular item appears in the collective agreement and as such the claimants are fully entitled for it to be revised. The court finds that the claimants are fully justified in asking the court to order the respondents to negotiate on this particular item and the court has decided to direct the respondents to enter serious negotiations with the claimants on this particular item. The merits or otherwise of the claimants' demand can be gone into during these negotiations. Having given this directive the court does not intend to make an award straightaway in favour of the claimants on this issue which they asked the court to do in their final submissions. The proper way to handle this issue is for the parties to negotiate it again seriously and failing a settlement they will be at liberty to bring this item before the court through the normal procedures.

Dismissal of Simba Mukono.

THE Kenya Engineering Workers' Union shall hereinafter be referred to as the claimants and Marshall-Fowler (Engineers) Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 5th September, 1984, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 25th May, 1983, duly signed by the parties was received by the court on 15th December together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The grievant worked for the respondents from sometime in November, 1969, until 7th June, 1982, when he was dismissed summarily for absenting himself from duty without any leave or lawful cause. His monthly salary at the time was KSh. 920.

The reason for his dismissal was that instead of reporting for duty on 2nd June he reported on 7th June after a long weekend which the workers and the management had mutually agreed upon. He was asked to give an explanation and he explained in writing that he had some school problems of his child and he overstayed the few days trying to get him fixed in a school. He explained that his child also became sick and he had to take him for medical treatment. The respondents did not accept the explanation and dismissed him.

The Ministry of Labour investigated the dispute and found that the respondents' decision was harsh and the dismissal was unjustified and recommended that he should be paid all his terminal benefits plus six months' salary as compensation. The claimants accepted the recommendation but the respondents did not.

During the hearing the claimants produced a letter which had been signed by an assistant teacher confirming that Mr. Mukono had been to Kiaganari Girls' Secondary School on 2nd and 3rd June. The respondents naturally objected to this letter saying that they had never seen it before and in any case it should have been signed by a headmaster. They referred the court to Mr. Mukono's previous record which they maintained showed him to be habitually absent. They pointed out that in 1982 on various dates he had been absent for a day or few hours and even half a day on which occasions he was not paid for such absences and he had not complained either. They, however, conceded that the warning letters which they allege were issued to him had not been copied to the shopsteward or the branch secretary as required under the warning procedure in the collective agreement. The respondents also referred the court to two incidents in 1980 when it is alleged that Mr. Mukono had taken a sum of KSh. 170 and KSh. 500 from two workers who had come for employment by pretending that he was close to the management and he could get them the jobs.

Dealing with this last allegation first, the court would like to point out that the respondents should have taken drastic action against Mr. Mukono in 1980 if what they alleged regarding his accepting money from job-seekers was true but they were content to let this matter be sorted out by the workers themselves outside their premises. In any case Mr. Mukono denied that he ever solicited this money. In these circumstances the court cannot hold this allegation against him.

The court would like to stress that the warning procedure as specified in the collective agreement should be scrupulously followed by the employers because when they are required to give copies of the warning letters to the shopstewards and the branch secretaries the purpose behind that is to make the trade union officials aware of the shortcomings of their member so that when the termination eventually takes place these officials are fully in the picture as to the misbehaviour of their member. The respondents failed to follow the proper procedure on warning letters in this dispute.

The few odd absences in 1982 for which he was not paid are really not serious at all. The court finds that there is some truth in Mr. Mukono's claim that he was trying to get his child fixed in a school and the court can take notice of the fact that such efforts do take a few days. In these circumstances and considering his thirteen years' service with the respondents the

court finds that the respondents' action was indeed harsh and the court accordingly finds that Mr. Mukono has suffered a wrongful dismissal and awards him six months' salary by way of compensation in addition to his terminal benefits in accordance with the parties' collective agreement.

The grievant worked for the respondents on permanent terms from 1st May, 1980, until 18th September, 1982, when he was dismissed. His monthly wage at the time was KSh. 679.

The reason for his dismissal was that he was absent without permission on 17th September, 1982. The claimants, however, strongly submitted that Mr. Ikiara had asked for leave to go for medical treatment at least on three occasions prior to 17th September and permission was refused for him to go and see a doctor. On 17th he decided to go for treatment himself. Mr. Ikiara stated on oath that he at that time was suffering from V.D. and although he first reported at Rhodes Avenue Clinic from there he was refered to S.T.C. All this resulted in his not being able to report for work on 17th September.

The respondents submitted that he was dismissed summarily because he was absent from duty from 17th September without any valid and proper reason. Moreover, he had five previous warnings starting from 23rd April, 1981, for absenteeism ending on 27th May, 1982, for misconduct towards the supervisor. The respondents' witness informed the court that although the grievant had not signed any of these warnings they had been handed over to the shopsteward for delivery to him.

The court has carefully considered this matter and finds the respondents' attitude towards Mr. Ikiara in denying him to go for medical treatment when he requested to be rather unreasonable. The court finds that it is quite possible that he wasted one complete day in first reporting at Rhodes Avenue Clinic and then going to the S.T.C. for treatment. But the fact still remains that his record with the respondents was extremely poor. The court finds itself in agreement with the findings and recommendation of the Ministry of Labour and the court accordingly awards as recommended by the ministry that the dismissal should be reduced to normal termination and he should be paid his terminal benefits in accordance with the parties' collective agreement.
