THE Kenya Game Hunting and Safari Workers' Union shall hereinafter be referred to as the claimants and E.A. Wildlife Safaris Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi, on 14th June, 1983, and 2nd April and 31st July, 1984, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 27th September, 1982, duly signed by the parties was received by the court on 10th December, 1982, together with the statutory certificate signed by the Labour Commissioner.

The respondents operated a tented camp in the Masai Mara Game Restrice known as Mara River Tented Camp and the persons involved in this dispute were employed by them on daily rates as season it employees. It appears that although the number of such employees is given as 26 the dispute really is in respect of 22.

In the parties' collective agreement there is a provision on the matter of redundancy and under clause 12 (d) it is stated that seasonal employees shall be entitled to severance pay calculated as being one and a half days' wages for each completed month of service.

With effect from April, 1980, a firm called Shamara Camps Ltd. took over the operation of Mara River Camp. A letter was issued to all employees signed by a director A. G. G. Doig stating that the respondents had ceased to operate from 31st March, 1980, and Shamara Camps Ltd. had acquired their assets and they would like the employees to continue employment with them, i.e. the new company, and a new letter of appointment was enclosed.

As a result of the various investigations carried out it is established that six employees who were re-employed by Shamara Camps Ltd. are still in their employment. They are:

John Mutungwe.

Joseph Makau.

John Mutisya. Nzuva Kavinda. Trajai ole Naoi. Ai Bata Ore Shipan.

Out of these six, J. Makau and J. Mutisya were paid what the court was told half of their entitlements amounting to KSh. 600 and KSh. 1,000, respectively. The following seven were also re-employed by Shamara Camps Ltd. but have resigned or were dismissed and have been replaced by new employees:

Mindi Kitela.

Joseph Makau. Musyoka Maitha.

Stephen Musembi.

Muivangela.

Muiya Ngemu.

Joseph Wambau.

The following ten were not re-employed by Shamara $C_{\rm A} mps$ Ltd.

Boniface Mukunzu. Katie Kianzo. Nzau Kitela. Mutina William. Ali Salimu. Kingoo Kaleli. Kasali Lau. Hassın Mukoła. Westor Munguti. Joseph Jimmy.

The claimants demand that the respondents should pay their employees redundancy benefits in accordance with the parties' collective agreement. They referred the court to clause 12 (d) which clearly covered benefits to which seasonal employees were entitled. This dispute was investigated by the Ministry of Labour whose finding confirmed that these employees were not casuals but were seasonal employees and were therefore entitled to be paid their severance pay benefit in addition to other terminal benefits. The respondents submitted that these employees and that Shamara Camps Ltd. had taken them on as permanent employees. They had also offered them to continue on seasonal basis as in the past. They maintained there was no question of them either being dismissed or terminated or being declared redundant.

The court has carefully considered the parties' submissions and the two reports by the D.M.P.D. and since respondents have indicated their agreement to pay redundancy benefits to those employees who were not re-employed by Shamara Camps Ltd. the court really is concerned with the question of whether or not the remaining 13 who were employed by Shamara Camps Ltd. seven of whom have since been dismissed or have resigned should be entitled to redundancy benefits. The court can find no evidence in respect of these 13 employees that Shamara Camps Ltd. took over their previous services rendered to the respondents. The evidence clearly shows that they were offered fresh employment, with effect from 1st April, 1980, and although the court appreciates the respondents' submission that those who are still in employment are better off now than they were as seasonal employees the fact still remains that the respondents have to give these employees their redundancy benefits for the services rendered to them as seasonal employees. The court can find no evidence that Shamara Camps Ltd. took over the liabilities of the respondents in respect of these claims.

After careful consideration of all the submissions the court awards that all the 22 employees should be paid their redundancy benefits in accordance with the parties' collective agreement clause 12 and the court directs that the parties should work out the dues of each one of these employees with the assistance of D. W. Gakuyu of the D.M.P.D.
