THE Commissioner of Lands invites applications for alienation of plots in the above-mentioned area described in the schedule hereto. A plan of the plots may be seen in the Public Map Office, Lands Building, city square, or obtained therefrom on payment of KSh. 10.

2. Applications may be sent so as to reach the Clerk to Council, County Council of South Nyanza, P.O. Box 20 Homa Bay, not later than 12 noon on Friday, 23rd November, 1984, and should not be sent direct to the Commissioner of Lands, Nairobi. Applications must be on the prescribed forms which are available from Lands Department or the office of the Clerk to County Council of South Nyanza.

3. Applicants must enclose with their applications a bank cheque, postal order, money order or cash for KSh. 1,000 made payable to the clerk to council, as deposit. Personal cheques will not be accepted.

The deposits will be dealt with as follows:

- (a) Credited to a successful applicant.
- (b) Refunded to an unsuccessful applicant.
- (c) Forfeited if a successful applicant fails to pay within thirty (30) days of the offer of a plot from the date of the letter of allotment, and the applicant shall have no further claim thereto.
- 4. Each application should be accompanied by a statement indicating:
  - (a) The amount of capital available for the purchase of the plot.
  - (b) The aim of capital available for the development of the plot. Attach a bank statement or letter from a bank or any other financial institution indicating the amount of development loan they are prepared to give you if you are allocated with a plot.

- (c) The manner in which it is proposed to raise the balance required for development, if any.
- (d) Full details of other plots owned by the applicant in this township.
- (e) Individual applicants must quote their identity card numbers and their nationalities.
- (f) In case of companies, names of directors must be included and a photostat copy of the company's registration certificate.

#### General Conditions

1. The grant will be prepared under the provision of the Trust Land Act and title will be issued under the Registration of Titles Act (Cap. 281).

2. The grant will be made in the name(s) of the allottee(s) as given in the letter of application and will be subject to special conditions set out below.

3. The term of the grant will be for ninety-nine (99) years from the first day of the month following the issue of letter of allotment.

#### Special Conditions

1. No buildings shall be erected on the land nor shall additions or external alterations be made to any buildings otherwise than in conformity with plans and specifications previously approved in writing by the local authority. The local authority shall not give approval unless it is satisfied that the proposals are such to develop the land adequately and satisfactorily.

2. The lessee shall within six calendar months of the actual registration of the lease submit in triplicate to the local authority plans, including block plans showing the positions of the buildings and system of drainage for the disposal of sewage surface and sullage water, drawing elevations and specifications as amended (if such be the case) by the local authority:

Provided that notwithstanding anything to the contrary contained or implied by the Trust Land Act, if default shall be made in the performance or observance of any of the requirements of this condition, it shall be lawful for the county council or any person authorized by the county council to re-enter into and upon the land or any part thereof in the name of the whole and thereupon the term created shall cease but without prejudice to any right of action or remedy of the county council in respect of any antecedent breach of any condition herein contained.

3. The lessee shall maintain in good substantial repair and condition all buildings at any time erected on the land.

4. Should the lessee give notice in writing to the county council that she/he/they/is/are unable to complete the buildings within the period aforesaid, the county council shall (at the lessee expenses) accept a surrender of the land comprised herein:

Provided further that if such notice as aforesaid shall be given twelve (12) months of the commencement of the term of the county council shall refund to the lessee fifty per cent of the stand premium paid in respect of the land or (2) at any subsequent time prior to the expiration of the said building period the county council shall refund to the lessee five per cent of the said stand premium. In the event of notice being given after the expiration of the said building period no refund shall be made.

5. The land and the buildings shall only be used for one private dwelling house (excluding a guest house).

6. The buildings shall not cover more than 50 or 75 per cent of the area of the land or lesser area as may be laid down by the local authority in its by-laws.

7. The land shall not be used for the purpose of any trade business which the local authority considers to be dangerous or offensive.

8. The lessee shall not subdivide the land without prior consent in writing of the county council and the Commissioner of Lands.

9. The lessee shall not sell, transfer, sublet, charge on part with the possession of the land or any part thereof or any buildings thereon except for such consent in writing of the county council. No application for such consent (except in respect of a loan required for building purposes) will be considered until special condition No. 2 has been performed.

10. The lessee shall pay to the local authority on demand such sum as the local authority may estimate to be the proportionate cost of constructing all roads and drains and sewers serving or adjoining the land and shall on completion of such

construction and ascertainment or the actual proportionate cost either pay (within seven (7) days of demand) or be refunded the amount by which the actual proportionate cost exceeds or falls short of the amount paid as aforesaid.

11. The lessee shall from time to time pay to the local authority on demand such proportion of the cost of maintaining all roads and drains serving or adjoining the land as the local authority may assess.

12. Should the local authority at any time require the said roads to be constructed to a higher standard the lessee/grantee shall pay to the local authority on demand such proportion of the cost of such construction and the local authority may assess.

13. The lessee shall pay such rates taxes, charges, duties, assessments on outgoings of whatever description as may be imposed charged or assessed by any government or local authority upon the land or the buildings erected thereon including any contribution or other sum paid by the local authority or the county council in lieu thereof.

14. The county council or such person or authority as may be appointed for the purpose shall have the right to enter upon the land, lay and have access to water mains, service pipes and drains, telephone or telegraph wires and electric mains of all descriptions whether overhead or underground and the lessee shall not erect any building in such a way as to cover or interfere with any existing alignments, main or service pipes or telephone or telegraph wires and electric mains.

15. The county council reserves the right to revise the annual ground rental payable hereunder after the expiration of the 33rd and 66th years of the term granted; such rental will be at the rate of 4 per cent of the unimproved freehold value of the land assessed by the county council.

## CAUSE No. 12 OF 1984

## Parties:

Railways and Harbours Union (Kenya)

and

Kenya Railways

## Issue in dispute:

Refusal and/or unreasonable delay by the Kenya Railways to pay the employees who ran away from Uganda for the days they were forced to avail leave without pay after their flight from Uganda.

THE Railways and Harbours Union (K) shall hereinafter be referred to as the claimants and Kenya Railways shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 11th and 12th July, 1984, and relied on their written and verbal submissions.

## AWARD

3. The Notification of Dispute Form "A" dated 7th April, 1983, duly signed by the parties was received by the court on 7th February, 1984, together with the statutory certificate signed by the Labour Commissioner.

The origin of this dispute dates back to the time of the East African Railways Corporation (E.A.R.C.) which used to operate under the now defunct East African Community. It should be noted that the respondents who are the Kenya Railways Corporation came into being in 1978 after the break-up of the community and were established as a result of an Act of Parliament.

It is a matter of history when the army took over the Government in Uganda in 1971 and towards the end of 1972 the security situation in that country deteriorated to such an extent that many leading personalities working in the community lost their lives with the result that about 100 employees of the E.A.R.C. left Uganda for Kenya. It appears that the claimants then made representations on their behalf to the Kenya region at the time and/or to the headquarters of the E.A.R.C. In due course after consultations 41 employees were persuaded to go back to Uganda. Sixty, however, refused to go. These employees were told to take their leave which was due and after that they were told that they would be on leave without pay. These employees were told that if they refused to return to Kampala in due course where their posts were vacant then it would be deemed that they no longer wished to continue serving the E.A.R.C. and would be believed to have resigned.

In August, 1973, the claimants involved the Minister for Labour, Kenya in this dispute. On 29th August, 1973, the then director-general of E.A.R.C. issued a circular stating that out of the hundred who fled Uganda about seven months ago a little over 30 had not returned to Uganda and were still on leave without pay. The board of directors had discussed the future of these employees and he decided that the E.A.R.C. should absorb them into existing vacancies outside Uganda and he asked his various departmental heads to make endeavours to absorb these employees into existing vacancies either in Kenya or Tanzania. The claimants then sought a definite assurance from the director-general before they would withdraw the trade dispute which they had reported to the Minister for Labour, Kenya, that all these employees affected would be treated as having been on leave with pay or on duty with pay from the date they arrived in Kenya from Uganda and then they continue to be treated as such until such time as they will physically be absorbed in Kenya or Tanzania. They asked all these employees to be paid their salaries in arrears. The director-general, however, rejected the attitude of treating them as though they had been on leave with pay after they had exhausted their earned leave and informed the claimants that the decision by the corporation to absorb them in Kenya or Tanzania was partially

a sign of goodwill. He also expressed the view that the security situation in Uganda had considerably improved and the reason why they refused to go back could not be fully understood.

The claimants then amended their notice of trade dispute with the Minister for Labour and it appears the matter then dragged on without any positive outcome. In the meantime the community and its corporations packed up and the respondents came into being in January, 1978. It should, however, be noted that during all this time these employees had either through the claimants or individually made representations to the E.A.R.C. asking for payment for the period when they were on leave without pay but without any success. The claimants then started making representations to the respondents after they were created.

The Ministry of Labour, Kenya, then set the conciliation machinery into motion and the claimants alleged that the respondents deliberately delayed conciliation proceedings on one pretext or the other like asking for unnecessary details concerning these employees. Eventually it was established that the following 22 persons had claims as shown in front of their names against the respondents.

The Ministry of Labour then withdraw the original conciliator and appointed another officer to look into the matter and from 1981 till early 1983 the matter was under conciliation but it seems that most of the time the conciliator was busy arranging meetings between the parties which for one reason or the other did not take off.

The claimants' principal submissions in this dispute are that it was the employers' duty both legal and moral to ensure that the employees worked in a secure and safe place. It was not in dispute that Uganda at that critical period was not a safe place to work in. And that since the respondents were the logical successors of the E.A.R.C. as far as Kenya was concerned they had to discharge all the obligations which rested on E.A.R.C. in respect of their employees. They referred to section 94 and 95 of the Kenya Railways Act and maintained that the respondents could not escape their liability.

The claimants referred to court to the treatment that the respondents had accorded to another employee by the name of Joseph W. Odipo who was a senior official and stated that this officer was exactly in the same position as the 22 other workers involved in this dispute and that he was given full pay for the days he was forced to avail leave without pay after his flight from Uganda. They added that the respondents should not be allowed to discriminate in treating their employees on the basis of a worker's position. They also informed the court that the services of these employees had continued without a break and that on their arrival in Kenya they had joined the claimants and had paid all the dues in cash and that the respondents had acknowledged that the claimants were fully entitled to represent them as they had negotiated on their behalf. The claimants' prayer to the court was for an order declaring that these employees remained lawfully the employees of the respondents after their flight from Uganda and were entitled to their jobs and that having fled from Uganda due to unavoidable grounds they were for all intents and purposes on duty immediately they arrived in Kenya hence they were entitled for payment during the period they were forced to avail leave without pay.

The respondents have very strongly resisted this demand on the ground that employees were not members of the claimants at the material time as they were members of the railway union

in Uganda as there were three railway employees unions at that time—in Kenya, Uganda and Tanzania.

The respondents gave details of the set up of the E.A.R.C. at that time and pointed out that no provision had been made for the salaries of these employees who had suddenly run away from Uganda in the approved estimates in the Kenya region and therefore there was no money with which to pay their salaries if they were taken immediately they returned. Moreover there were no posts in Kenya for them to occupy. It was in the light of this that a decision was taken to first let them exhaust their earned leave and then to treat them as being on leave without pay. They stressed that every employee was aware right from the beginning that he will not be paid for any time after his accrued leave was exhausted and that it was an act of dishonesty on the part of these employees to now turn round and demand payment for the period they did not work for the railways.

The respondents submitted that their jurisdiction extended to only Kenya and not beyond and therefore there was no question of the respondents providing security for the employees. The respondents' main submission, however, is that at the time these employees fled Uganda, E.A.R.C. was still in existence and that the respondents had not even been created at that time. The then board of directors of E.A.R.C. had decided that these employees should be absorbed in existing vacancies in Kenya and Tanzania. This showed it was an East African responsibility and not a Kenya Railways Corporation responsibility. If some expenditure was to arise as a result of paying these employees during the period they were on leave without pay then the expenditure involved should have been borne by the Uganda region.

As far as the case of Mr. Olipo was concerned they stated that the facts of his case were different from those of the 22 employees and that in any case even if Mr. Olipo's decision was at variance with the official position which had been held by the then director-general then the claimants should not be allowed to capitalize on that mistake as two wrongs don't make a right.

Finally the respondents pleaded that these employees had in actual fact deserted their employment and should consider themselves very lucky that the Kenya region subsequently absorbed them and that any expenditure from the public funds would not be justifiable as demanded as they did not work for the respondents. Nor is it proper for anyone to be paid for services not rendered.

The court notes that the principal facts of this dispute are more or less agreed by both the parties. The court now has to decide if the respondents are liable to assume and discharge the liabilities of the now defunct E.A.R.C. It is obvious that these employees at the material time were employees of the E.A.R.C. but working in the Uganda region where their salaries and other expenses had been budgeted. About 50 of them returned to Uganda and the remaining found jobs in Tanzania and Kenya. The court has carefully considered this matter and finds that the E.A.R.C. had quite clearly told them that they should first exhaust their earned leave after which they would be on unpaid leave while posts were found for them in Kenya. It was up to these employees then either to accept the terms or to return to Uganda. They accepted the terms and stayed in Kenya although they were not at that time under the responsibility of the Kenya region. In these circumstances the court cannot find that sections 94 and 95 of the Kenya Railways Corporation Act apply to these employees because at that time they were under the responsibility of the Uganda region and not the Kenya region.

The court must therefore reject the claimants' demand in this dispute and while doing so the court would like to say that the Kenya region indeed acted very humanly in respect of them and gave them jobs here and did not force them to go back to Uganda, where they rightly belonged as far as their employment was concerned. It may well be that the claimants might consider raising their claims through some other forum but this court cannot help them.

Dismissal of Joyce Kirubi.

THE Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the claimants and Kenya Planters Co-operative Union Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 16th August, 1984, and 21st September, 1984, and in addition to relying on their written and verbal submissions called the following witnesses:

*Claimants.*—Joyce Kirubi.

*Respondents:*

Kibai Mboru.

Jeremiah K. Limbere.

## AWARD

3. The Notification of Dispute Form "A" dated 30th September, 1983, duly signed by the parties was received by the court on 20th February, 1984, together with statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The grievant, Joyce Kirubi, worked for the respondents as a branch cashier at their Dandora depot with effect from 25th September, 1981. She was suspended from work pending investigations on 27th September, 1982, and was summarily dismissed on 30th September, 1982. The letter of her dismissal stated "reasons you have advanced to defend yourself against the theft of KSh. 6,764.95 at Dandora on the night of 24th September, 1982, are completely unacceptable".

The dispute was investigated by the Ministry of Labour whose findings was that the dismissal was justified. The claimants rejected this finding.

The circumstances of this dispute are rather unusual because it is alleged that Mrs. Kirubi either stole this money as is alleged in the letter of dismissal or that she was grossly negligent which resulted in the respondents losing KSh. 6,764.95. On the day in question Mrs. Kirubi had a balance of KSh. 6,764.95 from KSh. 43,000 which she had collected on 22nd September to pay casual labourers. The procedure was that any balance had to be locked by her in the safe in the manager's office. The key to the manager's office was kept by one other employee, Mr. Kibai, who would open the office and let Mrs. Kirubi keep the money in the safe. The court notes with great surprise that this person who was entrusted with the key to the manager's office was a casual employee! On 24th September while Mrs. Kirubi had the balance she worked for sometime at the clocking section. While there she told Mr. Kibai to clock out and the other *askari*, Mr. Limbere, whose job was to maintain order among casuals while they were being paid, was also told to go as his work had finished. Mr. Kibai after clocking out went home with the key to the manager's office so Mrs. Kirubi was left with the aforesaid amount which she had to lock in the drawer. In the morning another employee came and told her at her house that the office had been broken into. She went to the office, opened it and found that KSh. 5,667.30 had been stolen. The matter had been reported to the police and they were already there.

The court has now to determine if Mrs. Kirubi was an accomplice in this theft or she was grossly negligent in any manner. She told the court that along with the respondents' money she had also kept her own personal money amounting to KSh. 3,000 in the drawer as she did not want to take it home where the security was very poor at the time. She had taken this money from her husband in the morning. Moreover over KSh. 1,000 in coins were not stolen. Further the matter had been reported to the police who had made all the inquiries and preferred no charge against anyone. It was also found that there were guards on duty all the time on shift duty. Moreover the window of the office which is alleged to have been broken through which entrance was gained was inside the store where entrance could only be gained through the main door.

The court finds that the respondents' interference that Mrs. Kirubi told Mr. Kibai to go home after clocking out is rather questionable. Mrs. Kirubi said that when she told him to clock out she expected him to wait at the manager's office to open

the door for her to enable her to keep the money in the safe. This explanation is reasonable. So if Mr. Kibai misunderstood her instructions then it is not her fault. And she had no alternative but to keep the money in the drawer to which she allegedly added her own money. She had mentioned about her own money in the police statement as well.

In these aforesaid circumstances the court has to determine the dispute. The court must emphasize that it is not a criminal court and the court therefore cannot be expected to hear cases of theft where the police have not filed criminal case against the person. The court has only to decide if Mrs. Kirubi was negligent. In her letter of dismissal the allegation against her is that of theft but during the hearing this allegation seems to have been changed to gross negligence.

The court has carefully considered this aspect of the dispute and finds that the breaking of the office that night in all the circumstances surrounding thereto does not appear to have been the work of Mrs. Kirubi. The court finds that in the circumstances since the police did not prefer a case of theft against her that she was not negligent either. The court therefore finds that she has suffered a wrongful dismissal.

Mrs. Kirubi, however, had served the respondents for only one year and the court finds that the best remedy in this dispute would be to give her two months' salary as compensation for the wrongful dismissal that she has suffered and the court so awards.

THE Amalgamated Union of Kenya Workers shall hereinafter be referred to as the claimants and Kericho Farm and Machinery (K) Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 7th September, 1984, and relied on their written and verbal submissions.

## AWARD

3. The grievant, S. Otieno, worked for the respondents from 1st June, 1982, until 17th January, 1983, when his services were terminated due to gross misconduct. He was employed as a motor vehicle electrician. The reason for his dismissal was that on 15th January, 1983, he had refused to carry out lawful instructions issued to him by the workshop foreman to repair a customer's generator and he turned down the instructions despite the fact that it was still official working hours.

The claimants took up the matter on his behalf and reported a trade dispute to the Minister for Labour whose finding was that Mr. Otieno had suffered a wrongful dismissal and recommended that it should be reduced to normal termination and he should be paid two months' salary by way of compensation for the wrongful loss of employment. The respondents rejected the recommendation.

During the hearing of the dispute it was not disputed that the instructions that Mr. Otieno is alleged to have refused to obey were given to him at 11.50 a.m., i.e. only ten minutes before the workshop closed for business by 12 p.m. on that Saturday. The court is satisfied from the submissions that for all practical purposes the work had ceased as mechanics were expected to change into their ordinary clothes at that time. The court further finds that there is no evidence that Mr. Otieno was told quite clearly that he would be paid overtime and further there is no evidence that a job card was prepared for this particular job.

The court has carefully considered the respondents' submission that it should be understood by the workers that if they worked beyond normal hours they would be paid overtime and therefore even if they are told a few minutes before closing time that they are to work on a particular job then they should not refuse to obey the order of the management.

The court however finds that this matter is not so simple as the respondents would like to suggest. The management should at all times give out instructions to their employees properly like in this case the proper job card should have been prepared and there would have been no harm at all if the worker had been told that he would also be paid overtime for any time worked after 12 p.m.

The court has carefully considered the parties' submissions and finds that the Ministry of Labour's recommendation of reducing Mr. Otieno's dismissal to normal termination and payment of two months' salary by way of compensation is reasonable under the circumstances and the court so awards.

The respondents put up a counter claim against Mr. Otieno in respect of seven months' rent amounting to KSh. 1,050 which they alleged was the rent for the house which Mr. Otieno had occupied after his dismissal at the rate of KSh. 150 p.m.

The court rejects the respondents' demand that this amount should be deducted from the dues of Mr. Otieno under the award as the court has no details of this claim and in any case this claim is one which should be pursued in the ordinary civil court. The Industrial Court should not be used by parties for setting such civil matters.

#### AWARD

3. The grievant, Wilson Kyule, worked for the respondents from 26th June, 1979, until 4th May, 1983, when he was dismissed summarily. At the time of his dismissal he was acting as the foreman and the allegation against him was that he was found asleep on duty and incapable of performing his work properly due to influence of alcohol on 1st April, 1983.

The claimants took up the matter on his behalf and reported a trade dispute to the Minister for Labour and the ministry's finding was that he was found asleep and drunk on 1st April, 1983, and that he was not sick as he claimed but was found to be incapable of carrying out guard duties. He had to be sent home since the area had to be guarded. The ministry recommended that the dismissal should be reduced to normal termination and he should be paid his terminal benefits in accordance with parties' collective agreement. The claimants rejected the recommendation.

During the hearing the court heard the evidence of the grievant and the three witnesses called by the respondents and the court is satisfied that on 1st April, 1983, when Mr. Kyule came on duty and took over the charge he came to ground floor and went round to a place near the "Feather Your Nest" shop, removed his helmet and promptly went to sleep on the floor. The supervisor, Herman Kaliodo saw him do this and then called another worker Mr. Karanja to come and witness the scene. When Mr. Karanja came Mr. Kaliodo kicked Mr. Kyule lightly to wake him up. When he was kicked, Mr. Kyule got up but did not even see the two people near him, walked around to another shop nearby sat near the column and went to sleep again. The supervisor followed him and he was asked if he was drunk and he admitted to them that he had taken alcohol. The court is satisfied that Mr. Kyule at that stage was completely helpless and could not do anything and was therefore sent home.

The court cannot find any evidence to show that Mr. Kyule was suffering from malaria and had asked for some tablets. The simple truth of the matter is that he had come on duty while under the influence of drink and especially at a time when he was acting as the foreman. The court can find no mitigating circumstances in this dispute in favour of Mr. Kyule and the court must reject the demand made by the claimants on his behalf.

The court would like to sound a warning that workers who report on duty under the influence of drink and are not able to perform or discharge their duties properly should not expect any sympathy from the court. The court finds that Mr. Kyule deserved summary dismissal as he had committed a gross misconduct.
