Kenya Union of Commercial Food and Allied Workers and

Kenya Breweries Ltd.

Issue of dispute:

Parties:

Dismissal of Joseph arap Too.

THE Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the claimants and the Kenya Breweries Ltd., shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 14th January, 1985, and relied on their written and verbal submissions. The claimants also called Joseph arap Too to give evidence during the hearing.

AWARD

3. The Notification of Dispute Form "A" dated 5th January, 1983, duly signed by the parties was received by the court on 5th April, 1983, together with the satutory certificates signed by the Minister for Labour and the Labour Commissioner.

The complaint arose as a result of the respondents' decision to dismiss Joseph arap Too, a truck driver on 21st August, 1981, for failure to heed the orders of the police to stop when he was signalled to do so on three occasions both on Naivasha-Nairobi Road and Nairobi Forest Road, on 30th July, 1981.

It is alleged that Joseph arap Too had hit a vehicle whose registration No. is EE 46 along Naivasha-Nairobi Road and had refused to co-operate with the occupants of that vehicle when

they caught up with him at Kinoo Trading Centre, on 30th July, 1981. The matter was reported to the police at the police station, Kikuyu, who immediately signalled Nairobi police patrol to have him apprehended as he had failed to stop after an accident he had been involved in on the way and for not obeying police orders subsequently to stop.

The claimant in his verbal evidence told the court that he could not stop when ordered to do so as he was afraid he could be beaten and therefore chose to drive to his base at Ruaraka. He also told the court that he was not aware of any accident that they alleged he had been involved in on that occasion.

The claimants submitted that the managements' decision to sack Joseph arap Too was arbitrary as there was no evidence that the basis of dismissal existed. They considered Joseph arap Too's dismissal as unlawful which did not call for such serious disciplinary action. They therefore requested the court to have Joseph arap Too reinstated with full benefits as it is in evidence that the complainant was charged with an offence of which he was subsequently acquitted. They concluded by saying that Joseph had a past good record during his period of employment with the respondents and he deserved to be treated leniently.

The respondents considered the complainant's behaviour of failing to stop after having been involved in an accident and refusing to stop on three occasions when he was ordered by the police to do so while using the respondents' vehicle, as a very serious misconduct in the course of his duties. They told the court that such behaviour not only injured their reputation but made them vulnerable to possible suit by the aggrieved users of vehicle No. EE 46. They went on to say that they are committed to promoting safety on all Kenyan roads through the observance of strick discipline by their drivers and they could not in any way condone the complainant's intentional defiance of both traffic laws and standing instructions of employment.

The court notes that the dispute was investigated by the respondents through their accidents committee and that Joseph arap Too had made a full statement.

The court further notes that the accused pleaded guilty to the two counts but was discharged by the resident magistrate under section 35 (1) of the Penal Code.

The court finds the decision to dismiss Joseph arap Too by the respondents under the circumstances to have been harsh. He only deserved normal termination. His (Joseph arap Too's) past record during his employment with the respondents was clean and it should have been taken into consideration. The court accordingly awards that the respondents should pay Joseph arap Too three (3) months' salary in lieu of notice and all his other terminal benefits due to him under the parties collective agreement.

THE INDUSTRIAL COURT

CAUSE NO. 123 OF 1983

Parties: Kenya Union of Domestic Hotels, Educational Institutions Hospitals and Allied Workers

and

Kangaru School

Wrongful suspension of Fredrick Kiura and John Njaga.

THE Kenya Union of Domestic, Hotels, Educational Institutions, Hospitals and Allied Workers shall hereinafter be referred to as the claimants and Kangaru School shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 6th December, 1984, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 28th September, 1983, duly signed by the parties was received by the court on 10th December, 1983, together with the statutory certificates signed by the Labour Commissioner and the Minister for Labour.

The respondents are a government educational institution established under the Education Act. They have a recognition and a collective agreement with the claimants regulating terms and condition or employment of the respondents' unionizable staff.

Fredrick Kiura was employed by the respondents as a watchman on 1st January, 1970, and was terminated on 1st August, 1980. His monthly salary was KSh. 593.

Johnson Nyaga was employed in a similar position starting from 16th October, 1972, and was terminated on 1st August, 1980, when his salary was KSh. 578 per month.

The event that led to their dismissal was that on 28th July, 1930, a battery was stolen from a school vehicle registration KVE 424 while parked in the school compound guarded by the two workers. The respondents' headmaster reported the theft to the Embu police, who arrested the two watchmen as suspects. They were questioned at length and were subsequently released for lack of sufficient evidence.

In the meantime the respondents suspended the watchmen from duty and referred their case to the executive committee of the school board of governors for consideration. This action was vigorously opposed by the claimants arguing that they have no suspension clause in their collective agreement, instead they have an interdiction clause which allows the two watchmen to be on half pay until the dispute is resolved. The respondents however, after suspending them placed the matter before the executive committee of the board held on 31st October, 1980, and the com-mittee resolved to terminate the services of the grievants with effect from 1st August, 1980. This decision was upheld by the full board meeting held on 24th November, 1980, but, sought further advice from the labour officer over their action.

On 12th June, 1981, this matter was again brought before the full board of governors for discussion and the board agreed to terminate the services of the watchmen as a measure to tighten the school's security. The board agreed to pay them three months' salary in lieu of notice and rejected the claimants' demand for their reinstatement.

The claimants have strongly argued that the respondents have failed to follow the laid down procedure which requires their members to be interdicted with half pay pending the grievants' appearance before a full board. The court finds that no financial loss was suffered by the watchmen as a result of being suspended.

The court notes that there was a joint conciliation meeting between the parties chaired by the Labour Officer. Embu, when it was agreed that an additional three months' salary be paid to each watchman. The respondents at this meeting conceded to the claimants' further demand for leave and house allowance to be paid.

The court finds that the grievants were not blameless during their services with the respondents. In fact there was an incident of theft from the school canteen in 1979 and the school lost a lot of property. Again the following year another theft took place which led to the two watchmen's services being terminated. Under these circumstances the respondents had every reason to lose confidence in them and were in fact justified in taking appropriate steps to tighten the security in the school, hence their termination of service.

The court having weighed the submissions from both parties finds that Messrs. Kiura and Nyaga were negligent in their duty as watchmen and had in this instance, made the respon-dent to suffer a loss of a car battery which they were, among others, expected to guard.

The court therefore rejects the claimants' demand made on their behalf for reinstatement but awards them three months' pay in lieu of notice plus three months' ex gratia pay as offered by the respondents. In addition they should be paid their leave and house allowance.

The court was told that the respondents had deposited a certain amount with the Labour Officer, Embu, and the court directs that it should be released to the grievants towards payment of the award in this dispute. The respondents should also pay them the balance, if any.

IMPORTANT NOTICE TO SUBSCRIBERS TO THE KENYA GAZETTE

THE following notes are for the guidance of persons submitting "copy" for inclusion in the Kenya Gazette, Supplements. etc.:

- (1) The Kenya Gazette contains notices of a general nature which do not affect legislation. They are therefore submitted to the Government Printer directly.
- (2) Legislative Supplement contains Rules and Regulations which are issued by the Central Government. Because of this they must be submitted to the Government Printer through the office of the Attorney-General.
- (3) Bill Supplement contains Bills which are for introduction in the National Assembly.
- (4) Act Supplement contains Acts passed by the National Assembly.

All "copy" submitted for publication should be prepared on one side of an A4 sheet no matter how small the notice or Act, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible and contain a minimum of alterations.

- Particular attention should be paid to the following points: (i) Signatures must be clarified by means of rubber-stamping
- or typing the name of the signer in capital letters. (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to
- notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D-Kenya Gazette

"D.14.(1) Communications for the Kenya Gazette should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.

(2) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer when ready.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
