Further take notice that penalties for the breach of the by-laws (Licensing of Occupations By-laws, 1983) will be imposed after 31st March, 1984, in accordance with section 201, sub-section 2 (a) of the Local Government Act.

A local authority may, by law, prescribe all or any of the following penalties which may be imposed for breach of any by-law made by it under the Act, i.e.:

A fine not exceeding two thousand shillings in respect of a first offence and not exceeding three thousand shillings in respect of a second or subsequent offence, or imprisonment for a period not exceeding six months in respect of a first offence and not exceeding nine months in respect of a second or subsequent offence, or both such fines and such periods of imprisonment.

Issue in dispute:

Recognition.

THE Kenya Bakers and Confectioners Workers Union shall hereinafter be referred to as the claimants and J. Lyons and Company (K) Ltd. shall hereinafter be referred to as the respondents and Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the interested party.

2. The parties were heard in Nairobi on 11th September, 1984, 29th November, 1984 and 27th May, 1985 and relied on their written and verbal submissions. The dispute was mentioned on 30th July, 1984, 14th August, 1984 and on 8th February, 1985 and at the request of the parties the hearing was fixed for 27th May, 1985.

AWARD

3. The Notification of Dispute Form "A" dated 30th January, 1984, duly signed by the parties was received by the court on 22nd May, 1984, together with the statutory certificate signed by the Labour Commissioner.

The dispute between the parties stems from the claimants demand to recognition by the respondents in respect of their unionizable employees in their bakery.

The respondents have strongly resisted this demand on the ground that they have recognized the interested party since last many years and have concluded several collective agreements with the same trade unions as the respondents' industry falls within the ambit of the membership clause of the interested party's constitution.

The court gave every facility to the interested party to make written and verbal submissions on this issue along with the parties to the dispute. In addition the court caused detailed investigations to be carried out by the Division of Manpower Planning and Development of the Ministry of Labour who prepared two reports both of which were made available to all the parties in order to enable them to make submissions thereon.

During the pre-Industrial Court procedures an official investigation was carried out by the Ministry of Labour and the ministry's finding and recommendation were in favour of the claimants in that the respondents should recognize the claimants as far as their bakery employees are concerned and the interested party should continue to be recognized and represent the employees in the ice-cream and grocery sections. The respondents strongly rejected the ministry's recommendation.

To begin with the court would like to examine the respective clauses in the claimants and the interested party's constitutions.

The relevant clause in the claimants constitution reads as follows:

3 (a): "Membership of the union shall be open to all employees engaged in pastries, biscuits, cakes, confectionery making and sweets making factories."

The interested party's membership clause in their latest constitution provides as follows:

Rule No. 3 (Membership)—

(a) Membership of the union shall be open to all employees engaged in the following industrial groups provided such employees is above the apparent age of sixteen years:

(i) *Distributive and Commercial Group*—which shall embrace all employees engaged in warehouses, and merchandize, flour, coffee and spice mills, food processing, banks, insurances, offices, cinemas, showgrounds, shopworkers, wholesale and retails, watchmen organizations, distributive dairy workers co-operative societies and statutory boards, financial institutions, slaughter houses.

(ii) *Laundry Cleaners and Dyers Group*—which shall embrace all employees engaged in dyers, dry cleaners and laundry industries.

(iii) *Tobacco Trade Group*—which shall embrace all employees engaged in tobacco industries.

(iv) *Bottling and Brewing Group*—which shall embrace all employees in bottling and brewing industries.

A careful study will show that in the interested party's constitution the only words within which they bring the bakery activity are, food processing in 3 (a) (i) above.

In February, 1981, the Senior Deputy Registrar of Trade Unions confirmed in writing that the registered constitutions of the two unions (the claimants and the interested party) do not overlap in any way and are certainly distinct and differing in contents.

The court has no doubt that bakery employees should be represented by the claimants. The matter, however, does not end there and the dispute is not so simple. What complicates the issue is the respondents and the interested party's very strong submissions to the effect that the pre-dominant nature of their business (as bakery is only a section of their industry) falls within the membership clause of the interested party's constitution and that in accordance with the system of industrial unions in Kenya their industry belongs to the interested party.

The court will now examine this aspect of the dispute.

Any person running a bakery is required to have a bakery licence. The respondents to-date do not appear to have got a bakery licence although previously when they were operating from different premises they had a licence from the Nairobi City Council for their bakery section. The court has no doubt that the respondents will get a bakery licence for their Ruaraka premises as soon as they get an occupation certificate as the M.O.H. did not recommend the premises for production and manufacture of food stuffs and ice-cream—so it is really a matter of time before they get the bakery licence failing which they will not be able to operate their bakery.

The bakery section has 47 employees—one of them is a production manager who reports to the operations manager. There are six supervisors while the rest are floor level employees. Out of the 40 unionizable employees 34 are claimants' members and only six are members of the interested party.

The breakdown of employees in other sections are:

- (i) Ice-cream/grocery section—39 employees—24 unionizable. They are all members of the interested party.
- (ii) Engineering section—eight employees—four unionizable all members of the interested party.
- (iii) Commercial department—39 employees—20 unionizable and five claimants' members. Eleven are interested party's members.
- (iv) Sales department—12 employees—six unionizable. They do not belong to any trade union.
- (v) Mombasa Branch—12 employees—nine unionizable and seven members of the interested party.

The D.M.P.D. report shows that most of the workers in the bakery started working as casuals and that there are still some casual workers who have worked there for more than one year continuously. From about 25 employees who were interviewed by the D.M.P.D. investigator it became apparent that they had never worked in any section other than the bakery. One supervisor in the bakery section used to work in grocery and one female worker had asked for transfer on doctors advice from bakery to a cooler place except for these two there have been no transfers.

The respondents have three major departments—operations, commercial and sales. The operations department has three sections—bakery, grocery and ice-cream.

The trend of sales of the respondents products are as follows:

The court has carefully scrutinized all the aforesaid facts which came to light during the hearing and finds that baking sections is earning a revenue which is only KSh. 33,000 less than ice-cream the hitherto main product of the respondents.

The court has no doubt that the claimants have the majority of workers in their membership from the bakery section.

The court has given anxious thought to this dispute and after carefully studying the two constitutions of the claimants and the interested party the court is almost of the view that the respondents enterprise really falls within the claimants membership clause but since the claimants are not seeking recognition in respect of other sections apart from the bakery the court does not intend to deprive the interested party to continue representing workers in other sections except the bakery. The court is also not creating a precedent against the interested party as every dispute has to be considered on its own merits.

In the aforesaid circumstances and considering that the respondents have a completely different section almost an establishment in which they undertake their bakery activities the court is of the view that it can safely be considered that the respondents have diversified their business considerably and their continued recognition of the interested party regarding their bakery employees is inconsistent with the actual state of affairs. The respondents are the second largest bakery in Kenya. The court must emphasize that it has given proper weight and examination to the industrial trade unions system in Kenya and the respondents plea that their industry falls within the membership clause of the interested party. The court however does not agree with the respondents plea and finds itself in complete agreement with the recommendation made by the Ministry of Labour that the respondents should recognize the claimants as far as their bakery employees are concerned and the interested party should continue to enjoy recognition as far as employees in the ice-cream and grocery sections are concerned.

The court awards that the respondents should recognize the claimants as far as their bakery employees only are concerned on the expiry of the current collective agreement between the interested party and the respondents.

Issues in dispute:

- Annual leave days.
- Leave travelling allowance.
- Salary increments.

The Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the claimants and Coffee Board of Kenya shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi for the first time on 30th May and 15th August, 14th October, 14th November, 1983 and 1st February and 16th May, 1984, and the court thereafter made a preliminary ruling on 8th July, 1984, directing the parties to embark on renegotiations within the salary scales and terms of employment as approved by the Parastatal Advisory Committee (P.A.C.). The parties failed to resolve the dispute and thereafter, the parties were heard on 30th January, and 11th June, 1985, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 2nd June, 1982, duly signed by the parties was received by the court on 10th December, 1982, together with the statutory certificate signed by the Labour Commissioner.

This dispute affects some 480 unionizable employees who work at the respondents premises at Kahawa House and Coffee Plaza both in Nairobi. The respondents are a parastatal body class "E" established in 1963 under the Coffee Act (Cap. 333).

The parties to this dispute signed their recognition agreement in April, 1965 and thereafter arose during the parties negotiations to amend their last agreement which was effective from 1st May, 1974 to 30th June, 1976. The parties agreed on most of the issues except the ones now before the court.

Annual leave days

During the very vigorous submissions made by the claimants, the court was told that the respondents have dismantled the parties collective agreement "clause 5" by unilaterally reducing or increasing the annual leave days. The claimants felt that the respondents action in changing the annual leave days was arbitrary with complete disregard of the claimants role and violation of the signed agreement which they (the claimants)

viewed as a grave offence. Hence, the claimants would like the court to reintroduce annual leave days to the 1974 levels as appended hereinbelow:

Job group	Leave days

The respondents in their reply strongly argued that they have dealt with the claimants for a period of over 18 years and there has never been a time when the claimants representations were ignored. The claimants were completely aware of the adjustments in the annual leave days. The respondents have confirmed that changes in the leave days have been strictly in accordance with the recommendations of the Waruhiu Commission Report of 1979/80 on the civil service terms and conditions of employment. They have requested the court to sustain their offer as follows:

Grades	Annual leave days
1 and 2	24 working days
3, 4 and 5	27 working days

The court has examined the arguments put forward by both parties and is satisfied that the respondents in adjusting the annual leave days did not violate the parties collective agreement clause five. The respondents were only implementing the recommendations of the Waruhiu Committee Report as approved by the Parastatal Advisory Committee (P.A.C.). The adjustments in leave days were in line with government policy of harmonizing terms and conditions of employment for the parastatals with those obtaining in the civil service. The court has noted that the changes in the annual leave days did not only affect the claimants members, but the management personnel also.

The court has carefully considered this issue and is satisfied that the employees in job group 1 numbering 216, out of 480 were given an additional 3 working days to make their annual leave entitlement 24 working days. The court has also noted that the government sometimes back did reduce the working week to five (5) days and the claimants' members were among the beneficiaries.

The court feels that the current annual leave days of 24 and 27 working days, respectively, are adequate for the employees and would not be in the best interest of the national economy to increase annual leave days any further and has decided to reject the claimants demand.

Leave travelling allowance

The claimants would like the previous leave allowance reintroduced and revised upwards in two consecutive segments to cover the period between 1st July, 1980, up to 30th June, 1984, a period of four (4) years. The leave allowance the claimants have sought revision as of 31st December, 1984, were as follows:

The claimants would like the leave allowance revised and the amount accruing be paid in arrears. They submitted that failure to give workers leave allowance would mean reducing the labour costs to the detriment of the employees welfare.

In their reply the respondents submitted that leave allowance was also revised by the Waruhiu Commission and the rates offered to the employees were the rates approved by the Parastatal Advisory Committee (P.A.C.). The respondents argued that, like any other parastatal body they are governed by the guidelines and directives issued from time to time by the Government. In accordance with parastatals guidelines, the respondents have no authority or ability to go beyond the limits set by the Parastatals Advisory Committee (P.A.C.)

The court notes that the respondents employees had continued to enjoy leave allowances as agreed by the parties in their various agreement up to 31st December, 1984. The court is also satisfied that the automatic payment of leave allowance before one proceeded on annual leave for employees in the civil service and parastatals was abolished by the government with effect from 31st December, 1984. New travelling arrangements were introduced with effect from 1st January, 1985, whereby the employees are granted reimbursement of the costs incurred on travelling while on leave. The court has learned that reimbursement of the costs incurred travelling on leave is more advantageous to the workers than the payment of uniform rates of leave allowance.

In view of the above the court reaffirms the government policy that with effect from 1st January, 1985, the employees will be entitled to reimbursement of the expenses incurred while travelling to and from their leave destinations and this demand is accordingly rejected.

Salary increment

The claimants on this issue submitted that the workers have not been adequately compensated for the rise in the cost of living as indicated by the cost of living indices to cater for the rising cost of living. They vigorously argued that the 1980 basic salary of KSh. 550 has not been revised upwards to boost workers purchasing power.

They further explained to the court that the respondents are in a position to increase the salaries for the workers, but have deliberately refused due to sheer greed and desire to maximize profits. They emphasized that the respondents balance sheets for the years 1983 and 1984 had reflected huge profits and out of the profits the workers salaries should be increased.

In their response the respondents vehemently disagreed with the claimants that the last time the employees salaries were increased was 1977. They submitted that although the parties had not revised their last collective agreement since 1974 the workers salaries were occasionally revised from 1st July, 1976, up to 1st October, 1980. They felt that the 1980 salaries review was meant to compensate workers for the period between 1977 to any other time that the government would authorize a further salaries review.

They further argued that their employees have been sufficiently compensated in view of the fact that they are entitled to annual salary increments based on their sliding scales. Hence, the respondents pleaded with the court to maintain the *status quo* on the present salaries since they are now subject to revision any time this year, as there is already an appointment committee to revise the salaries for the parastatals and the civil service.

During the hearing the parties made very important submissions with the claimants vigorously submitting that the workers are responsible for handling coffee the major foreign exchange earner and in that capacity they deserve a better deal especially in view of the prevalent high inflation rate and the previous devaluation of the Kenya shilling. The court notes that the parties were unable to conclude an agreement as from 1st July, 1976, a period well over 10 years, despite the fact that the wages guidelines require parties to revise their agreement regularly.

However, the court is satisfied that the employees salaries are based on sliding scales with automatic annual salary increments which have been adjusting workers salaries every year. The court notes that the Coffee Board of Kenya is a service organization to the coffee industry on behalf of Kenya coffee farmers. The court has always pointed out in the past in all disputes concerning the farmers incomes and would like to reiterate it once again that the farmers play an important role in the economy of Kenya and need to be encouraged to increase production.

The court notes that there has been no agreement between the parties for the last 10½ years as from 1st July, 1974 to-date.

The court would like to add that there is a certain amount of validity in the claimants' argument that the annual salary increments under the wage guidelines do not adequately compensate workers for their rise in the cost of living indices.

The court accordingly awards the following salary increments for the respondents unionizable employees only with effect from 1st January, 1985:

The court further directs that in the event of the salaries being revised as a result of a government directive then the salary increments awarded by the court will be taken into consideration.

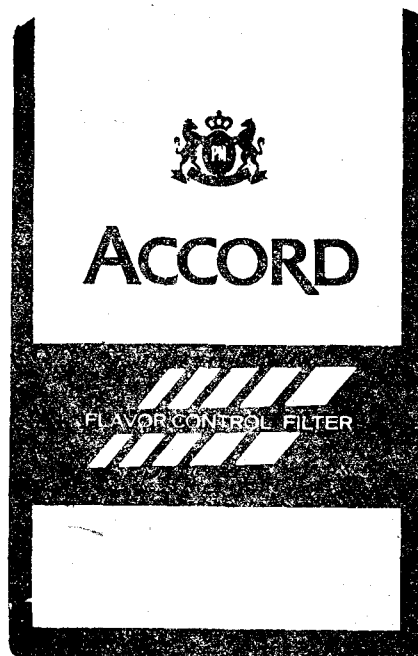

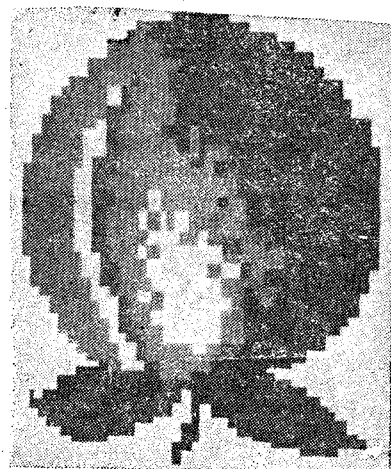

(4) He will seek to co-ordinate the activities undertaken by the division with other Unesco programmes and units concerned with development co-operation and the establishment of a new economic order. He will ensure that the reports prepared by the division are in harmony with the declared and approved policies of the organization.

(5) He will supervise the work of the professional staff members of the division and evaluate their services.

Qualifications and experience required:

- (a) University degree in education, economics, science or engineering (technical or agriculture).
- (b) Experience in the field of education, including administrative experience at the policy-making level.
- (c) Knowledge of educational systems in both advanced and developing countries is essential.
- (d) Fluency in both English and French, and ability to draft coherently in one of these languages.

- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—**Kenya Gazette**

"D.14.(1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.
