Vacancies in the Ministry of Labour:

Labour Officer I (Two Posts) (No. 273/85)

Salary scale.—K£2,154 to 2,928 p.a. PENSIONABLE or AGREEMENT.

Applicants must be civil servants with minimum educational qualifications of East African Certificate of Education or its equivalent with considerable experience in labour administration and industrial relations. They must have shown ability and merit over a period of at least three (3) years in the grade of Labour Officer II. They must have thorough knowledge of government regulations, and should have administrative experience and knowledge of accounting procedures.

Duties include handling of industrial relations either at the labour department headquarters or in one of the provinces in way of conciliation and investigation and at the same time assisting junior officers in these duties; as well as advising employers and workers on matters concerning industrial relations. The successful candidates will be expected to work as deputy provincial labour officers in the provinces or assistants to the senior labour officers at the headquarters.

Lecturer I (Engineers) (Three Posts) (No. 274/85)

Salary scale.—K£2,154 to 2,928 p.a. PENSIONABLE or AGREEMENT.

Applicants must be holders of a degree from a recognized university in mechanical/electrical engineering and be registrable by the Engineers Registration Board of Kenya.

They must have served at Job Group "J" level for at least three years and have been confirmed in appointment and must have shown ability and competence to perform and to discharge duties and responsibilities normally carried out by professional engineers. Post-graduate qualification in textile technology in either spinning, or weaving or fabric processing is essential. Teaching experience would be desirable but not essential.

Or applicants must be holders of a degree from a recognized university in textile/chemical engineering or higher diploma in mechanical/electrical/chemical engineering and a qualification in textile technology/sciences or have equivalent academic qualifications. They must have at least four years experience in a senior position in government or industry.

The successful candidates will be responsible to the training manager of the Kenya Textile Training Institute in the administration and managerial control of his/her training section in spinning, or weaving, or fabric processing, or maintenance which involves planning and implementing of training programmes, budgeting and control of his/her section, supervising the teaching staff of his/her section. Maintenance of machinery and equipment in liaison with maintenance section, checking stores, conducting training, making job specifications and training surveys, follow-up of trainees' performance, advising industry on quality and quantity standards and training matters and any other duties as will be assigned by the training manager/principal.

Lecturer II (Garments) (One Post) (No. 275/85)

Salary scale.—K£1,794 to 2,424 p.a. PENSIONABLE or AGREEMENT.

Applicants must be holders of a higher diploma in garment making from a recognized institution. They must have a minimum of three years' professional experience in government or industry. Teaching experience would be desirable but not essential.

The successful candidate will be responsible to the training manager in supervising training programmes and instructors, conducting lessons, follow-up of trainees' performance, advising garment industry in training matters and perform any other duties as will be assigned by the training manager.

Lecturer II (Engineers) (Three Posts) (No. 276/85)

Salary scale.—K£1,794 to 2,424 p.a. PENSIONABLE or AGREEMENT.

Applicants must be holders of a degree from a recognized university in mechanical/electrical/chemical engineering. Post-graduate qualification in textile technology/sciences either in spinning or weaving or fabric processing or maintenance is essential. Alternatively applicants must be holders of a degree from a recognized university in textile engineering. Teaching experience would be desirable but not essential.

The successful candidates will be responsible to the Lecturer I (head of section) in supervising training programmes and instructors, conducting lessons, follow-up of trainees' performance and perform any other duties as will be assigned by the Lecturer I.

Labour Officer II (Four Posts) (No. 277/85)

Salary scale.—K£1,794 to 2,424 p.a. PENSIONABLE or AGREEMENT.

Applicants must be civil servants with a minimum educational qualification of E.A.C.E. or its equivalent with considerable experience in labour administration and industrial relations. They must have shown ability and merit over a period of three (3) years in the grade of Labour Officer III and have been confirmed in appointment. They must have thorough knowledge of government regulations and should have administrative experience and knowledge of accounting procedures.

Duties involve taking charge of a district labour office with industrial undertakings. Running the office including undertaking conciliations in trade disputes; work organization for labour inspections to ensure compliance with statutory requirements; labour investigations and the Trade Disputes Act.

Labour Officer III (Three Posts) (No. 278/85)

Salary scale.—K£1,494 to 2,010 p.a. PENSIONABLE or AGREEMENT.

Applicants should be in possession of a university degree in any of the social sciences or its equivalent. Candidates who do not possess university degree should have served in the grade of Senior Labour Inspector for a period of not less than three years. They should have gained practical experience in the field of industrial relations, labour inspections as well as prosecutions.

Duties include the enforcement of labour laws through inspection of places of employment, conciliations and investigations as well as advising trade unions, disputes, as well as advising on improvement of working conditions for workers.

Instructor (Training Programme) (Thirteen Posts) (No. 279/85)

Salary scale.—K£1,494 to 2,010 p.a. PENSIONABLE or AGREEMENT.

- (a) Motor vehicle mechanic, fitting and turning, motor vehicle electrician—two posts each.
- (b) Technical drawing, welding, building/woodwork, electrical installation, carpentry/joinery, automotive motor vehicle and liberal arts—one post each.

Applicants must have been educated to at least E.A.C.E. level, hold the City and Guilds Technician Part II Certificate in any of the engineering disciplines—automotive, building and civil, chemical, electrical, mechanical, fitting and turning or hold equivalent qualification. They must also be in possession of certificates or diplomas in training from recognized institutions. They must be proficient in teaching adults and in elements of instructions. They must have a minimum period of two years' industrial experience since obtaining the above qualifications. Technical teaching experience in addition will be an advantage and a Grade I Trade Test Certificate in a relevant trade is desirable.

VACANCIES—PUBLIC SERVICE COMMISSION—(Contd.)

The successful candidate will be required to instruct apprentices (trainees) in the instructor training section of this department and take part in training in both technical skills and pedagogy, prepare relevant training materials; prepare, mark and assess proficiency tests and be responsible for the installation, commissioning and maintenance of machines, equipment and tools as well as for the overall cleanliness and effective operation of workshops in his section.

*Vacancies in the Ministry of Commerce and Industry:**Senior External Trade Officer (Five Posts) (No. 280/85)*

Salary scale.—K£2,712 to 3,540 p.a. PENSIONABLE or AGREEMENT.

Applicants should be serving External Trade Officers Grade I (Job Group "K") or in equivalent post within the Ministry of Commerce and Industry and must possess a degree in commerce or business administration or economics from an approved university or equivalent professional qualification—special preference will be given to those who have specialized in aspects of foreign trade. They should also have served for a minimum period of two years in Job Group "K". Besides, they should possess sound knowledge in foreign trade policies and practices and be versed in international trade relations, export trade promotion and export financing. In addition to this, they should have demonstrated ability to guide, control and co-ordinate activities of other officers as well as the ability to plan and initiate action for implementation of programmes in the Department of External Trade as a whole. The successful candidates will initially be posted to work in the External Trade Department with the possibility of later being posted out to Kenya's missions abroad to work as commercial attaché.

Duties will include participation in the planning co-ordination, organization of, and initiating action on export promotion activities and export credit financing facilities; and participating and initiating action on international, regional and bilateral trade conferences, meetings and negotiations in which the Ministry of Commerce and Industry is involved.

*Vacancies in the Ministry of Finance and Planning:**Tax Officer I (Seven Posts) (No. 281/85)*

Salary scale.—K£1,794 to 2,424 p.a. PENSIONABLE or AGREEMENT.

Applicants should be experienced civil servants with not less than three (3) years' service as Tax Officer III (Job Group "H") and have demonstrated outstanding technical competence and ability in addition to organizing and supervision skills. They should be officers of undoubted integrity.

Duties and responsibilities at this level will include training and supervising groups of tax officers in the lower grades, checking and auditing more difficult tax returns, approving amended assessments, dealing with more difficult correspondence and interviews as referred to them by lower grade tax officers; leading P.A.Y.E. audit teams and any other duties assigned to them.

In collection office Tax Officer I will be responsible for supervising and training tax officers, tax assistants and clerical officers under him/her. They will, in addition, deal with more difficult correspondence and interviews as referred to them by the supporting staff. Other duties include receiving tax payments, banking, recording, accounting, write-offs, reconciliation of balances and security management, approving and signing letters to ensure proper follow-up by junior officers and preparation of cases for enforced recovery and repayment work and any other duties assigned to them.

*Vacancies in the Ministry of Works, Housing and Physical Planning:**Chief Superintending Quantity Surveyor (One Post) (No. 282/85)*

Salary scale.—K£3,804 to 4,956 p.a. PENSIONABLE or AGREEMENT.

Requirements for appointment:

The applicant must—

- (i) be in possession of requisite professional qualification;
- (ii) have, in the case of serving officers, completed a minimum of twelve (12) years' post-professional qualification experience as a quantity surveyor, three of which having been served in Job Group "M" level, or in the case of other sectors, have completed a minimum of fourteen (14) years' post-professional qualification experience as a quantity surveyor at least five of which must have been served in a managerial capacity;

- (iii) have shown wide experience, outstanding professional competence and a high degree of administrative and leadership capacity.

Duties and responsibilities.—The chief superintending quantity surveyor is the head of the department and the duties and responsibilities include the following:

- (i) Overall responsibility for direction, management, performing and evaluation of the quantities and contracts department.
- (ii) Control of the contractual administration of all building construction contracts.
- (iii) Control of tenders and tender procedures for all building construction contracts. He is secretary to the Board of Registration of Architects and Quantity Surveyors and of the contractors registration committee.
- (iv) Formulation of policy on contractual matters relating to building works.
- (v) Control and supervision of the performance of consulting quantity surveyors.
- (vi) Advisor to other ministries and government bodies on the administration of building construction contracts and other contractual matters.
- (vii) Preparation and implementation of training and staff development programmes for staff working in his department.

Architectural Assistant III (Three Posts) (Re-advertisement) (No. 283/85)

Salary scale.—K£1,128 to 1,554 p.a. PENSIONABLE or AGREEMENT.

Applicants should be in possession of the diploma in building and civil engineering or its equivalent from the Kenya Polytechnic or other approved institution.

Duties and responsibilities include interpretation of architects' sketches of simple buildings, and also engineering drawings relative to the various engineering disciplines from which he will be required to prepare detailed architectural drawings, specification notes and schedules. He will be expected to be able to prepare presentation drawings perspectives and simple models of such buildings. He will also be expected to understand the activities in an architectural office and will work directly under an architect.

*Vacancies in the Vice-President's Office and Ministry of Home Affairs:**Social Welfare Officer I (Three Posts) (No. 284/85)*

Salary scale.—K£1,794 to 2,424 p.a. PENSIONABLE or AGREEMENT.

Applicants must be social welfare officers grade II who have served in Job Group "H" for a minimum period of three (3) years and in addition be in possession of the requisite professional qualifications. They must have also shown merit and ability to run efficiently social welfare services at the provincial level or at any other comparable position.

Duties will include investigation and solution design to social problems of staff and prisoners at a provincial penal institution. He will liaise with relevant authorities such as prisoners' aid association on behalf of the prisoners.

Probation Officer II (Six Posts) (No. 285/85)

Salary scale.—K£1,494 to 2,010 p.a. PENSIONABLE or AGREEMENT.

Applicants should be in possession of a degree in social sciences from the University of Nairobi or any other recognized university. Serving probation officers grade III who have completed a minimum of three years' service at Job Group "G" level, are confirmed in their appointments, have knowledge of the Probation Offenders' Act, have shown merit and proven ability in carrying out probation work will also be considered.

Successful candidates will initially work under the supervision of a more senior officer. He/she will be responsible for social investigation for courts. - (a) Accounts or
- (b) Stores or
- (c) Personnel or
- (d) General office services.

3. ELIGIBILITY TO ENTER

The requirements for clerical officers (civil servants only) to qualify for sitting for the Proficiency Examination are as follows:

- (i) That those appointed directly in Job Group D are required to complete at least four (4) years' service in the grade before entering for the examination.
- (ii) Those clerical officers who were appointed at a starting salary of K£618 per annum and above by virtue of their educational qualification or experience may enter the examination after completing two (2) years' service.
- (iii) Junior clerical officers who have been promoted to Job Group D are required to complete at least two (2) years' service in this grade before they qualify.
- (iv) Storemen grade III qualify for the examination in the same manner as junior clerical officers.

4. CONDITIONS FOR OBTAINING A PASS

Every candidate will be required to enter for and pass *all the three main papers* at one and the same sitting.

No partial passes will be allowed.

5. EXAMINATION REGISTRATION FEES

Every candidate entering this examination will be required to pay a registration fee of KSh. 50 only, for the whole examination. The registration fee which will be non-refundable, will be payable to the Secretary, Public Service Commission of Kenya, P.O. Box 30095, Nairobi in either crossed Kenya money order, postal order or cash. Personal cheques will not be accepted.

6. ENTRY FORMS

Candidates must complete and submit the examination entry forms in triplicate, as set out at the "Appendix" to this circular letter, copies of which should be reproduced and cyclostyled by each ministry/department as required and the completed entry forms, duly certified correct by the candidate's chief/senior personnel officer or PF & EO and accompanied by the correct registration fees, should be forwarded to the Secretary, Public Service Commission of Kenya, Nairobi, so as to reach him on or before Friday, 27th September, 1985. Late entries, incomplete/wrongly completed entries or uncertified forms and forms not accompanied by the correct registration fees, will automatically be rejected.

It is, therefore, the responsibility of the certifying officer to check and satisfy himself/herself that the information given is correct in every respect and that the person intending to register for the examination is what he/she claims to be. 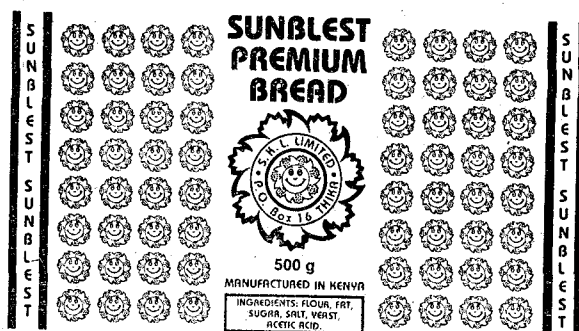

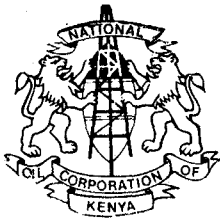

"D.14.(1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer when ready."

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
