THE Tailors and Textiles Workers' Union shall hereinafter be referred to as the claimants and KICOMI (1983) Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi, on 13th August, 1985, and relied on their written and verbal submissions.

#### Award

3. The Notification of Dispute Form "A" dated 3rd October, 1984, duly signed by the parties was received by the court on 1st March, 1985, together with the statutory certificate signed by the Labour Commissioner.

The respondents are situated in Kisumu, Nyanza Province. They took over from the receivers of the defunct Kisumu Cotton Mills in May, 1983. The defunct Kisumu Cotton Mills was established several years ago and after operating for a number of years, they had financial problems and could not meet their financial obligations. They were eventually placed under receivership on 30th April, 1982, with Messrs. Cooper Lybrand. The receivers were appointed managers to replace the previous management of the Kisumu Cotton Mills Limited. The company was heading for liquidation had it not been for the intervention of the government through the initiative of His Excellency the President. The government had to come in to save the jobs of hundreds of Kenyans. At the time of being placed under the receivership the company had over two thousand employees. After twelve months, the receivers found the buyers, namely the Industrial Development Bank (I.D.B.), Industrial Commercial Development Corporation (I.C.D.C.), Development Finance Company of Kenya (D.F.C.K.), and Continental Development Corporation (C.D.C.). The four financial institutions formed a company under a new name KICOMI (1983) Limited, on 1st May, 1983.

While presenting their demands in court, the claimants told the court that they were aware of the previous problems which led to the collapse of the defunct Kisumu Cotton Mills Ltd. and they are now aware that the respondents had made some improvement after 12 months of operation. And because of this the claimants told the court they could not see any reason why the respondents cannot better the terms and conditions of their employees. The claimants continued to tell the court that they had submitted their proposals to the respondents to revise wages and terms and conditions of employment on 29th February, 1984, and that at the time, the issues in dispute were 41 which were eventually scaled down to 4. The claimants accused the respondents of failure to respond for discussion and therefore, they had no alternative but to report a formal dispute to the Minister for Labour. The claimants

F. B. MAIKO, Secretary, National Standards Council. submitted their demands as follows.

On gratuity.—The claimants demanded that an employee with one or more years of unbroken service with the company shall be entitled to twenty-five (25) days wage for each completed year of service.

Housing.—The claimants demanded that every employee who is not provided with housing accommodation shall be entitled to KSh. 240 as house allowance in addition to his basic wage, for the first year and KSh. 240 per month for the second year of the agreement.

## Wage:

The claimants demanded wage increase as follows:

- (i) Those earning up to KSh. 700, 60 per cent for the first first year and 60 per cent for the second year of the agreement.
- (ii) Those earning above KSh, 700, 40 per cent for the first year and 40 per cent for the second year of the agreement.

## Effective date of the agreement:

The claimants had previously demanded the effective date to be 26th October, 1980, but later told the court that they would not mind if the effective date would be September, 1984.

The respondents told the court that in November, 1984, the new company was being managed by the promoters without a consitituted board of directors. The respondents also informed the court that as from 1st May, 1985, 21st November, 1984, they incurred a lot of losses, and the promoters had to look for finance to save the company from collapsing. The respondents went further to tell the court that despite these heavy losses, the general manager pleaded with the promoters for authority to give the workers a wage increase. This request was granted and the workers were given an increase of 10 per cent with effect from 1st January, 1984. The court was also told by the respondents that prior to the defunct Kisumu Cotton Mills Ltd. going into receivership, the company had 1939 workers working on 3 shifts and today the respondents have only 1,454 employees working on 2 shift roster, and therefore they operate at only two-thirds capacity and were producing goods which keep on piling up unsold. The respondents continued saying that the poor sales are attributed to the following factors:

- (a) General recession and 1984 drought.
- (b) Undercutting by the local competitors.
- (c) Competition with cheaper goods from the Far East.
- (e) Delays in processing of the raw material import licence applications.

Again, the respondents told the court that despite their financial constraint, they agreed with the claimants to adopt the terms and conditions of service which the claimants had previously signed with the defunct Kisumu Cotton Mills Ltd., and also they had co-operated with the claimants and as a result they managed to agree on so many other issues except the four in question. The respondents pleaded with the court to reject the claimants demands and to uphold their offers. They went ahead to say they have a loan to the tune of 89.9 million shillings and also they operate on 30 million shillings overdraft. Lastly the respondents informed the court that despite its financial problems, they were prepared to offer as follows:

- (a) Gratuity.—The respondents requested the court to reject this demand as it is an entirely new item involving a heavy expenditure which they could not afford.
- (b) House allowance.—The respondents offered to increase house allowance from KSh. 100 per month :o KSh. 160.
- (c) Wages.—The respondents offered as follows:
  - (i) For those earning KSh. 700 per month (excluding house allowance) 8 per cent wage increase for the first year and further 8 per cent for the second year with effect from the date the award is announced.
  - (ii) Those earning a wage above KSh. 700 per month (excluding house allowance) 7 per cent for the first year, further 7 per cent for the second year, with effect from the date the award is announced.
- (d) Effective date.—The respondents pleaded with the court to make the effective date to be the date when the award is announced. They told the court that backdating the effective date as per claimants demand could cripple the operation of the respondents, and therefore the court should reject this claimants demand.

respondents offers with modification on effective date only. The court awards as follows:

- (at On gratuity.-The court rejects the claimants demand.
- (b) House allowance.—The court accepts the respondents offer of KSh. 160 per month and so awards.
- (c) Wages.—The court accepts the respondents offer and awards as follows:
  - (i) For those earning KSh. 700 per month (excluding house allowance) 8 per cent increase for the year and a further 8 per cent increase for the second year.
  - (ii) For those earning a wage above KSh. 700 per month (excluding house allowance) 7 per cent wage increase for the first year and a further 7 per cent increase for the second year.
- (d) Effective date.—The court awards the effective date to be 1st January, 1985, with a duration of two years.

CAUSE NO. 64 OF 1984

Parties:

Kenya Timber and Furniture Workers' Union

and

National Pencil Company Limited

Issue in dispute:

Recognition.

THE Kenya Timber and Furniture Workers' Union shall hereinafter be referred to as the claimants and the National Pencil Company Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi, on 6th February and 8th July, 1985, and the court primarily relied on both their written and verbal submissions.

## AWARD

3. The Notification of Dispute Form "A" dated 16th January, 1984, duly signed by the parties was received by the court on 14th August, 1984, together with the statutory certificate signed by the Labour Commissioner.

The court has scrutinized carefully the written and verbal submissions made by both parties. The court noted with dismay the astronomical and unreasonable demands made by the claimants. They had asked for a wage increase of 120 per cent within 2 years. The claimants know very well that KICOMI (1983) Ltd. had inherited financial problems from the defunct Kisumu Cotton Mills Limited and at the same time the same company had been saved by the government from a total collapse so as to save the jobs of hundreds of Kenyans. The court is satisfied that KICOMI (1983) Limited, has a loan of KSh. 89.9 million which has to be paid and they are currently on a KSh. 30 million overdraft. In these circumstances the court feels that the new management of the company should be given a chance to rehabilitate the business and bring it back to be financially viable and profitable. The court finds that to make an award as per the claimants demand would cripple the operations of the respondents and could be deterimental to the interests of both the claimants and the respondents. The court has decided to make an award as per

The claimants approached the respondents to accord them recognition on 21st July, 1980, after recruitment of fifty-four (54) of their employees as claimants' members. However, the parties failed to agree on recognition issue and due to either victimization or on their own volition, the employees withdrew from the claimants membership. Another attempt was made by the claimants to recruit new members in May/June, 1983, during which time eighty-six (86) workers registered. The recruitment drive by the claimants was aimed at gaining fifty-one (51.0) per cent simple majority in order to be accorded recognition by the respondents as required under the Trade Disputes Act, (Cap. 234) clause 5, section 2. In brief, the relevant section stipulates that the Minister for Labour may order an employer(s) to accord recognition to a trade union after being satisfied with its authentic membership. A conciliator was appointed to assist the parties reach an agreement but all was in vain. On receipt of the conciliator's report, the Minister for Labour in his letter of 9th January, 1984, recommended that the respondents should accord the claimants full recognition. This recommendation was apparently ignored given the continuation of the dispute.

During the hearing of the dispute, the parties tried to blame each other for their failure to reach a voluntary agreement on recognition. In fact, the claimants have strongly argued that the respondents have hindered their recruitment drive through dismissals and unwarranted transfers of their workers to frustrate membership and hence, ward off recognition.

The court notes that the claimants sought recognition from the respondents in July, 1980, and yet they would like the award to be effective from January, 1984. This date is based on the minister's letter to the parties recommending the respondents to accord recognition to the claimants. However, they would prefer an earlier date, but not later than January, 1984.

The respondents had categorically denied being responsible for stalled negotiation through indiscriminate dismissals and transfers. In fact, they blamed the claimants for having not achieved a simple majority membership of their total labour force of 224 as per statutory requirements, submitting illegible check-off list with dubious signatures and above all, soliciting and getting non-employees signatures. In addition, the checkoff list did not have union membership numbers and appended signatures. All in all, the respondents submitted during the hearing that they have no objection to accord recognition to the claimants provided the claimants achieve simple majority of workers in their membership and serve them with well documented and legible check-off list of genuine members employed by the respondents.

The court requested the Division of Manpower Planning and Development (D.M.P.D.) to carry out on the spot investigations regarding the number of unionizable employees, employment status and the appropriate dates of union membership. On the spot investigations were consequently carried out by the D.M.P.D. and the analysis made available to the court and the parties. This analysis revealed among other things that the respondents had a total labour force of 224 in 1984-85 out of which 191 or 85.3 per cent had joined the claimants. By inference, this implies that a simple majority of 51.0 per cent had been achieved and exceeded as required by statutory provisions indicated herein above. In addition, the report revealed that some degree of coercion was used by the respondents to discourage union membership although the claimants were also to blame for issuing membership cards without numbers.

The court would like to point out that this dispute has taken five (5) years since July, 1980, during which time the workers welfare was adversely affected in terms of remuneration and other terms and conditions of employment. Furthermore, account has been taken of the Ministry of Labour recommendation, the approval of the Registrar of Trade Unions that the check-off list was properly served on the respondents by the claimants and above all, the D.M.P.D. report which revealed that a simple majority of 51.0 per cent membership had not only been attained but exceeded according to statutory provisions. The court has also noted that there is no rival trade union claiming to represent the respondents employees and therefore the claimants appear to be the right trade union according to their existing constitution.

After careful consideration of all the parties submissions, the court has come to the conclusion that the respondents should accord recognition to the claimants and the court awards accordingly. In addition, the court directs that the recognition agreement should be signed by the parties within one month of the date of the court award.

Finally, the court has noted with serious concern the poor industrial relations existing between the parties hitherto. Having resolved this thorny issue of recognition through arbitration, the court hopes that the parties will endeavour to improve their industrial relations for their own common good. It is of paramount importance for the parties to recognize that higher productivity stamps from a healthy and contented labour force. This can only be achieved through improved industrial relations machinery which will have a bearing on the parties collective bargaining agreements to be entered into immediately after signing of the recognition agreement.



## IMPORTANT NOTICE TO SUBSCRIBERS TO THE KENYA GAZETTE

THE following notes are for the guidance of persons submitting "copy" for inclusion in the Kenya Gazette, Supplements, etc.:

- (1) The Kenya Gazette contains notices of a general nature which do not affect legislation. They are therefore submitted to the Government Printer directly.
- (2) Legislative Supplement contains Rules and Regulations which are issued by the Central Government. Because of this they must be submitted to the Government Printer through the office of the Attorney-General.
- (3) Bill Supplement contains Bills which are for introduction in the National Assembly.
- (4) Act Supplement contains Acts passed by the National Assembly.

All "copy" submitted for publication should be prepared on one side of an A4 sheet no matter how small the notice or Act, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible and contain a minimum of alterations.

Particular attention should be paid to the following points:

- (i) Signatures must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D-

## Kenya Gazette

"D.14.(1) Communications for the Kenya Gazette should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.

(2) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer when ready."

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
