VACANCIES

Civil servant applicants and local authority officers should complete Form PSC. 2A (Revised) in triplicate (submitting the original through their heads of department) and cards PSC. 25 and 25A. Other applicants should complete forms PSC. 2 in triplicate and cards PSC. 24 and 24A.

The documents are obtainable either from the secretary or from other government offices and are issued free of charge.

**NOTE**

Incremental credits will be granted to successful candidates who are not civil servants for approved previous experience provided the maximum salary is not exceeded. They will also be eligible for benefits and privileges enjoyed by civil servants in accordance with existing government regulations.

*Vacancy in the Ministry of Water Development:*

*Senior Water Bailiff (One Post) (Water Resources) (No. 445/85)*

Applicants must be law graduates from an approved university and should have a bias towards environment law; knowledge of water law will be an added advantage. Applicants must be in possession of K.A.C.E. or its equivalent standard of education and should have passed City and Guilds certificate in motor mechanic part I or II. Applicants also hold current driving licence for both light and heavy commercial vehicles.

The successful candidates will be required to assist in the inspection of motor vehicles as prescribed under the Traffic Act (Cap. 403), of the laws of Kenya and should be prepared to be posted to any testing centres in Kenya.

**Senior Superintending Quantity Surveyor (One Post) (No. 450/85)**

Development and maintenance of professional standards of the quantities and contracts in the department and provincial offices. Supervision of preparation of bills of quantities; specifications and approval of final accounts; supervision and control of specialized units such as the cost planning unit, contract audit, computer bills, contracts office, pre-contract office and contracts register. Advice on contract procedures; liaison with the Attorney-General's Chambers on legal matters, staff matters including their training, and development. Control and implementation of all tender and contractual matter in relation to maintenance programme of government buildings throughout the Republic of Kenya.

**Senior Housing Officer (Planner) (One Post) (No. 451/85)**

**Salary scale.**—K£2,928 to 4,116 p.a. PENSIONABLE or AGREEMENT.

Applicants must hold at least a good first degree in either architecture, building or land economics plus at least five (5) years of relevant working experience in Job Group "K" if in Government service or equivalent if in private sector. Preference will be given to those who have had post graduate training in the fields of urban development and project planning. The senior housing planner as the head of the housing planning and project division of the department of housing will be responsible for co-ordinating and supervising the work of several professional officers in the division. He/she will in addition be charged with the following duties:

- (a) Advising on the formulation of national housing policies;
- (b) Formulation of national housing programmes within the frame work of national development plans;
- (c) Determining the short- and long-terms physical, financial and organizational requirements of such programmes;
- (d) Preparation of housing projects for financing by various donor agencies.
- (e) Co-ordinating the implementation of national housing programmes.
- (f) Monitoring and evaluation of national housing programmes.

**Superintending Architect (One Post) (No. 452/85)**

**Salary scale.**—K£2,928 to 4,116 p.a. PENSIONABLE or AGREEMENT.

Applicants must be in possession of a degree in architecture from the University of Nairobi or equivalent qualification acceptable to the Board of Registration of Architects and Quantity Surveyors of Kenya. They must have four (4) years' post-graduate practical experience in a government department or a reputable architectural drawing office. They must also be registered by the Registration Board of Architects and Quantity Surveyors of Kenya and have demonstrated general administrative ability required for direction, control and implementation of buildings programmes including supervision of professional and technical staff.

**Duties and Responsibilities:**

Work involves management and co-ordination of professional and sub-professional staff in the preparation of design and production of drawings of all projects in the works programme, job control and site supervision of these projects during construction, monitoring of expenditure in liaison with forward planning group and informing client ministries on matters relating to design briefs and expenditure. He may also undertake duties of comparable responsibility at the provincial level.

In research work, duties of superintending architect will involve carrying out complex field surveys user reaction investigations, analysis and establishment of new space standards, better architectural detailing, utilization of local materials, report and drawings.

**Chief Superintendent (Electrical) (One Post) (No. 453/85)**

**Salary scale.**—K£2,928 to 4,116 p.a. PENSIONABLE or AGREEMENT.

Applicants must possess the electrical engineering technician certificate part III from the Kenya Polytechnic or its equivalent and hold a class "A" Electrician's Licence. They must have at least ten (10) years' post qualification experience three (3) of which must have been served as senior superintendent electrical in work involving preparation of designs and estimates for electrical installations; installation and maintenance of diesel generating plants, refrigeration and air-conditioning plants, cookers and domestic appliances as well as low and high voltage systems in public buildings. They must also have experience in contract administration and have ability to control a multi-disciplinary staff and budgeted funds.

Candidates are required to have a good working knowledge of the current "regulations for the electrical equipment of buildings".

**Estate Surveyor I (One Post) (No. 454/85)**

**Salary scale.**—K£2,424 to 3,540 p.a. PENSIONABLE or AGREEMENT.

Applicants must possess B.A. Land Economics degree from the University of Nairobi or equivalent qualifications from a recognized university. They must have a minimum of three (3) years' working experience as an estate surveyor II at Job Group "J" in Government or other organization of comparable scope and function. This post qualification experience should be in planning and implementation of housing programmes.

**Duties and responsibilities:**

- (a) Planning, development and management of staff mortgage housing programmes.
- (b) Review and appraisal of housing programmes and strategies.
- (c) Liaison with financial institutions on construction and mortgage finance.

He/she will also be expected to monitor the activities of the travel agents and tour operators. Applicants must have at least a minimum of certificate of Primary Education with a wide experience in security duties in establishments which require constant and concerted security control. Preference will be given to those applicants who have successfully held responsible positions in such establishments as police force or prisons service where security duties are carried out intensively. A sound knowledge of English and Kiswahili and ability to co-operate with members of the public are essential.

The duties will include allocating duties to the security men at the stadium who look after the stores and equipment in the main store, gymnasium, lounges, toilets, floodlights and general electrical fittings. He will also be in charge of the fencing and gates. He will control trespassers and protect and improve security measures.

## Archivist Grade I (Technical Services) (One Post) (No. 457/85)

They must also be serving archivist II (Job Group "J") or its equivalent and must have completed at least one year's service in this grade. The successful candidate will be responsible to a senior archivist in the administration division for the effective implementation of reprographic programmes, and the development and management of restoration facilities in the National archives.

**Salary scale.**—K£2,010 to 2,928 p.a. PENSIONABLE or AGREEMENT.

Applicants should be holders of a degree in social science from a recognized university with a minimum of three years (3) years' working experience in an archival institution in which they must have displayed talent and industry in research methodology, acquisition, description and storage of audio-visual and private records, or the acquisition, accession, classification and cataloguing of library materials. Candidates in possession of a post-graduate diploma/certificate in archives administration, records management or librarianship from a recognized training institution will have an added advantage.

The successful candidates will be responsible for research and acquisition of audio-visual and private records, description, storage and retrieval or the accession, classification, cataloguing and user services for library materials.

## Children's Officer I (Two Posts) (No. 459/85)

**Salary scale.**—K£2,010 to 2,928 p.a. PENSIONABLE or AGREEMENT.

Applicants must be serving Children's Officer II, Social Welfare Officer II, Education Officer II or manager of an approved school, who have served for a minimum period of three (3) years in Job Group "H". Preference will be given to applicants with a degree in social sciences or education obtained from recognized universities.

The successful candidates will be posted to any approved school within the Republic of Kenya as managers as stipulated under Chapter 141 of the Laws of Kenya to be in charge of total administration of the school, inmates' discipline and financial control of the school. He/she will be responsible to the Director of Children's services.

Applicants must have a C.P.A. II certificate or its accepted equivalent with a minimum of two years' post-qualification experience at a senior level in a large local authority, government or other public organization.

The successful candidate will be required to discharge accounts assignments under the general direction of the section head.

## Chief Internal Auditor (One Post) (No. 463/85)

**Salary scale.**—K£3,666 to 5,301 p.a. PENSIONABLE or AGREEMENT.

Applicants must be fully qualified accountants with C.P.A. III (Final) certificate or its accepted equivalent and must have had at least three (3) years' relevant post qualification experience. Serving officers with C.P.A. II certificate and a minimum of three (3) years' auditing experience in a local authority, will also be considered.

The successful candidate will be required to discharge routine audit duties and to prepare audit reports.

## Chief Revenue Officer (One Post) (No. 464/85)

**Salary scale.**—K£3,666 to 5,301 p.a. PENSIONABLE or AGREEMENT.

Applicants must be fully qualified accountants with C.P.A. III (Final) certificate and must have had a minimum of three (3) years' post qualification accounting experience. Serving officers with C.P.A. II certificate and a minimum of three (3) years' experience in revenue collection, preferably in a local authority, will also be considered.

They must have over five (5) years' post-qualification experience in land and valuation matters with particular reference to rating, compulsory acquisition, rental assessment and insurance. The successful candidate will be responsible to the town clerk for the efficient management of the valuation section and to appear before tribunals or courts whenever there are land acquisition or rating valuation cases.

Applicants must have a diploma in public health inspection, another diploma in inspection of meat and other foods or their accepted equivalent, and a minimum of five years' relevant experience, two of which must have been at the level of public health officer II in a local authority or central government. Applicants with additional qualifications such as a diploma in tropical hygiene or public health engineering will have an added advantage.

The successful candidate will be responsible for the enforcement of public health regulations under the general supervision of the chief public health officer.

*Public Health Officer I (Four Posts) (No. 467/85)*

**Salary scale.**—K£2,220 to 3,774 p.a. PENSIONABLE or AGREEMENT.

Applicants must have a diploma in public health inspection, another diploma in meat and other foods inspection or their accepted equivalent, and a minimum of three (3) years' relevant experience at the level of public health officer II, in a local authority or central government. Applicants with a diploma in health engineering or tropical hygiene will have an added advantage.

The successful candidate will be involved in enforcement of public health regulations under the direction of a chief public health officer.

*Public Health Officer II (Two Posts) (No. 468/85)*

**Salary scale.**—K£1,824 to 3,234 p.a. PENSIONABLE or AGREEMENT.

Applicants must have a diploma in public health inspection or accepted equivalent, and a minimum of three (3) years' relevant post qualification experience. Applicants with a diploma in meat and other foods inspection, tropical hygiene or health engineering will have added advantage.

The successful candidates will be involved in enforcement of public regulations under the direction of a senior public health officer.

*Nyeri Municipal Council:**Chief Internal Auditor (One Post) (No. 469/85)*

**Salary scale.**—K£2,532 to 4,434 p.a. PENSIONABLE or AGREEMENT.

Applicants must be in possession of a degree from a recognized university with accounting as a major field of study plus at least three (3) years' post-graduate experience in auditing or accounting or must be in possession of part II certificate of the C.P.A. (Kenya) plus at least three (3) years' post-qualification experience. Preference will be given to candidates with local government accounting auditing experience.

The successful candidate will be required to discharge routine audit duties and to prepare audit reports.

*Town Treasurer (One Post) (Re-Advertisement) (No. 470/85)*

**Salary scale.**—K£3,855 to 5,511 p.a. PENSIONABLE or AGREEMENT.

Applicants should have passed the final examination of the Certified Public Accounts (Kenya) or equivalent professional accountancy qualification plus at least five (5) years' accounting experience; or, should be graduates from a recognized university with accounting as a major field of study plus at least five (5) years' post-qualification accounting experience. Candidates with school certificate or equivalent standard of education plus at least ten (10) years' experience as a senior officer of a local authority treasurer's department, may also be considered.

The town treasurer is the chief finance officer of the council. He is responsible for financial management in the council, keeping of all financial records and advising the council on all financial matters.

#### Issue in dispute:

Dismissal of Joseph Kiragu.

THE Kenya Union of Domestic, Hotels, Educational Institutions, Hospitals and Allied Workers shall hereinafter be referred to as the claimants and Sarova Hotels Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 17th October, 1985, and in addition to relying on their written and verbal submissions the claimants called the grievant to give evidence on oath.

#### AWARD

3. The Notification of Dispute Form "A" dated 8th October, 1984, duly signed by the parties was received by the court on 20th February, 1985, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

Joseph Kiragu was employed by the respondents on 1st July, 1979, and posted to Whitesands Beach Hotel at an initial salary of KSh. 517.50 including a house allowance of KSh. 120 per month. He was also paid service charge at an average of KSh. 370 per fortnight. During the time he was dismissed his salary had risen to KSh. 782.15 plus a house allowance of KSh. 220 per month, in addition to KSh. 370 service charge.

The claimants stated that at the time Joseph Kiragu worked at Whitesands Beach Hotel, Mombasa, he got on well with his superiors and never had conflicts with them as he was not involved in trade union activities. The management at Mombasa managed their affairs well and furthermore paid their workers on time and there was, therefore, no conflict between them and the employees.

However, when Joseph Kiragu got a transfer from Mombasa to New Stanley, Nairobi matters changed as he found that the management of the hotel in question were violating collective agreements by not providing reasonable meals to unionizable staff, late payment of service charges and overtime and failing to provide night transport to unionizable staff to their respective locations of abode.

Mr. Kiragu further noticed that there was unnecessary harassment of unionizable staff by certain members of the management. Some of the management indulged in bad labour practices and summarily dismissed workers without good cause. Furthermore, the management refused to remit union dues to the claimants. It was because of the violation of the collective bargaining agreement by management that Joseph Kiragu as an active member of the union objected and as a result was marked by the senior members of the management as a bad man who should be sacked.

The claimants went on to say that after a shortwhile Mr. Kiragu was served with a letter of warning on issues that were flimsy to make him frustrated. The management later demoted him and made him a wine waiter instead of a barman. However, Mr. Kiragu persevered till the time he was sacked for having talked to a pressman who had come up to cover a serious incident which happened in the New Stanley Hotel during the Organization of African Unity Conference that was held in Nairobi, a few years ago and also to recent complaints by members of the public of discriminatory nature of service rendered in their hotel. The claimants, therefore, submitted that Mr. Kiragu was victimized for his involvement in trade union activities.

The respondents stated that during the time Joseph Kiragu worked at Whitesands Beach Hotel, Mombasa, contrary to what the claimants submitted Mr. Kiragu was given a letter of warning on 17th April, 1980, for insubordination and was then demoted to the position of a shambaman. He was then transferred to Nairobi at his own request. The respondents, however, do not agree with the statement by the claimants that Mr. Kiragu was a good friend of management as he worked so efficiently at his job as a barman and was not warned by the management neither did they complain about him. The res-

pondents pointed out that Mr. Kiragu, had, prior to his being elected a shopsteward been issued with two warning letters besides that which was issued to him while working at Mombasa. Those warning letters concerned insubordination on his part. Mr. Kiragu was later suspended with immediate effect from 4th February, 1982. It was after this suspension that Mr. Kiragu was demoted from barman to room service waiter.

The respondents further stated that Mr. Kiragu became a shopsteward on 17th March, 1982 and asked the court to note that Mr. Kiragu had already an aggregate of three warnings with suspension and demotion as a way of disciplining him and not as alleged by the claimants that he was disliked by the management for his role in trade union affairs. The management gave Mr. Kiragu all the assistance and co-operation he needed as a shopsteward and allowed him time to attend seminars organized by his union with full pay. He was also given financial assistance in form of soft loans which is not common. Mr. Kiragu was not demoted at all after he became a shopsteward as the claimants would like the court to believe. Mr. Kiragu became defiant of authority which he had shown at Whitesands in Mombasa, and also at New Stanley Hotel in Nairobi, even after becoming a shopsteward. He on certain occasions tried to defame some managers in the establishment. He further caused defamatory articles to be published in some local papers which as a result caused him to be suspended after the release of the Press report. Despite the fact that Mr. Kiragu had been given a chance to repent for his utterances he persisted in his misbehaviour with the result that the management had no alternative but to dismiss him.

The respondents referred the court to the investigation by the Ministry of Labour where it was found that Mr. Kiragu's behaviour even prior to his being elected as a shopsteward was unsatisfactory. The Ministry also found that Mr. Kiragu had exceeded his responsibilities as a shopsteward and had gone very far when he caused the publication of a defamatory article to be published in the local "Kiswahili" paper against his superiors. This action could not be described as a legitimate trade union activity in the interest of the workers. Under such circumstances and also due to the fact that his employment record was not satisfactory the Ministry of Labour found that dismissal was justified and recommended that the management's action in dismissing Mr. Kiragu be upheld.

The respondents asked the court to uphold the findings and recommendations of the Ministry of Labour in dismissing Mr. Kiragu and reject the claimants demands.

The court after very careful consideration of the facts and issues raised by both parties finds itself in agreement with the Ministry of Labour finding and recommendation. The court notes that the article in a newspaper which was written after an interview with Mr. Kiragu had the following opening paragraphs:

*Employees of New Stanley Hotel threaten to strike;*

"The employees of New Stanley Hotel yesterday asked for the dismissal of the general manager and the food and beverages manager."

In a letter addressed to the directors of the hotel, the representative of KUDHEIHA Workers, Mr. J. M. Kiragu, said the employees had rejected the General Manager, Mr. George Crossland and the Food and Beverages Manager, Mr. Stephen Mbugua.

The employees insisted that the two people should be dismissed immediately or else they (workers) go on strike if their demands are not met, said Mr. Kiragu.

He urged the directors to dismiss the two to avert the strike.

The fact that the workers grievances were being looked into through the established industrial relations machinery by the parties makes Mr. Kiragu's misconduct even more serious.

The court rejects the claimants demand for his reinstatement but awards that his dismissal be reduced to normal termination.

**IMPORTANT NOTICE TO SUBSCRIBERS  
TO THE KENYA GAZETTE**

THE following notes are for the guidance of persons submitting "copy" for inclusion in the *Kenya Gazette, Supplements*, etc.:

- (1) The *Kenya Gazette* contains notices of a general nature which do not affect legislation. They are therefore submitted to the Government Printer directly.
- (2) *Legislative Supplement* contains Rules and Regulations which are issued by the Central Government. Because of this they must be submitted to the Government Printer through the office of the Attorney-General.
- (3) *Bill Supplement* contains Bills which are for introduction in the National Assembly.
- (4) *Act Supplement* contains Acts passed by the National Assembly.

All "copy" submitted for publication should be prepared on one side of an A4 sheet no matter how small the notice or Act, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible and contain a minimum of alterations.

Particular attention should be paid to the following points:

- (i) Signatures must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

**Kenya Gazette**

"D.14.(1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer when ready."

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
