Issue in dispute:

Refusal to pay acting/duty allowance to Mr. James Opiyo, porter group RC II C/No. 311519 by the Chief Traffic Manager, Kenya Railways Corporation, Nairobi.

THE Railways Workers Union (K) shall hereinafter be referred to as the claimants and the Kenya Railways Conporation shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi, on 10th January, 1989, and relied on their written and verbal submissions.

#### AWARD

3. The Notification of Dispute Form "A" dated 22nd July, 1987, duly signed by the parties was received by the court on 14th July, 1988, together with the statutory certificate signed by the Labour Commissioner.

In this dispute the parties are agreed that Mr. Opiyo who is a porter worked as a stores clerk for 28 months on the aforesaid various dates. It is also on record that the Road Service Foreman and the District Superintendent, Mombasa, recommended that he be paid acting allowance for these assignments. He, however, could not be paid the acting allowance because the post in which he acted had not been established and the headquarters rejected the claim. The court agrees that he cannot be paid acting allowance and the headquarters decision is proper on that score.

The court however finds that requiring a porter to do a stores clerk's work for 28 months and then denying him extra compensation for the higher duties he performed is an understrable labour practice and the respondents should take steps to ensure that such practices are not repeated. To say the least it can amount to an undue exploitation of a worker. Surely an employer of such a magnitude like the respondents should not appear to be doing that.

After careful consideration of all the submissions the court finds that Mr. Opiyo is entitled to some compensation for having worked as a stores clerk when his substantive post was that of a porter.

The court has decided to award him a sum of Sh. 1,983 for the higher duties he performed.

2. The parties were heard in Nairobi, on 2nd March, 1989, and relied on their written and verbal submissions.

#### Award

3. The Notification of Dispute Form "A" dated 5th July, 1988, duly signed by the parties was received by the court on 17th October, 1988, together with the statutory certificate signed by the Labour Commissioner.

The respondents engage in the manufacture of leather shoes and started their business operations in 1972. They are wholely locally owned by I.C.D.C. Investment Company Limited and the Industrial and Commercial Development Conporation (I.C.D.C.) and currently employ 100 employees.

The parties entered into a recognition agreement in 1972 and since then the parties have negotiated and concluded several collective agreements. This dispute arose when the parties were negotiating for the renewal of the latest of their collective agreement which expired on 30th September, 1987.

In this dispute the respondents have pleaded financial inability to meet any of the claimants' demands and have bluntly told the court that they have no funds to improve their workers' benefits.

The court notes that on account of financial difficulties that faced the respondents in 1987, the parties had to agree on stringent measures to revitalize the business. Firstly, there was a change of board of directors and management. When the new management took-over the parties agreed on a wage freeze for a period of one year effective from 1st October, 1986. Above all 62 workers from both the management and unionizable employees had to be declared redundant.

As a result the respondents were able to reduce their accumulated business loss for the financial year 1986/87 from a sum of Sh. 6.9 million to Sh. 4.8 million in the financial year 1987/88.

The court further notes that out of the 62 redundant employees only 14 have been recalled to resume duty and some 10 redundant employees have been offered casual jobs from time to time. Consequently 38 former employees are still out of employment and hope one day that they shall be recalled back to their former jobs.

The court is satisfied that the respondents financial position is precarious indeed and they deserve a chance to improve on their business performance and to stay in business. The future of nearly 100 workers is at stake.

After a careful consideration of all the submissions the court has decided that all the other items except wages should stay at their existing level.

On wages the court awards a standstill for 1 year from 1st October, 1987 till 30th September, 1988, and only a modest wage increase of 5 per cent for the second year from 1st October, 1988 till 30th September, 1989.

The court hopes that with this award the respondents will succeed in revitalizing their business and not only save the jobs of those still in employment but will recall those workers who were declared redundant.

- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

"D 41. (1) Communications for the Kenya Gazette should reach the Government Printer not later than 9 a.m., on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.
