THE INDUSTRIAL COURT

CAUSE No. 48 OF 1989

Parties:

Kenya Engineering Workers Union

and

Friendship Container Manufacturers Limited

Interpretation application:

Ruling:

The parties appeared before the court in Cause No. 48 of 1989 and the disputed issue was as follows:

"The resumption of work of all the workers, except the five employees who are working, and the issue of the payment of their wages upto and including the date of the award."

The court gave the dispute priority hearing and at the commencement of the hearing at the court's advice and order 82 employees resumed work on 2nd August, 1989, subject to normal discipline and were to achieve production targets they achieved in 1987.

As a result of the aforesaid court directive which parties accepted the remaining issues in dispute were as appended herein below:

- (a) Payment of wages of 103 (87 plus (16) employees for the period between 27th May, 1989 to 5th June, 1989 inclusive.
- (b) Payment of wages of 82 employees between 6th June, 1989 and 1st August, 1989, inclusive.
- (c) Dismissal of the 16 employees.

The court announced its award in the above dispute on 10th July, 1990, in respect of the three issues indicated hereinabove.

However, this application is in respect of issue No. (c) only namely: "Dismissal of the 16 employees". The court ruled that the 16 grievants deserved summary dismissal and the court upheld the respondents' action in that and all the claims made on their behalf were accordingly dismissed.

The claimants have moved the court for an interpretation of this award saying that the court's ruling did not interfere with payments accruing from the parties' collective agreement for the period between 1st August, 1988 upto 31st July, 1990. The claimants argued that the collective agreement giving rise to this application was concluded and signed on 24th January, 1989. Subsequently, it was registered by the court on 14th March, 1989, as R.C.A. No. 70 of 1987. The claimants stressed that the respondents were legally required to implement the said collective agreement immediately after its registration on 14th March, 1989. The claimants felt that the parties' collective agreement for the period 1st August, 1988 upto 31st July, 1990, was not an issue in dispute before the court. They stated that respondents were duty bound to discharge their obligations prior to 10th July, 1990, and thus this application would not have arisen. As a result, any worker who was in the respondents pay-roll as at 14th March, 1989, was entitled to benefits accruing therein.

The claimants pleaded with the court to rule that the 16 grievants are entitled to their benefits arising from the parties' collective agreement for August 1988 to July 1990.

The respondents submitted that the interpretation application by the claimants should be dismissed because there are no valid grounds to support the payment of arrears as alleged, in law or in fact or at all. The respondents stated that they were not a party to the collective agreement entered into between the claimants and the Minor Engineering Group of Federation of Kenya Employers. The respondents stated that, they neither participated in the negotiations nor signed the said collective agreement registered by the court as R.C.A. No. 70 of 1987.

The respondents told the court that they had resigned from the Minor Engineering Group of Federation of Kenya Employers in May 1988. Consequently, the respondents and the claimants had agreed to negotiate an independent and separate collective

agreement. However, on commencing negotiations the parties were deadlocked. The claimants then went ahead and reported a trade dispute which was filed in court as cause No. 85 of 1989.

The claimants went on to tell the court that the parties had agreed that in the interest of good industrial relations and industrial peace they should adopt the agreement registered as

R.C.A. No. 70 of 1987 to its expiry, and a new agreement negotiated to replace it. The respondents explained that collective agreement R.C.A. No. 70 of 1987 came into effect and applicable to them only after the agreement by consent and court's ruling thereof in November 1989.

As a result, the 16 grievants were not in the respondents' employment and therefore, the court's ruling in November 1989 did not apply to them. The respondents stated that the 16 employees were dismissed in June 1989 and the court in its award upheld the dismissal. The respondents urged the court to dismiss the claimants' application in total.

The facts in this dispute are somewhat different from the several cases in the past in which the court has ruled that only those employees who are in employment when the collective agreement is ordered to be implemented, can benefit from such collective agreement.

In fact the serious industrial unrest that erupted at the respondents' factory was partly due to non-implementation by the respondents of the Minor Engineering Group's collective agreement with the claimants (R.C.A. 70 of 1987). As a result of the serious incident that happened on 26th May, 1989, during which the respondents' director was badly beaten up, the sixteen employees were dismissed. The dismissal of the sixteen employees was upheld by the court as the court found that resorting to mob justice was not the answer to industrial relations problems.

Keeping the background of this dispute in mind and after having heard the parties' submissions the court rules that the terminal dues payable to the sixteen dismissed employees should be on the basis of R.C.A. 70 of 1987 and the court accordingly upholds the claimants' submission on this point.
