CAUSE No. 50 OF 1989

Parties:

Kenya Union of Domestic, Hotels, Educational
Institutions, Hospitals and Allied Workers
and
African Tours and Hotels

Issue in dispute:

Dismissal of Mr. Harold Kaduki, Union Shopsteward.

THE Kenya Union of Domestic, Hotels, Educational Institutions, Hospitals and Allied Workers shall hereinafter be referred to as the claimants and African Tours and Hotels shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi, on 13th November, 1990, and relied on their written and verbal submissions.

AWARD

3. The Minister for Labour referred this dispute to the court on 5th July, 1989, in accordance with section 8 of the Trade Disputes Act (Cap. 234), laws of Kenya. The Minister's reference was received by the court on 6th July, 1989, together with the statutory certificates signed by himself and the Labour Commissioner.

The respondents who are based in Mombasa are members of the Kenya Association of Hotel Keepers and Caterers and are engaged in tourism business.

The grievant, Harold Kaduki, was employed by the respondents as a driver/tour guide at a monthly salary of Sh. 815 plus Sh. 175 house allowance. He remained in that position but his salary stood at Sh. 1,637 plus a house allowance of Sh. 300 at the time of his dismissal on 24th April, 1985.

The circumstances that led to the grievant's suspension and subsequent dismissal were that on the 20th February, 1985, while driving the respondents' vehicles registration No. KUG 457, in the course of his duties, along the junction of the Kenyatta Avenue and Digo Road, Mombasa, he was involved in a motor vehicle accident with another vehicle belonging to Nairobi Homes Services. The grievant did not stop immediately at the scene of the accident. He also did not report this accident to the police immediately but went for his duties and made the report later on the same day. By the time he informed his employer the police, and the other party whose vehicle he had an accident with, had already brought it to his employer's attention.

The grievant went ahead and admitted liability in writing and also paid National Homes Services Sh. 175 for the damage occasioned to their vehicle as full and final settlement of the matter. This was contrary to the employer's and insurer's instructions on such a matter. The respondents then decided to suspend the grievant from their services with effect from 25th March, 1985, and consequently dismissed him.

The grievant who was also a shopsteward approached the claimants and this matter was discussed by the Coast Disputes Committee on 16th July, 1985, whereof the respondents decision to summarily dismiss the grievant was upheld. The claimants, however, rejected this and formally reported a trade dispute to the Minister for Labour and Mr. L. Ocharo of the Labour Office, Mombasa, was appointed an investigator. On 8th September, 1987, the chief industrial relations officer released his report to the parties and recommended as follows:

Findings:

It is not disputed that Mr. Kaduki worked continuously between July, 1979 to April 1985, and that there was a no valid warning in his record. The management's statement that Mr. Kaduki caused an accident on 17th March, 1983, for which he was not warned cannot be connected with the accident of 20th February, 1985, especially when the time span is taken into consideration. Had he been issued with a warning letter the same would still not have been valid at the time of the accident of 20th February, 1985.

Investigations revealed that Mr. Kaduki while driving vehicle No. KUG 457 was involved in an accident on 20th February, 1985. He stopped about 50 metres away. The other vehicle went straight to the police whereof Mr. Kaduki later went and found a report of accident having been made.

On going to the office the same report had already been received and a memo had already been written by the manager demanding an explanation to which he did verbally consequent to which he was suspended on 25th February, 1985, and subsequently dismissed on 24th April, 1985. The scratched vehicle was repaired by Mr. Kaduki at the cost of Sh. 175, the management therefore did not incur any loss.

In view of the above findings and taking into consideration that Mr. Kaduki had worked with the company for over five (5) years with no valid warning letter and having been suspended contrary to the provision of the collective agreement, I find the decision taken by the management to dismiss Mr. Kaduki summarily to have been rather harsh and therefore wrongful.

Recommendations:

In view of the parties' submissions coupled with the above findings, it is recommended that Mr. Kaduki's dismissal be reduced to normal termination. He should be paid all his terminal benefits according to the parties' collective agreement. In addition to this he should be paid three (3) months' salary being compensation for wrongful dismissal.

The claimants accepted the ministry's recommendation, but the respondent rejected it and the matter is now before the court for its decision. The claimants have sought the grievants'

reinstatement back to duty without loss of benefits and payment of all his terminal benefits including three (3) months' salary being compensation for wrongful dismissal.

The respondents strongly submitted that these misdeeds constituted gross misconduct under section 17 (c) (e) and (g) of the Employment Act and they were therefore justified in terminating grievant's services which they did on 24th April, 1895.

The respondents agreed that though the claimants took the matter up they reached a deadlock at the joint industrial council. And that the reason why they rejected the ministry's findings and recommendations was on the ground that the investigator failed to take into account all available facts and therefore his findings and recommendations were biased and untenable. The respondent denied that the grievant was victimized due to his trade union activities and termed this as frivolous and untrue and finally urged this court to reject the union's demand because they are vexatious and unjustified.

The court finds that the warnings referred to in the grievant's record had expired and the accident that led to his dismissal was not a serious one at all as the damage to the other vehicle cost only Sh. 175.

There are, however, certain points against the grievant in this dispute in that he did not stop after the accident, did not immediately report that accident to the police and went ahead and admitted liability for the damage and fact paid Sh. 175 damage to the other party.

It is most unfortunate that the grievant behaved in the manner he did on a minor accident. Strictly speaking the grievant's behaviour can fall under section 17 of the Employment Act dealing with gross misconduct but the circumstances of this dispute are such that the respondents should have taken a rather lenient view of the offence because the respondents did not suffer any damage.

The court is inclined to go with the Ministry of Labour's recommendation except that three (3) months' compensation to the grievant is not merited.

The court accordingly reduces the grievant's summary dismissal to normal termination and awards that he be paid all the benefits that accrue to him under a normal termination.

THE INDUSTRIAL COURT

CAUSE No. 84 OF 1990

Parties:

Kenya Union of Commercial, Food & Allied Workers
and
Samtanus Freight Forwarders Limited

Issues in dispute:

Wrongful termination of Joseph Obunga.

THE Kenya Union of Commercial, Food and Allied Workers shall hereinafter be referred to as the claimants and Samtanus Freight Forwarders Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 28th November, 1990, and relied on their written and verbal submissions.

AWARD

3. The Notification of the Dispute Form "A" undated but duly signed by the parties was received by the court on 10th August, 1990, together with the statutory certificates signed by the Labour Commissioner and the Minister for Labour.

Joseph Obunga, was employed by the respondents on 15th February, 1980, as a declaration clerk and on 12th November, 1987, he was promoted to be a supervisor. Mr. Obunga was dismissed by the respondents on 4th January, 1990, and his

salary stood at KSh. 3,600 per month at that time. The respondents are members of D.A.T.A. and are based in Mombasa.

The claimants told the court that the circumstances leading to the grievant's dismissal were that Mr. Obunga was given KSh. 6,000 by the respondents to go to the airport in Mombasa to clear four cases of spare parts, and while heading to the airport he was accompanied by the driver and the clerk. The claimants continued to tell the court that the goods were cleared very late and were released at around 5 p.m. and since the goods were very heavy they needed to hire a big vehicle to carry the goods. The claimants added that there was a big vehicle at the airport belonging to another company and Mr. Obunga asked his driver to make a deal with the driver of the Freight Forwarders Limited and it was agreed between the two drivers that KSh. 400 would be paid as hiring charges for the big vehicle to take the goods to the respondents premises.

The claimants further told the court that Mr. Obunga telephoned his boss to seek permission to spend KSh. 400 to hire the said vehicle to deliver the goods and that permission was granted to do so. The claimants added that the money was handed to the respondents driver by Mr. Obunga to go and pay the other vehicle's driver since it was the driver who had concluded the deal with the other driver. It was also said by the claimants that when the money changed hands between the two drivers, Mr. Obunga did not witness or see it.

On the other hand the respondents told the court that on 13th November, Mr. Obunga was given KSh. 400 not KSh. 6,000 as alleged by the claimants with instructions to go to the Moi International Airport, Mombasa, to clear four cases of spare parts and have the said cases delivered to the respondents godown. On this occasion he was accompanied by a driver and clerk. The respondents further told the court that it is true that Mr. Obunga as alleged by the claimants telephoned the respondents manager, that he wanted to hire transport for KSh. 400 to deliver the four cases of spare parts to the company godown and was given approval for this.

The respondents added that they were puzzled when on 18th of November, they received a letter from Freight Forwarders Limited demanding to know as to who was responsible for paying the charges of transporting the four cases of spares and were told by the respondents that their driver had previously received KSh. 400 handed to him by the respondents driver. The respondents continued to tell the court that on 18th November they asked Mr. Obunga for an explanation on this matter and he stated that he had given KSh. 400 to the respondents' driver who was with him at the time to go and pay to the Freight Forwarders' driver.

The court took into account the submissions to the two parties, written and verbal. The court also studied the findings and recommendation by the Ministry of Labour. The court notes the fact that the parties were not disputing the fact that Mr. Obunga was given permission by the respondents to spend KSh. 400 to hire a vehicle to enable him to transport the four cases of spare parts to the respondents godown.

It is not disputed that the goods were delivered by the vehicle belonging to Freight Forwarders Limited of Mombasa. The court believes that the said goods could not have been transported by the Freight Forwarders' driver without being paid but no one saw the money change hands between the two drivers and even the grievant did not witness it. So the truth about that transaction lies with the two drivers. The court also blames the respondents for their failure to avail the payment voucher to the grievant so that whenever a situation arises like the one in question where a vehicle has to be hired, the driver could have been asked to sign the voucher as a proof that he has received the money.

The court has taken into account Mr. Obunga's clean record of employment for the period of nine (9) years and 10½ months. The court agrees with the findings of the Ministry of Labour and awards that Mr. Obunga's dismissal be reduced to normal termination to entitle him to terminal benefits in accordance with the parties' collective agreement and in addition he should be paid three (3) months salary by way of compensation for the wrongful dismissal he has suffered.

**IMPORTANT NOTICE TO SUBSCRIBERS

All "copy" submitted for publication should be prepared on one side of an A4 sheet no matter how small the notice or Act, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible and contain a minimum of alterations.

Particular attention should be paid to the following points:

- (i) Signature must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

Kenya Gazette

"D 41. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m., on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer when ready."
