AWARD

3. By consent of the parties the court awards that the respondents should reinstate Mr. Bwire, to his job and his reinstatement be deemed to be from 1st September, 1991.

That in addition to his reinstatement Mr. Bwire, be paid a sum of KSh. 10,000.

AWART

Maulidi Mushahama (hereinafter called "the grievant"), was employed by the respondents as a P.S.V. driver, on 21st October, 1971. He worked as such until 19th August, 1986, when he was summarily dismissed from the services of the respondents for negligently and carelessly driving a bus, fleet No. 46, downhill at an excessive speed along Wundanyi/Dembwa Road, on 7th June, 1986, and as a result he caused an accident in which one passenger died and the bus was extensively damaged. At the time of his dismissal, he had served the respondents for a period of 13 years and his salary stood at KSh. 1,491 plus a house allowance of KSh. 550 per month.

The claimants took up the matter on behalf of the grievant with the respondents but no amicable settlement was reached. Consequently, the claimants reported a trade dispute to the Minister for Labour in accordance with section 4 of the Trade Disputes Act (Cap. 234), and on 11th February, 1987, E. A. Ouma of Mombasa Labour office, was appointed to act as an

investigator. On 13th September, 1988, the ministry released to the parties the following findings and recommendations:

"Findings:

The investigation has established that Mr. Maulidi served Kenya Bus Services (Mombasa) Limited, for a period of 13 years without any warnings up to 19th August, 1986, when he was dismissed.

It has not been disputed that on or about 7th June, 1986, the bus Mr. Maulidi, was driving along Wundanyi/Dembwa Road was extensively damaged in an accident. What appears to be in dispute was the actual cause of the accident. The parties gave conflicting facts of the incident which required an independent authority to institute an investigation with a view to establishing the true facts of the matter.

In their submission, the union said that the police case is still pending in court of law, for determination. On account of this, it is therefore not my intention to comment on the matter which is sub judice.

In view of this and due to the fact that the management seemingly made a hasty decision to blame the accident on Mushahama's negligence and overspeeding I find that Mushahama's dismissal was based on insufficient grounds. Hence, unfair and wrongful. It has also been noted with concern that the management refused to discuss the matter with the investigator for reasons best known to themselves.

Recommendation:

It is recommended that Mr. Mushahama should be reinstated to his former position without loss of benefits."

The claimants accepts the findings and recommendation, but the respondents rejected them on the ground that they were based on completely biased information which did not reflect the actual and true position of the matter. Thereupon the parties signed and submitted a Notification of Dispute Form "A", dated 12th June, 1990, to this court under section 14 (7) of the Trade Disputes Act, for the adjudication of the dispute. The notification, together with the statutory certificates from the Minister for Labour and the Labour Commissioner in accordance with section 14 (9) (e) and (f) of the Act, were received by the court on 19th March, 1991, and the matter is now before the court for consideration.

The claimants urged the court to uphold the ministry's findings and recommendation; and, in addition, award that the grievant be paid his salary for the period he has been kept out of employment without a justifiable cause. In reply, the respondents heavily relied on their chief engineer's accident report in this matter dated 1st July, 1986.

The respondents pointed out that prior to this incident, the grievant had been served with warning letters on 3rd July, 1972, for speeding on 29th June, 1972, on 25th October, 1977, for causing an accident through careless driving on 18th October, 1977, and on 17th July, 1979, for hitting a stationary bus on 8th July, 1979, and failure to report the accident. In support of their case, they told the court that in Traffic Case No. 585 of 1987, before the resident magistrate's at Voi, which was determined before the release of their chief engineer's report, the grievant was found guilty on the charge of causing death by dangerous driving.

The respondents finally pleaded with the court to find that the grievant's summary dismissal was justified, and prayed it to reject the claimants' demand for his reinstatement and compensation.

The facts relating to this case are undisputed. The grievant who was plying his bus, fleet No. 46, along Wundanyi/Dembwa Road on 7th June, 1986, met with an accident on a steep hill, and as a result one passenger lost her life and the bus was extensively damaged with the result that the bus was scrapped as repairing it was economically prohibitive. The grievant was as summarily dismissed on account of the accident and subsequently charged as aforestated with the offence of causing death by dangerous driving for which he was found guilty, convicted and placed on one year probation period. But the claimants did not admit that the grievant was in any way responsible for causing the accident. They contended that the accident happened unexpectedly because the brakes of the bus failed while moving downhill, and consequently it crashed.

In our view and from the facts and the evidence on record we are satisfied that the grievant was solely responsible for the accident. He was rash and negligent in his driving for which he was liable. We are fortified in this view by the chief engineer's report and the tachograph that was produced in court by the respondents through their witness which glaringly proves that the grievant carelessly or recklessly drove the bus downhill at a high speed. His previous driving record does not also augur well for him.

The above circumstances are sufficient criteria for the court not to entertain any demand by the claimants for either reinstatement of the grievant to his former job or any compensation to him. But purely on compassionate grounds due to his 13 years of service to the respondents, the court feels that the grievant deserved normal termination of service instead of summary dismissal. Accordingly, the court awards that the grievant's summary dismissal be reduced to normal termination of service to enable him receive his terminal benefits, if any, in terms of the relevant collective agreement in force between the parties at the time.

AWARD

THE conciliation officer having failed to bring about a settlement on the above demands between the parties issued a failure certificate on 7th August, 1990. Thereupon the parties signed and submitted a Notification of Dispute Form "A", to this court under section 14 (7) of the Trade Disputes Act (Cap. 234), for the adjudication of the same. The notification, dated 13th August, 1990, and accompanied by the statutory certificate from the Labour Commissioner under section 14 (9) (e), thereof, were received by the court on 22nd May, 1991, on which date the dispute was listed for mention on 10th June, 1991. On 10th June, 1991, the dispute was fixed for hearing on 6th August, 1991, but on the said date, the parties sought an adjournment of the case to enable them continue with negotiations for a settlement. The court granted the adjournment and ordered that in the event the parties failed to reach a settlement, the matter would proceed for hearing on 25th and 26th September, 1991. On 25th September, 1991, the parties reported that they had reached an agreement on all the issues, except three items—i.e.. (i) house allowance, (ii) casual workers' rates of pay and (iii) effective date and duration of the agreement. They, therefore, required more time to attempt a final settlement on the remaining issues. The court accepted the request, but fixed the dispute for hearing on the remaining issues on 31st October, 1991, in case the parties failed to conclusively settle them. On 31st October, 1991, the parties informed the court that they have reached a final settlement on the three (3) issues and prayed that an award may be made in terms of the settlement.

As prayed for by the parties, we make this award in the terms of the settlement at the parties' own level and on the following three (3) issues:

- (i) House allowance.—That the employees be paid 15 per cent house allowance on their basic wages subject to a minimum of KSh. 250 per month whichever is higher.
- (ii) Casual workers' rates of pay.—That casual workers be paid KSh. 43.50 per day.
- (iii) Effective date and duration of the agreement.—That the effective date of the agreement be 1st July, 1991, for a period of two (2) years.
