(iv) to notify that trade union and the organization in writing and within one (1) month of payment;

(v) make written returns to the Registrar of Trade Unions within one (1) month of making all payments to that trade union and to the organization.

VACANCIES

Civil service applicants and local authority officers should complete (revised) form PSC. 2A in triplicate (submitting the original through their heads of department). Other applicants should complete forms PSC. 2 in triplicate.

The documents are obtained either from the Secretary or from other Government offices and are issued free of charge.

Originals of certificates and similar documents should not be submitted unless specifically asked for. All applicants should state their postal address.

NOTE

Incremental credits will be granted to successful candidates who are not civil servants for approved previous experience provided the maximum salary is not exceeded. They will also be eligible for benefits and privileges enjoyed by civil servants in accordance with existing Government regulations.

Vacancies in the Office of the President:

Principal Lecturer (Two Posts) (Defence) (No. 9/92)

Salary scale.—K£5,223 to 7,101 p.a. PENSIONABLE or AGREEMENT.

Applicants must be holders of university degree in any of the following fields: mathematics, physics, technology, electrical/mechanical, computer, telecommunication and engineering. They must also possess post-graduate qualifications in education and must have served as senior lecturer, job group "M" for a minimum period of three (3) years.

Successful candidates will be deployed as squadron commanders with both military and civilian personnel working under them. Other duties will include—

- (a) co-ordination of setting and marking of internal examinations; and
- (b) looking after the welfare, administration and training of personnel in the squadron.

Senior Lecturer (Five Posts) (Defence) (No. 10/92)

Salary scale.—K£4,707 to 6,435 p.a. PENSIONABLE or AGREEMENT.

Applicants must be holders of university degree in any of the following fields: mathematics, physics, technology, electrical, mechanical, computer, telecommunication and engineering, and must have served as lecturer I, job group "L", for a minimum period of three (3) years. Holders of higher national diploma in the above fields may also be considered provided they have at least ten (10) years' teaching experience, five (5) of which must be in a national technical institution.

Successful candidates will be required to lecture in his/her field of specialization, set and mark examinations.

Duties of the successful candidates will include:

- (a) Lecturing, setting and marking of examinations.
- (b) Preparing of training aids and other instructional materials.
- (c) Monitoring of students' performance, interviewing and counselling.
- (d) Supervision of diploma students' projects.
- (e) Research, curriculum development and course planning.
- (f) Staff development of personnel under him.

Chief Management Analyst (Information) (One Post) (D.P.M.) (No. 11/92)

Salary scale.—K£4,707 to 6,435 p.a. PENSIONABLE or AGREEMENT.

Applicants must be Kenyan citizens in possession of a bachelors degree in economics, statistics, human resources management, computer science and/or management information systems, business/public administration or any of the social sciences from a recognized university who have served in the grade of senior management analyst (information management) for at least three (3) years. Candidates who have served in the grade of senior management analyst (information), for at

least three (3) years and are in possession of CPS II and CPA II or their approved equivalent will also be considered. Demonstrated capability and competence in computer based information systems, analysis and designs will be an added advantage.

Duties and responsibilities involve the direction and co-ordination of various activities in the management information section, including complement control, maintenance of data on staff deployment and utilization, personal emoluments, skills inventory and central payroll operations; overall supervision of collection of management information data to facilitate the day-to-day operations of the Directorate of Personnel Management; analysis; processing; storage; retrieval and dissemination of data/information to other divisions and sections in the directorate and to ministries/departments.

Chief Fingerprint Officer (Three Posts) (National Registration Bureau and Police Departments) (No. 12/92)

Salary scale.—K£3,807 to 5,223 p.a. PENSIONABLE or AGREEMENT.

Applicants should be serving officers with E.A.C.E. standard of education or its equivalent with at least three (3) years' satisfactory experience as senior fingerprint officer, job group "K". They must be fully conversant with the relevant Acts and regulations relating to the operation of national registration bureau/identification bureau.

Duties and responsibilities will include administration and efficient operation of the national registration bureau/identification bureau including all other functions relating thereto as required under the relevant Acts.

Fingerprint Officer I (Eight Posts) (National Registration Bureau and Police Departments) (No. 13/92)

Salary scale.—K£2,688 to 3,807 p.a. PENSIONABLE or AGREEMENT.

Applicants should be serving officers of E.A.C.E. standard of education or its equivalent with at least three (3) years' satisfactory experience as fingerprint officer II, job group "H". A wide knowledge of the registration Act pertaining to fingerprint and court procedure will be an advantage.

Work at this level involves supervision of the operation of a large section of the bureau; preparation of exhibits or court documents and court attendance; verification and certification of illegal registration or certificate of previous conviction and verification of exhibits/court documents prepared by officers under him. He may also be required to attend a court of law to give evidence.

Fingerprint Officer II (Nineteen Posts) (National Registration Bureau and Police Departments) (No. 14/92)

Salary scale.—K£2,253 to 3,198 p.a. PENSIONABLE to AGREEMENT.

Applicants should be serving officers of E.A.C.E. standard or its equivalent with three (3) years' satisfactory experience as senior fingerprint assistant, job group "G". A pass in the fingerprint examination "A", "B" and "C" is a must.

The duties involve supervision of a medium-sized section of the fingerprint bureau, searching and comparing finger marks found at scenes of crime and/or identification of bodies using fingerprints; verification and certification of illegal registration of certificates of previous convictions. The officer may, in addition, be required to give evidence in a court of law.

Assistant Telecommunication Engineer (Two Posts) (Re-advertisement) (Defence) (No. 15/92)

Salary scale.—K£2,253 to 3,198 p.a. PENSIONABLE or AGREEMENT.

Applicants must have had a recognized apprenticeship or similar training followed by considerable experience of at least three (3) years with a telecommunications organization at preferably the level of senior telecommunications assistant, job group "G". They should possess the Kenya National Examinations Council telecommunications technician certificate final part or its equivalent, and have had experience in the maintenance, repair and installation of the following:

- (a) H.F.S.S.B. equipment in fixed, mobile and portable modes.
- (b) V.H.F. and U.H.F. equipment (AM/FM) used in fixed, mobile and portable modes.
- (c) Telephone switchboards, teleprints, telephone and similar terminal equipment.

Vacancies in the Office of the Vice-President and Ministry of Finance:

Supplies Officer I (Two Posts) (Various Ministries) (No. 16/92)

Salary scale.—K£3,198 to 4,545 p.a. PENSIONABLE or AGREEMENT.

Applicants must be serving supplies officers III, job group "J", who have—

- (a) served for at least three (3) years in the grade of supplies officer III;
- (b) been confirmed in appointment in case of direct appointment;
- (c) shown merit and ability in work performance and results; and
- (d) diploma in supplies management parts I and II or foundation stage or their equivalent.

Duties and responsibilities:

A supplies officer I, will be required to run and supervise a multi-district supplies depot, or a comparable section in a large central store.

Duties will normally involve efficient management and distribution of stores, disposal of unserviceable and/or other stores on the recommendation of a Board of Survey, staff supervision and training.

Supplies Assistant (Two Posts) (Various Ministries) (No. 17/92)

Salary scale.—K£2,253 to 3,198 p.a. PENSIONABLE or AGREEMENT.

Applicants must be serving officers who—

- (a) have completed at least three (3) years satisfactory service at the level of senior storeman; and
- (b) possess the advanced certificate in supplies management or its equivalent.

For direct appointment to the grade of supplies assistant, candidates must have a diploma in supplies management parts I and II or foundation stage or their equivalent.

Duties and responsibilities:

A supplies assistant will take charge of departmental stores depot, or sub-section in a central store. In a departmental store, work will generally involve, security and safe custody of stores; procurement and storage; issues and rationing of stores, making recommendation for disposal of unserviceable and/or other stores, and supervision of staff under him.

Vacancies in the Ministry of Planning and National Development:

Deputy Director (Two Posts) (Resource Surveys and Remote Sensing) (No. 18/92)

Salary scale.—K£6,213 to 7,617 p.a. PENSIONABLE or AGREEMENT.

Applicants must be civil servants in possession of a M.Sc. degree with relevant post, professional training in such disciplines as the applications of remote sensing technology, the practice of the geographical information system to resource assessment and planning biostatistics and natural resources economics to development planning process. They must have a minimum of ten (10) years service in a technical department, two (2) of which must be in the grade of chief ecologist or chief biologist, job group "N", with working experience in the field of research and development as related to methods and the practice of renewable resource assessment, ecological monitoring concepts, data base development and implementation of development programmes in natural resources management.

In addition, the candidate would invariably be expected to be conversant with Government policies and should have effectively contributed to the formulating and implementing projects towards the perpetuation of the district focus planning strategy and published reports and scientific papers.

Duties and responsibilities:

The successful candidates will be responsible for the management of one of the department's major divisions and will be involved in the administration and management of professional, technical and support staff. They will be reporting directly to the director.

Vacancies in the Ministry of Transport and Communications:

Senior Engineering Technician (Seventeen Posts) (Civil Aviation) (No. 19/92)

Salary scale.—K£3,198 to 4,545 p.a. PENSIONABLE or AGREEMENT.

Applicants should be in possession of telecommunication or electronics engineering technician, part III, certificate of Kenya National Examination Council (K.N.E.C.), or its equivalent or higher national diploma or its equivalent with five (5) years field experience. Applicants possessing telecommunication or electronics engineering technician part II certificate with advanced factory training and at least fifteen (15) years in service, five (5) years of which must be at a responsible position, like manning a major unit, may also be considered.

The applicants must have shown merit, ability and proven experience in installation, testing and calibration, maintenance and operation of radio, air navigational aids and radar equipment.

Duties and responsibilities entail efficient running of a specialized equipment section, installation, maintenance and operation of navigational aids and telecommunications systems, assessment of equipment and recommending, when necessary, replacement, or instructional duties on aviation telecommunication engineering at the school of aviation, training and supervision of staff.

Senior Aeronautical Communications Officer (Ten Posts) (Civil Aviation) (No. 20/92)

Salary scale.—K£3,198 to 4,545 p.a. PENSIONABLE or AGREEMENT.

Serving aeronautical communications officer I, must have—

- (a) served for at least three (3) years in that grade; and
- (b) passed the advanced aeronautical communications officer examination at the East African School of Aviation or any other institution approved by the international civil aviation organization.

The duties and responsibilities attached to this grade involve—

- (a) suppression of harmful interference and maintenance of frequency tolerance to international telecommunication union standards in consultation with the engineering staff;
- (b) monitoring all frequencies in use to ensure accuracy and serviceability in accordance with the registration of each frequency;
- (c) ensuring proper and continuous communication of all aeronautical fixed telecommunications network circuits;
- (d) monitoring all navigational aids within the flight information region with a view to ensuring their serviceability;
- (e) supervision, preparation, investigation and analysis of the automatic message switching system; and
- (f) supervision of junior officers and giving instruction at the East African School of Aviation.

Aeronautical Communications Officer I (Twenty-one Posts) (Civil Aviation) (No. 21/92)

Salary scale.—K£2,688 to 3,807 p.a. PENSIONABLE or AGREEMENT.

Applicants must be aeronautical communication officer II, who must—

- (a) have served in that grade for at least three (3) years; and

For appointment to this grade, serving traffic control officers II, (non-graduates), will be required to have—
