

NOTICE is hereby given to all whom it may concern that The Kenya Power and Lighting Company Limited, a limited liability company incorporated in the Republic of Kenya having its registered office at Electricity House, Harambee Avenue, P.O. Box 30099, Nairobi (the licensee), intends to make an application on 31st May, 1993, to the Minister for Energy under sections 72 and 149 of the Electric Power Act for approval by him of proposed by-laws to be known as the "Methods of Charge (K.P.L.C.) By-laws, 1993" which, if and when approved, will revoke the existing Methods of Charge (K.P.L.C.) By-laws 1991 (No. 2).

The Kenya Power and Lighting Company Limited (K.P.L.C.) purchases electrical power from the Kenya Power Company Limited (K.P.C.) and Tana River Development Company Limited (T.R.D.C.). The price which K.P.L.C. pays represents the total financial requirements of K.P.C. and T.R.D.C. comprising their operating and maintenance costs, the cost of debt service in respect of their existing generating and transmission facilities and the local costs relating to their power development projects. In addition to these costs of power purchases K.P.L.C. has to meet the costs relating to operation and maintenance and debt service of other existing generating, transmission and distribution facilities. Any after tax profits made by K.P.L.C. is mainly applied towards reinforcement and expansion of the distribution network to meet the growing demand for electricity.

The bulk of the K.P.L.C. costs, which comprise mainly debt service and system expansion costs, are contracted in hard currencies. The depreciation of the value of the shilling against these hard currencies, especially in the last four years, has resulted in escalating financial commitments far beyond the increase in sales revenue. The recent devaluation by over 70 per cent, of the shilling against the hard currencies, coupled with steep rise in the rate of inflation, has increased the cost of the operations to unsustainable level even after allowing for the financial impact of the average tariff increase of 25 cents per cent of the shilling against the hard currencies, coupled with on 1st April, 1993.

The object of and reasons for the application are, therefore, to achieve an overall increase in revenue to partially mitigate the steep increases in the cost of the power industry operations. The effect of the minister's approval of our application will be an increase, in average electricity charges, ranging from 1 per cent to 19 per cent on all categories of consumers. The lowest average increase of about 1 per cent will apply to the small domestic consumers who comprise about 25 per cent of our consumers. Details of the proposed tariff structure are contained in the proposed "Methods of Charge (K.P.L.C.) By-laws, 1993". These have been deposited at the offices of the licensee and are open to public inspection during normal office hours without payment. Copies of the proposed by-laws may be purchased at the offices of the licensee at a price of Sh. 5 per copy.
