### THE LOCAL GOVERNMENT ELECTIONS (AMENDMENT) RULES, 1992

#### APPOINTMENT OF RETURNING OFFICERS AND DEPUTY RETURNING OFFICERS

## THE NATIONAL ASSEMBLY AND PRESIDENTIAL ELECTIONS ACT

(Cap. 7)

## APPOINTMENT OF REGISTRATION AND ASSISTANT REGISTRATION OFFICERS
