It is notified for general information that this year's Administrative Officers' Examination will be held on Wednesday, 14th, Thursday, 15th and Friday, 16th August, 1996, in accordance with the provisions of Personnel Circular No 1 of 4th February, 1971.

1 STRUCTURE OF EXAMINATION

The examination will consist of the following test papers, held over three days as follows:

Wednesday, 14th August, 1996—

- (a) Law (Parts I and II) 9 a.m.—12 noon
(b) Government Organization and Procedures 2 p.m.—5 p.m.

Thursday, 15th August, 1996—

- (c) Civil Service Regulations 9 a.m.—12 noon
(d) Financial Control and Procedures 2 p.m.—5 p.m.

Friday, 16th August, 1996—

- (e) General Knowledge of East African and World Affairs 9 a.m.—12 noon
(f) Applied Logic and Report Writing 2 p.m.—5 p.m.

2 SYLLABUS

There is no change to the syllabus given in the personnel Circular No 6 of 1970.

3 ELIGIBILITY TO ENTER

The examination is open to administrative officers in the service serving either as administrative officers in the provincial administration assistant secretaries in the ministries or second/third secretaries in the foreign service.

4 EXEMPTIONS

- (a) Candidates who have attempted the examination before and passed in one or more subjects will be exempted from those subjects they passed. They will have to sit only the subjects they failed.
(b) Serving officers with legal qualifications from accredited universities may, on application to the Permanent Secretary, Office of the President, Nairobi, be exempted from sitting part I of the law paper.

Exempted candidates must quote the reference numbers of their letters of exemption(s). Candidates who have previously passed any papers are required to indicate the year in which they passed the paper(s) and the respective index number(s) in their entry forms.

5 REGISTRATION FEE

Each candidate will be required to pay a registration fee of KSh 500 only. The fee which is non-refundable should be paid in either crossed Kenya Government cheques or bankers' cheques payable to the Secretary, Public Service Commission, Nairobi. Personal cheques, money orders and postal orders will not be accepted.

6 ENTRY FORMS

Candidates are required to complete the entry form in duplicate as set out in the 'Appendix' to the circular letter.

The forms should be reproduced and cyclostyled by each ministry/department as necessary.

The duly completed entry forms, accompanied by the correct registration fee should be submitted through the Permanent Secretary, Office of the President, Harambee House, Nairobi to the Secretary, Public Service Commission, Nairobi, so as to reach him not later than Friday, 12th July, 1996. Under no circumstances will late entries be accepted.

The Permanent Secretary, Office of the President, is asked to ensure that all entry forms are properly filled and submitted in time.

7 EXAMINATION CENTRES

The examination will be held at Mombasa, Nyari, Babu, Nairobi, Nakuru, Kisumu, Eldoret and Garissa will be the centres for the examination. Centres outside Kenya will be established for eligible candidates in the foreign service.

8 EXAMINATION PAPERS AND STATIONERY

A list of examination test papers and stationery, appointment of invigilators, arrangement for examination venues will be made by the provincial directors of education in each centre.

Candidates will, however, provide their own rulers, pens and ink. They may also bring their own law textbooks to be referred to during part II of the law paper if they are presenting themselves for the same. The provincial directors of education are, however, requested to ensure that the relevant law books are available at their centres for the candidates' use during part II of the law paper.
