### THE CONSTITUTION OF KENYA

APPOINTMENT OF A STANDING COMMITTEE ON HUMAN RIGHTS

IN EXTRCISE of the powers conferred by section 23 (1) of the Constitution of Kenya, I, Daniel Toroitich arap Moi, President and Commander-in-Chief of the Armed Forces of the Republic of Kenya, do appoint a Standing Committee on Human Rights. The committee shall consist of the following persons—

There shall be a secretary to the committee and such other officers assisting him/her who shall be public officers.

The terms of reference of the committee shall be-

- (a) to investigate complaints of alleged violation of the fundamental rights and freedoms set out in the Constitution;
- (b) to investigate complaints of alleged injustice, abuse of power and unfair treatment of any person by a public officer in exercise of his official duties;
- (c) to educate the public as to human rights and freedoms by such means as the committee deems fit including publication, lectures and symposia.

The committee shall not investigate any matter which is pending before a court or involving relations or dealings between the Government and any other government or an international body.

The committee shall submit to the President at the end of every three (3) months a written report of its findings in respect of any complaints or allegations making such recommendations as it deems necessary.

The committee shall in consultation with the Attorney-General, establish its own procedures.

The proceedings of the committee shall be held at such times and places as the committee may from time to time determine.
