NOTIFICATION FOR LAMU DISTRICT REPRESENTATIVE BY-ELECTION

A BY-ELECTION is to be held for the replacement of one District Representative to serve in the National Constitutional Conference pursuant to the provision of section 27 (2) (c) of the Constitution of Kenya Review Act in respect of Lamu District.

Pursuant to section 27 (2) (c) of the Act, each District shall have three representatives, at least one of whom shall be a woman and only one of whom may be a councillor.

The by-election shall be held on 26th March, 2003 between 9.00 a.m. and 4.00 p.m. at the Lamu County Council Meeting Hall.

Nomination forms for the elections may be obtained from the Secretary to the Clerk, Lamu County Council on and from the 18th March, 2003 between 9.00 a.m. and 12.00 noon.

Nomination papers may be returned by candidates to the returning officer at the Lamu County Council Clerk's Office between 8.00 a.m. and 4.00 p.m. on the 20th March, 2003 or 21st March, 2003.
