## THE KENYA NATIONAL COMMISSION ON HUMAN RIGHTS ACT

(No. 9 of 2002)

INVITATION OF APPLICATIONS FOR POSITIONS OF COMMISSIONERS (10)

PURSUANT to section 6 of the Kenya National Commission on Human Rights Act (No. 9 of 2002) (published in the Kenya Gazette on 12th March, 2003) applications are invited for nomination as commissioners by the National Assembly to the said Commission, which is the successor to the Standing Committee on Human Rights.

The Commission shall consist of a chairperson and nine commissioners. The chairperson shall be elected by the other members.

Applications may be made by-

- (a) any qualified person; or
- (b) by any person, organization or group of persons proposing the nomination of any qualified person.

A person shall be qualified for appointment as a commissioner if such person---

- (a) is a citizen of Kenya;
- (b) is a person of high moral character and proven integrity and has knowledge and experience in matters relating to human rights; and

(c) in the case of the chairperson, is qualified to hold office as a judge of the High Court of Kenya.

Members of Parliament, local authorities or executive bodies of political parties are not qualified.

Applications should be forwarded to the Clerk, National Assembly, P.O. Box 41842, Nairobi, or deposited in his office at Parliament Buildings, to reach him on or before 16th April, 2003.
