<i>Institution</i>	<i>Core Responsibilities</i>
Water Resources Management	Implementation of the policies and strategies for the management of water resources.
Authority (WRMA)	Development of catchment level management strategies.
Water Services Regulatory	Overseeing the implementation of policies and strategies relating to provision of water and sanitation services (WSS).
Boards (WSRB)	Regulating the provision of WSS services. Licensing WSBs and approving their appointed Water Service Providers (WSPs).
Water Services Board (WSB)	Responsible for the efficient and economical provision of water services. Asset holder of central government facilities.
Water Services Trust Fund (WSTF)	Assist in financing of provision water supplies in areas that are inadequately provided for.
Water Appeals Board (WAB)	Adjudicating disputes within the sector.

Seven Water Services Board covering the whole country were gazetted and are the sole authorities mandated to obtain the licenses for provision of water services within their respective areas of jurisdiction and appoint Water Services Providers.

1. Under the Water Act, 2002:

- The functions of provision of water services shall be regulated through and under the authority of a license issued by the Water Services Regulatory Board.
- The water services boards are the sole mandated authorities to obtain the licenses for the provision of water services, for their respective jurisdictions.
- The water services boards are mandated under the Water Act 2002, to provide water services through water services providers as agents by means of agreements as defined in the Water Act 2002.

2. Notwithstanding the repeal of the Water Act, Cap. 372 and the commencement of the Water Act, 2002, and the institutional establishment and operationalisation of the Water Services Boards, the provision of water services has continued to be performed by—

- the Ministry of Water and Irrigation;
- the National Water Conservation and Pipeline and Corporation;
- other bodies established by the Water Act (Cap. 372) (repealed) and other statutes;
- water undertakers appointed under the provisions of the Water Act (Cap. 372) (repealed) or any other enactment.

3. The Water Act, 2002 provides that the status quo defined above should be maintained until the Plan Transfer of the management and operation of water services to the Water Services Board is published by notice in the Gazette.

PART II: PROVISIONS DEFINING THE PROPOSED PLAN OF TRANSFER

1. *Water Policies:*

The plan of transfer is based on section 113 of the Act and on the water policies and strategies.

2. *Transfers of Functions, Property, Rights and Liabilities:*

On the Transfer Date:

- The Ministry of Water and Irrigation shall transfer—
 - its functions for the provision of water services to the Water Services Boards within their respective areas of jurisdiction;

NOTICE UNDER SECTION 11 OF THE ELECTRIC POWER ACT ON PROPOSED GRANT OF ELECTRIC POWER PRODUCTION LICENCE TO PAN AFRICAN PAPER MILLS (E.A.) LIMITED FOR THE DEVELOPMENT OF A 9 MW COMBINED HEAT AND POWER (CHP) PLANT

The minister for energy, upon the recommendations of the Electricity Regulatory Board ("the Board") made pursuant to section 9 of the Electric Power Act ("the Act"), proposes to grant an electric power production licence ("proposed licence") to Pan African Paper Mills (E. A.) Limited ("proposed Licensee") under section 123 of the Act.

The proposed licence shall authorize and entitle the proposed licensee to generate electrical energy for its own use from the power generating station to be known as Webuye CHP Plant situated at Pan African Paper Mills, Webuye, comprising a 9 MW CHP plant procured, constructed, installed, owned, maintained and operated by the proposed licensee.

THE WATER ACT

(No. 8 of 2002)

PROPOSED PLAN FOR THE TRANSFER OF THE MANAGEMENT AND OPERATION OF WATER SERVICES TO THE WATER SERVICES BOARD

PURSUANT to section 107 of the Water Act, 2002, it is notified for public information that the Minister for Water and Irrigation intends to gazette the plan for the transfer of the management and operation of water services to the Water Services Boards in accordance with section 113 of the Water Act, 2002.

The following is a summary of the plan of transfer—

PART I: INTRODUCTION

The Water Act 2002 commenced by virtue of Legal Notice No. 31 of 2003 and Legal Notice No. 158 of 2003. The Act provides the reformed legal institutional framework for the management and development of Kenya's water resources and the provision of water

- (ii) the property, rights and liabilities of the Director of Water, which shall be vested in the water services boards through transfer agreements.
- (b) The Government, its statutory corporations and other authorities (including the National Water Conservation and Pipeline Corporation) shall transfer the ownership and utilities of its water services facilities to the water services boards.
- (a) Water companies established by local authorities shall undertake the provision of water services and the overall control and management of water services facilities through an agreed legal framework with water boards.
- (d) Non-Governmental Organisations (NGOs), Community Based Organisations (CBOs) and other community and self-help groups shall enter into management agreement with water services boards regarding the management and control of water services facilities owned and used by them.

2. Transitional Arrangements:

Transitional Arrangements shall take effect in the period leading up to the transfer of the management and operation of water services as specified in the Plan of Transfer with supportive major activities as follows:

- (a) **Issuance of Licenses:** The Water Services Regulatory Board shall issue licences with or without conditions to the water services boards in compliance with Part IV of the Act.
- (b) **Appointment of Water Services Providers:** All current water services providers shall continue to provide services during the transitional period;
- (c) Transfer agreements shall be entered into between the parties concerned;
- (d) **Undertaking Key Studies:** The water services board in conjunction with the Water Sector Reform Secretariat shall carry out detailed studies with respect to—
 - (i) assessment of water services schemes and facilities within the area of each water services board;
 - (ii) the organization and development study of water services boards;
 - (iii) technical, financial and service performance examination of each water service whose ownership has been transferred from the Ministry to water services boards and also those owned by local authorities; and
 - (iv) the financial and economic prospects and implications of providing water services to its residents.
- (e) Identifying and recruiting of water services providers;
- (f) Capacity building and training of members of water services boards;
- (g) **Provisions Relating to Staff—**
 - (i) the Water Sector Reform Secretariat and water services boards shall undertake training and assessment programmes of their staff;
 - (ii) water services boards shall identify and recruit staff in accordance with their requirements;
 - (iii) staff absorbed by the Water Services Boards from the Ministry or National Water Conservation and Pipeline Corporation and shall be deemed to be transferred staff.
- (h) The Water Sector Reform Secretariat shall continue to co-ordinate the implementation of the Plan of Transfer until completion.

4. Financial Arrangements:

The following are the identified categories of costs during the relevant periods which the Ministry shall meet—

- (i) Costs of the transfer;

- (ii) Necessary operation and management costs while the Ministry and the National Water Conservation and Pipeline Corporation are the interim Water Service Providers up to the period ending 30th June, 2006; and
- (iii) Costs of operation and maintenance for water services boards for the three year period commencing 1st July, 2007, such support being pegged upon the performance of the boards with respect to section 57 of the Act.

PART III: RULES UNDER SECTION 113 (3)

The Plan of the transfer shall be operationalized by rules made by the Minister.

PART IV: ACCESS TO INFORMATION ON THE PROPOSED PLAN OF TRANSFER

The Ministry of Water and Irrigation invites members of the public to participate in the process of public consultation on the above proposals.

Any local authority, public body, water company, water undertakers, or any other person or body of persons wishing to make representations on or objections to the Plan of Transfer may do so in writing, stating the grounds on which such representations or objection is made, to the Minister, Ministry of Water and Irrigation, and mark on the outside of the envelope enclosing it "Proposed Plan of Transfer of Water Services" and forward the same on or before the expiry of 45 days from the date of publication of this notice.
