APPOINTMENT OF REGISTRATION OFFICERS AND ASSISTANT REGISTRATION OFFICERS

IN EXERCISE of the powers conferred by section 3 of the National Assembly and Presidential Elections Act and regulation 2 (1), 2 (2) and 3 (1) of the National Assembly and Presidential Elections (Registration of Electors) Regulations, 2002, the Electoral Commission appoints the persons named in the second and third columns in the Schedule to be the registration officers and assistant registration officers, respectively, for all constituencies in the districts named in the first column of the schedule for the purposes of carrying out inspection of voters registers and continuous voters' registration.

The registration officers and assistant registration officers named in the second and third columns shall be based at the district headquarters of the districts named in the first column of the schedule. The assistant registration officers named in the fifth column of the Schedule shall be based at the divisional headquarters named in the fourth column of the schedule.

The appointment shall be deemed to have come into force on 17th January, 2005. All other appointments of registration officers and assistant registration officers which were made previously or which will be subsisting as on 17th January, 2005, shall stand revoked from 17th January, 2005.

As part of continuous voter registration, those who wish to register as voters, transfer their registration, change their registration particulars or wish to raise other issues related to registration of voters should consult the registration officers or the assistant registration officers during the normal working hours.

- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

**EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—***Kenya Gazette*

"D 40. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m. on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.
