The Committee will be chaired by the Permanent Secretary, Ministry of Justice and Constitutional Affairs or his representative.

2. The functions of the Committee shall be to advise the Government on measures necessary to comply with its international human rights obligations and shall in this regard work with relevant Ministries, Government departments, public bodies, civil society and other stakeholders to co-ordinate the collection, documentation and updating of information relevant to Government's in order for concerned to meet and implement its obligations under the regional and international Human Rights Instruments to which Kenya is a party and shall in this regard the Committee shall—

- provide advice to Government and ensure compliance with Kenya's treaty obligations including domestication of such instruments;
- discuss with concerned parties and stakeholders and plan a schedule of activities to finalize all outstanding human rights country reports;
- co-ordinate activities to ensure timely submission of human rights related country reports;
- organize and co-ordinate stakeholders consultative meetings to raise awareness on the importance of Kenya reporting under international instruments to which Kenya is a party;
- support and participate in treaty specific standards training in conformity with the relevant treaty body's guidelines;
- co-ordinate the preparation of a core document on the general information on Kenya and submit the document to the various treaty monitoring bodies;
- ensure publication of prepared country reports for public scrutiny and debate before such reports are submitted to the relevant treaty bodies further ensure comments of the treaty bodies to the public;
- prepare quarterly reports in the status of human rights instruments for submission to the Minister for the time being responsible for matters relating to justice and constitutional affairs and advise on upcoming regional and international human rights instruments that Kenya should be party to; and
- carry out such other functions as may be necessary or incidental to the foregoing.

3. In the performance of its functions the Committee shall—

- be responsible to the Minister for Justice and Constitutional Affairs as the Minister responsible for the promotion and protection of human rights;
- consult and work closely with relevant ministries, civil society organizations and other institutions concerned with the promotion and protection of human rights;

- (c) hold such number of meetings in such places and at such times as the Committee shall consider necessary for the proper discharge of its functions;
- (d) co-opt any person(s) as it may consider necessary or expedient for the proper performance of its functions;
- (e) have regard to all applicable international human rights standards and in particular, to the fact that human rights are indivisible, interdependent, interrelated and of equal importance for the dignity of all human beings;
- (f) subject to the foregoing, the Committee shall have all the powers necessary or expedient for the proper discharge of its mandate including the power to regulate its own procedure.

4. The Secretariat of the Committee:

The Secretariat of the Committee shall be based at the Ministry of Justice and Constitutional Affairs, Co-operative Bank House, P.O. Box 56057, Nairobi and shall be responsible to the Committee for—

- (a) providing appropriate background briefing to the Committee;
- (b) preparing the Committee's reports and disseminating any information deemed relevant to the Committee; and
- (c) undertaking research and liaising with the relevant Government departments and any other institution in order to gather relevant information necessary for informing the Committee.

IMPORTANT NOTICE TO SUBSCRIBERS TO THE "KENYA GAZETTE"

THE following notes are for the guidance of persons submitting "copy" for inclusion in the *Kenya Gazette, Supplement*, etc.:

- (1) The *Kenya Gazette* contains notices of a general nature which do not affect legislation. They are, therefore, submitted to the Government Printer directly.
- (2) *Legislative Supplement* contains Rules and Regulations which are issued by the central Government. Because of this they must be submitted to the Government Printer through the office of the Attorney-General.
- (3) *Bill Supplement* contains Bills which are for introduction in the National Assembly.
- (4) *Act Supplement* contains Acts passed by the National Assembly.

All "copy" submitted for publication should be prepared on one side of an A4 sheet no matter how small the notice is, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible and contain no alterations.

Particular attention should be paid to the following points:

- (i) Signature must be supported by rubber-stamping or typing the name of the signatory in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—**Kenya Gazette**

"D 40. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m. on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) Ministries will be required to pay for the *Kenya Gazette* and to meet the cost of advertising in it.

(3) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer in time.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect."
