THE NATIONAL ASSEMBLY ELECTIONS (ELECTION PETITION) RULES

APPOINTMENT OF ELECTION COURTS

IN EXERCISE of the powers conferred by section 60 (5) of the Constitution of Kenya and section 19 of the National Assembly And Presidential Elections Act, the Chief Justice of the Republic of Kenya directs that the Election Petitions whose details are given hereunder shall be heard in the High Court of Kenya by Election Courts comprising of the Judges and sitting at the court stations indicated, respectively, in the sixth and seventh columns of the schedule below on such dates to be fixed by the Election Courts on priority basis in terms of section 19 (4) of the said Act. The Election Courts will give directions as to the hearing of the petitions during Mentions thereof on Monday, the 11th February, 2008 except where otherwise indicated in the schedule.
