NOMINATED PARLIAMENTARY AND CIVIC CANDIDATES

IN EXERCISE of powers conferred by the National Assembly and Presidential Elections Act and by Regulation 20 (4) of the Presidential and Parliamentary Elections Regulations, the Interim Independent Electoral Commission notifies the public that after the nomination of parliamentary and civic candidates on 27th and 28th April, 2011, the persons named in the first column of the schedule were and now stand validly nominated for parliamentary by-elections and the civic by-elections to be held on 23rd May, 2011 for Kamukunji and Ikolomani Constituencies and 11 civic wards as indicated.
