IN EXERCISE of the powers conferred by of the powers conferred by Section 2(1) (a), (b), (c) and 9 of the Sixth Schedule to the Constitution of Kenya, Article 90 of the Constitution, sections 34-37 of the Elections Act, 2011 as amended by The Elections

(Amendment)(No. 2) Act, 2012 and Regulations 54-56 of The Elections (General) Regulations, 2012, the Independent Electoral and Boundaries Commission publishes the formula in the schedule below that it is mandated to use in the allocation of the special seats envisaged under Articles 97 (1)(c), 98 (1)(b), (c) & (d), and 177 (1)(b) & (c) of the Constitution, to respective political parties –

The formula for allocation of seats to the respective Political Parties from the party lists shall be the number of seats won by a political party divided by the total number of seats multiplied by available seats for allocation in the respective House.
