IN THE MATTER OF THE NATIONAL LAND COMMISSION ACT NO. 5 OF 2012 SECTION 14 (5)

REVOCATION OF GRANT NO. I.R. 131908

PURSUANT to a complaint by Telposta Pension Scheme Trustees Registered and further to Legal Notice Number 133 published in the Kenya Gazette supplement No. 11 of 11th March, 1998 and the Legal Notice 131 published in the Kenya Gazette supplement Number 71 of 14th September, 2001 and allocation of Land Reference Number 209/2397 to Park Avenue Investments Limited and subsequent registration as Land Reference Number 209/13238 (I.R. No. 69308) in favour of Park Avenue Investment Limited and subsequent charge to the Trust Bank Limited under liquidation and transfer to Intercontinies Importers and Exporters Limited, the National Land Commission has determined that the allocation is illegal and Grant Number I.R. 69308 was unlawfully acquired by Park Avenue Investments.
