THE SENATE STANDING ORDERS
SPECIAL SITTINGS OF THE SENATE

NOTICE is given to all Senators that pursuant to section 33 (3) of the County Governments Act, 2012, Standing Order 68 (1) and Standing Order 29 (1) of the Senate Standing Orders:

UPON receipt of a letter from the Speaker of the County Assembly of Nyeri dated Friday, 2nd September, 2016 and received in the Office of the Speaker of the Senate on Monday, 5th September, 2016 by which the Speaker of the County Assembly of Nyeri informed the Speaker of the Senate of the approval of a Motion for the removal from office by impeachment of James Nderitu Gachagua, the Governor of Nyeri County;

I have appointed Wednesday, 7th September, 2016 as a day for the meeting of the Senate to hear charges against the Governor of Nyeri County. The meeting to hear charges against the Governor shall commence at 10.00 a.m. in the Senate Chamber, Ground Floor, Main Parliament Buildings, Nairobi.

NOTICE is further given that in accordance with Standing Order 29 (1) of the Senate Standing Orders, on the request of the Senate Majority Leader and the Senate Minority Leader with the support of the requisite number of Senators, I have appointed Wednesday, 7th September, 2016 and Thursday, 8th September, 2016 as days for special sittings of the Senate.

The special sittings shall be held as follows—

1. On Wednesday, 7th September, 2016 commencing at 10.00 a.m. to transact the following business—

- (a) Consideration of the Election Offences Bill (National Assembly Bills No. 36 of 2016); and
 - (b) Consideration of the Election Laws (Amendment) Bill (National Assembly Bills No. 37 of 2016).
2. On Thursday, 8th September, 2016 commencing at 10.00 a.m. to transact the following business—
- (a) Consideration of the Election Offences Bill (National Assembly Bills No. 36 of 2016);
 - (b) Consideration of the Election Laws (Amendment) Bill (National Assembly Bills No. 37 of 2016);
 - (c) Consideration of the County Outdoor Advertising Control Bill (Senate Bills No. 11 of 2015);
 - (d) Consideration of the Employment (Amendment) Bill (Senate Bills No. 1 of 2015);
 - (e) Consideration of the County Library Services Bill (Senate Bills No. 6 of 2015); and
 - (f) Consideration of the Physical Planning Bill (National Assembly Bills No. 46 of 2015);
 - (g) Consideration of Procedural Motion to vary the Senate Calendar pursuant to Standing Order 28 (4) of the Senate Standing Orders.

The business specified in this Notice shall be the only business before the Senate during the Special Sittings, following which the Senate shall stand adjourned until Tuesday, 20th September, 2016, at 2.30 p.m. in accordance with the Resolution of the Senate made on Wednesday, 24th August, 2016.
