THAT pursuant to Article 181 of the Constitution and section 33 of the County Governments Act, 2012, on 2nd September, 2016, the County Assembly of Nyeri approved a Motion "to remove from office, by impeachment," Hon. James Nderitu Gachagua, the Governor of Nyeri County;

AND THAT by a letter dated 2nd September, 2016, Ref: CAN/SEN/PMNT/COR/2/(3) and received in the Office of the Speaker of the Senate on 5th September, 2016, the Speaker of the County Assembly of Nyeri informed the Speaker of the Senate of the approval of the Motion by the County Assembly and further forwarded to the Speaker of the Senate documents in evidence of the proceedings of the Assembly;

AND FURTHER THAT pursuant to Article 181 of the Constitution, section 33 of the County Governments Act, 2012 and standing order 68 of the Senate Standing Orders, the Senate, by resolution, on Wednesday, 7th September, 2016 resolved to investigate the matter of the proposed removal from office of the Governor of Nyeri County;

AND THAT pursuant to Article 181 of the Constitution, section 33 of the County Governments Act, 2012 and standing order 68 of the Senate Standing Orders, the Senate found that the Particulars of the Allegations against Hon. James Nderitu Gachagua, the Governor of Nyeri County were not substantiated.
