- (b) The political parties shall nominate five suitable nominees in accordance with the provisions of Article 215 (3) and (4) of the Constitution and section 6 of the Commission on Revenue Allocation Act according to their proportion of members in the Senate; and
- (c) The names of the nominees shall be submitted to the National Assembly for approval in accordance with Article 250(2)(b) of the Constitution.
